Electricity Sold for May 2025

China Power International Development Limited (the “**Company**”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “**Group**”) in May 2025 amounted to 10,286,324MWh, representing a decrease of 10.16% compared with the same period last year, while the combined total electricity sold for the first five months of 2025 was 51,237,216MWh, representing a decrease of 2.30% compared with the same period last year.

The Group’s total electricity sold in May 2025 and for the five months ended 31 May 2025 presented by type of power plants are as follows:
