Electricity Sold for the First Half of 2025

China Power International Development Limited (the “**Company**”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “**Group**”) in June 2025 amounted to 11,299,344MWh, representing a decrease of 5.04% compared with the same month last year, while the combined total electricity sold for the first six months of 2025 was 62,536,560MWh, representing a decrease of 2.81% compared with the same period last year.

The Group’s total electricity sold in June 2025 and for the six months ended 30 June 2025 presented by type of power plant are as follows:
