Electricity Sold for July 2025

China Power International Development Limited (the “**Company**”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “**Group**”) in July 2025 amounted to 12,543,235MWh, representing an increase of 2.45% compared with the same month last year, while the combined total electricity sold for the first seven months of 2025 was 75,079,795MWh, representing a decrease of 1.97% compared with the same period last year.

The Group’s total electricity sold in July 2025 and for the seven months ended 31 July 2025 presented by type of power plant are as follows:
