**CHINA POWER INTERNATIONAL DEVELOPMENT LIMITED
announced the total electricity generation
for the year ended 31 December 2004**

China Power International Development Limited (the “Company”, stock code: 2380) has announced its total electricity generation for the year ended 31 December 2004 today.

According to the preliminary statistics of the Company, the consolidated total electricity generation of the power plants of the Company (excluding that of its associated company) for the year ended 31 December 2004 was 15,703,628 MWh, which increased by 5.74% when compared with that in the same period last year. Pingwei Power Plant, which recorded a substantial increase by 11.14%, has a higher rate of increase in electricity generation than that of the total electricity generation of the power plants of the Company in the same period, whereas electricity generated by Yaomeng Power Plant this year was more or less the same as that generated in the same period last year. In addition, the total electricity generation of Changshu Power Plant, being the power plant of its associated company, was 8,031,130 MWh, which slightly increased by 1.04%.

The change in the 2004 electricity generation of the Company was mainly attributed to the following factors:

1. The continuous growth in the PRC economy has created a strong demand for electricity in the eastern regions of China where the power plants of the Company are located. This has significantly enhanced the utilization rates of power generation units of Pingwei Power Plant.
2. In order to improve the reliability and efficiency of the generators of the Company, some power generation units of the Company were scheduled in the fourth quarter in 2004 for overhaul and major technological improvements. This partly offset the growth in the Company’s power generation in 2004.

The total electricity generation for the year ended 31 December 2004 of each power plant of the Company and that of its associated company is set out below:

The Company has been listed on the Main Board of the Stock Exchange of Hong Kong Limited since 15 October 2004. It is one of the leading independent power producers in China and its principal business is to develop, construct, own, manage and operate large power plants in China.

As at the year end of 2004, the Company has a 100% ownership interest in two of three high-capacity coal-fired power plants under commercial operation, namely, Pingwei Power Plant and Yaomeng Power Plant, and it has a 50% ownership in Changshu Power Plant. These three power plants have a total installed capacity of 3,610 MW and an installed capacity attributable to the Company's ownership of 3,010 MW.
