China Power Announced its Total Net Generation for the First Half of 2007

China Power International Development Limited (the “Company”, Stock Code: 2380) today announced its total net generation for the first half of the year ended 30 June 2007.

According to its preliminary statistics, the consolidated total net generation of the power plants of the Company (excluding the power plant of its associated company) for the first half of the year ended 30 June 2007 amounted to 11,430,800 MWh, representing an increase of 4.0% over the same period last year.

The increase in the total net generation of the Company in the first half of 2007 was mainly attributable to (1) the commence of operation of unit No.3 of Pingwei Power Plant II; (2) improved reliability over operation for units of each power plant; (3) the Company’s proactive endeavor of producing more non-base generation such as substitution generation and cross-province generation, provided that the base generation is guaranteed.

The respective total net generation figures of the power plants of the Company and its associated company for the first half of the year ended 30 June 2007 are as follows:

CHINA POWER INTERNATIONAL DEVELOPMENT LIMITED

The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited since 15 October 2004. The Company is the flagship company of China Power Investment Corporation (one of the five national power generation groups in China) and its principal business is to develop, construct, manage and operate power plants in China. The Company has 100% ownership in its three high-capacity coal-fired power plants under commercial operation, namely, Pingwei Power Plant, Yaomeng Power Plant and Shentou I Power Plant and 50% ownership in the associated company, Changshu Power Plant. The Company has 100% ownership in two high-capacity coal-fired power plants which are under construction, namely, Pingwei Power Plant II and Yaomeng Power Plant II, and is the controlling shareholder of 93% interest of Huanggang Dabieshan Power Plant which is under construction. Meanwhile, the Company also owns a 25% stake in Shanghai Electric Power Co. Ltd., which is listed on the Shanghai Stock Exchange. Currently, China Power has an attributable installed capacity of approximately 5,948 MW.
