## China Power Announced Total Net Generation for the First 3 Quarters of 2007

China Power International Development Limited (the “Company”, stock code: 2380) announced today its total net generation for the first 3 quarters of the year ended 30 September 2007.

According to its preliminary statistics, the consolidated total net generation of the power plants of the Company (excluding the power plant of its associated company) amounted to 17,978,456 MWh for the first 3 quarters of the year ended 30 September 2007, representing a year-on-year increase of 5.95%.

The increase in net generation for the first 3 quarters of 2007 was mainly attributable to (1) the commence of operation of unit No.3 of Pingwei Power Plant II; (2) improved reliability over operation for units of each power plant; (3) the Company’s proactive endeavor of producing more non-base generation such as substitution generation and cross-province generation, provided that the base generation is guaranteed.

The total net generation figures of the power plants of the Company and its associated company for the first 3 quarters of the year ended 30 September 2007 are as follows:

## **China Power International Development Limited**

The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited since 15 October 2004. The Company is the flagship company of China Power Investment Corporation (one of the five national power generation groups in China) and its principal business is to develop, construct, manage and operate power plants in China. The Company has 100% ownership in its three large scale coal-fired power plants under commercial operation and 50% equity interest in the associated company, Changshu Power Plant. The Company wholly-owns or owned as controlling shareholder three large scale coal-fired power plants which are under construction. In addition, the Company also owns a 21.92% stake in Shanghai Electric Power Co. Ltd., which is listed on the Shanghai Stock Exchange. Currently, the attributable installed capacity of the Company is approximately 5,906 MW.
