China Power Announced its Gross Generation and Total Net Generation for the First 3 Quarters of 2010

(12 Oct 2010, Hong Kong) China Power International Development Limited (the "Company", Stock Code: 2380) today announced its gross generation and total net generation for the first 3 quarters of the year ended 30 September 2010.

According to its preliminary statistics, the consolidated gross generation of the power plants of the Company (excluding the power plant of its associated company) amounted to 36,897,032 MWh for the first 3 quarters of the year ended 30 September 2010, representing a year-on-year increase of 42.85% while its consolidated net generation totalled to 34,897,552 MWh, representing a year-on-year increase of 45.36%.

The respective gross generation and total net generation figures of the power plants of the Company for the first 3 quarters ended 30 September 2010 are as follows:

CHINA POWER INTERNATIONAL DEVELOPMENT LIMITED

The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited since 15 October 2004. The Company is the flagship company of China Power Investment Corporation (one of the five national power generation groups in China) and its principal business is to develop, construct, manage and operate power plants in China. The Company has 100% or controlling interest in its six large-capacity coal-fired power plants under commercial operation and 50% equity interest in the associated company, Changshu Power Plant. The Company also owns a 63% controlling interest in Wuling Power Corporation, which is one of the leading hydropower companies in China. In addition, the Company owns a 20.17% stake in Shanghai Electric Power Co., Ltd, which is listed on the Shanghai Stock Exchange. Currently, the Company has an attributable installed capacity of approximately 11,777 MW, among which the hydropower installed capacity is approximately 2,497MW and hence the Company has the highest percentage of hydropower capacity among the overseas listed Chinese independent power producers.
