China Power Announced its Gross Generation and Total Net Generation in 2010

(6 Jan 2011, Hong Kong) China Power International Development Limited (the “Company”, stock code: 2380) announces today its gross generation and net generation for the year ended 31 December 2010.

Benefitting from Wuling Power acquisition and strong power demand, the consolidated gross generation of the power plants of the Company (excluding the power plant of its associated company) for the year ended 31 December 2010 amounted to 48,558,685 MWh, representing an increase of 30.55% compared with the same period of last year. The consolidated total net generation was 46,002,897 MWh, representing an increase of 32.52% compared with the same period of last year.

The respective gross generation and total net generation figures of the power plants of the Company for the year ended 31 December 2010 are as follows:

Note1: The acquisition of 63% equity interest of Wuling Power was completed in October 2009, and the hydro power generation of Wuling Power have been consolidated since 1 November 2009.

Note2: The hydro acquisition of Li Xian Hua Cheng, Hunan Zhong Shui and Sichuan Jiu Yuan of Wuling Power were completed in June, November and December respectively, and the power generation have been consolidated on the completion of acquisitions.

CHINA POWER INTERNATIONAL DEVELOPMENT LIMITED

The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited since 15 October 2004. The Company is the flagship company of China Power Investment Corporation (one of the five national power generation groups in China) and its principal business is to develop, construct, manage and operate power plants in China. The Company has 100% or controlling interest in its six large-capacity coal-fired power plants under commercial operation and 50% equity interest in the associated company, Changshu Power Plant. The Company also owns a 63% controlling interest in Wuling Power Corporation, which is one of the leading hydropower companies in China. In addition, the Company owns a 20.17% stake in Shanghai Electric Power Co., Ltd, which is listed on the Shanghai Stock Exchange. Currently, the Company has an attributable installed capacity of approximately 11,777 MW, among which the hydropower installed capacity is approximately 2,497MW and hence the Company has the highest percentage of hydropower capacity among the overseas listed Chinese independent power producers.
