主席報告 Chairman's Statement

致各位股東：

我們謹代表董事會（「董事會」）向各位股東提呈中國星集團有限公司（「本公司」）及其附屬公司（以下統稱「本集團」）截至二零二四年十二月三十一日止年度的年度業績及年報。

二零二四年是澳門回歸祖國二十五週年，亦是橫琴深度合作區實現第一階段發展目標之年。在全城歡慶回歸的重大時刻，國家主席習近平蒞臨澳門，出席回歸慶典及新一屆特區政府就職典禮，發表重要講話，並視察澳門，不單增強了澳門實行「一國兩制」的信心，也為澳門未來發展指明了新方向。

年內，澳門以至大灣區經歷大事連連，不斷蛻變。我們看到橫琴粵澳深度合作區正式封關運行（三月），十四年樓市調控暫告一段落（四月），內地客到港澳購物的免稅額增至人民幣15,000元（七月），國慶假期訪澳旅客近100萬人次，「一周一行」及「一簽多行」新政出台（十一月），澳門博彩收入累計2,267.82億澳門元（按年增長23.9%，恢復至疫情前的78%），以及輕軌橫琴線正式開通（十二月）。另一亮點為，繼港珠澳大橋後，粵港澳大灣區另一項超級工程深中通道，歷時七年建設後，終於六月三十日正式通車運營。此後，深圳至中山兩地車程由兩小時大幅縮減至半小時，大大促進了兩地經濟發展。

To the shareholders:

On behalf of the Board of Directors (the "Board"), we are pleased to present the annual results and the annual report for the year ended 31st December 2024 of China Star Entertainment Limited (the "Company") and its subsidiaries (collectively as the "Group") to the shareholders.

Year 2024 marked the 25th anniversary of Macau's return to the motherland and the achievement of the first-phase development goals for the Hengqin In-depth Cooperation Zone. During this significant moment of citywide celebration, President Xi Jinping visited Macau to attend the return anniversary celebrations and the inauguration ceremony of the new-term Special Administrative Region (SAR) government. He delivered an important speech and inspected Macau, which not only reinforced confidence in Macau's implementation of "One Country, Two Systems" but also charted a new direction for its future development.

Throughout the year, Macau and the Greater Bay Area experienced a series of significant events and continuous transformation. Key milestones included the official customs closure of the Guangdong-Macau In-Depth Cooperation Zone in Hengqin (March), the temporary removal of 14 years of purchase restriction on property market (April), an increase in the duty-free shopping allowance for mainland visitors to Hong Kong and Macau to RMB15,000 (July), nearly 1 million tourist visits to Macau during the National Day holiday, the implementation of new policies "one trip per week" and "multiple entries with one visa" (November), Macau's gaming revenue reaching a cumulative MOP226.782 billion (a year-on-year increase of 23.9%, recovering to 78% of pre-pandemic levels), and the official opening of the Hengqin Light Rail Line (December). Another highlight was the completion of the Shenzhen-Zhongshan Link, a mega infrastructure project in the Guangdong-Hong Kong-Macau Greater Bay Area following the Hong Kong-Zhuhai-Macau Bridge. After seven years of construction, it officially opened to traffic on 30th June, reducing the travel time between Shenzhen and Zhongshan from two hours to just half an hour, significantly boosting economic development between the two regions.

澳門樓市方面，二零二四年四月開始跟隨香港及國內其他城市，實施全面撤辣，有效釋放樓市購買力，多個發展商把握時機推盤，而美國聯儲局自去年九月起三度減息及內地推人民幣6萬億元化債為樓市再添動力，全年成交量重上3,000宗，各類型物業普遍呈交投量升價跌。踏入二零二五年，中央政府不斷使出穩樓市組合拳及推出多項惠澳措施，包括「一簽多行」、「一周一行」，將為澳門經濟注入新的增長動力，有助提振經濟。當經濟逐步復甦，也會為樓市帶來正面影響。預料二零二五年上半年減息效應浮現，而農曆年前後不少發展商有計劃開售，相信會帶動住宅成交量將較去年同期上升百分之十，約達3,500宗。另一邊廂，橫琴隨著去年三月起正式封關運行，標誌著粵澳深合區邁入發展新階段，加上有取消限購等利好政策加持，新一年表現尤其值得關注。

With regard to the property market in Macau, starting in April 2024, Macau followed Hong Kong and other mainland cities in fully lifting restrictive property measures, effectively unleashing purchasing power. Multiple developers seized the opportunity to launch projects, while the U.S. Federal Reserve's three interest rate cuts since September last year, combined with the mainland's RMB6 trillion debt resolution plan, further fueled the property market. Annual transaction volumes exceeded 3,000 units, with most property types showing increased trading volumes but declining prices. Entering 2025, the central government has continued to roll out a combination of property market stabilization measures and pro-Macau policies, such as "multiple entries with one visa" and "one trip per week," injecting new growth momentum into Macau's economy and aiding its recovery. As the economy gradually rebounds, this is expected to positively impact the property market. The effects of interest rate cuts are anticipated to emerge in the first half of 2025, and with several developers planning launches around the Lunar New Year, residential transaction volumes are projected to rise by approximately 10% compared to the same period last year, reaching around 3,500 units. Meanwhile, since the official customs closure of Hengqin in March last year, the Guangdong-Macau In-depth Cooperation Zone has entered a new phase of development. Coupled with favorable policies such as the removal of purchase restrictions, the performance of Hengqin in the coming year is particularly noteworthy.

回看本集團之主營業務，在電影相關業務經營業務方面，本集團正運用其於電影行業的豐富經驗，籌備製作短劇及網絡電影，預期將有更多此類作品於未來幾個月開始投入製作。物業開發及投資經營業務方面，C7物業正式命名為「天璽•湖」，並於二零二五年一月十三日取得預售許可證及於二零二五年一月二十四日完成封頂，預期將於二零二六年年初取得其佔用許可證。我們計劃將其打造成南灣湖畔唯一高尚住宅，具備澳門最高酒店式公寓交樓標準，擁有前後花園電梯別墅，大型高級會所及泳池。另外，狄梵尼•豪舍第一座已接近售罄，第二座面向金蓮花廣場已於下半年推售。值得一提的是，澳門政府就房地產政策作出利好更改，於二零二四年一月統一所有住宅的按揭成數上限為七成，以及於二零二四年四月免除徵收懲罰性稅項，有助於業主升級或更換更大的單位並改善其居住環境。該等措施因而有助於狄梵尼•豪舍的銷售，因其擁有相對較多的較大單位。多媒體及娛樂經營業務方面，誠如中期報告所述，我們通過於中國設立的全資附屬公司「杭州英明向太多媒體有限公司」，成功進軍多頻道網絡電子商務平台直播電子商務及產品批發、貿易、進出口領域。進入第二階段，我們已建立由多名優秀帶貨主播組成的團隊，於抖音設立多個直播頻道（包括我們的主要抖音賬號向太陳嵐、向太奢品及向太官方旗艦店），以及於小紅書設立「向樣」速食品牌旗艦店以提升我們的客戶基礎。兩邊均標榜「深植於中國美食文化，以高標準高品質要求，確保每款產品，系列都能在消費者留下深刻印象，獲得『像樣』好評」。繼二零二四年七月推出首個品牌向樣及首款甜品（紅豆沙）後，陸續推出【一路繁花】姐姐系列的桂花銀耳燉整梨、鳳凰酥小金磚伴手禮糕點、牛肉乾（臺灣風味）及可可芝士曲奇糕點等，大受好評。於二零二五年，將有更多自家品牌產品推出市場。其他經營業務方面，本集團擬將狄梵尼•豪舍的商場發展為購物商場，為狄梵尼•豪舍的住戶及附近居民提供餐廳、商店及娛樂所需。

Reflecting on the Group's core businesses, in the film-related business operations, the Group is leveraging its extensive experience in the film industry to prepare for the production of short dramas and online movies, with more such projects expected to commence production in the coming months. In the property development and investment operations, the Property C7 has been officially named "Lake Yoho" and obtained its pre-sale permit on 13th January 2025, with its topping-out ceremony completed on 24th January 2025. It is expected to obtain its occupancy permit in early 2026. We plan to position it as the only upscale residential project by the Nam Van Lakes Zone, featuring Macau's highest standard of hotel-style apartment delivery, complete with front and rear garden elevator villas, a large premium clubhouse, and a swimming pool. Additionally, the first tower of Tiffany House is nearing sell-out, while the second tower, facing Golden Lotus Square, was launched in the second half of the year. Notably, the Macau government introduced favorable real estate policy changes, unifying the mortgage ceiling for all residential properties at 70% in January 2024 and abolishing punitive taxes in April 2024. These measures have facilitated upgrades or transitions to larger units, improving living conditions for homeowners and boosting sales of Tiffany House, which offers a relatively high proportion of larger units. In the multimedia and entertainment business operations, as outlined in the interim report, we successfully entered the livestreaming e-commerce in multi-channel network e-commerce platform, and product wholesale, trading and import-export sectors through "杭州英明向太多媒體有限公司" ("YMXT"), our wholly-owned subsidiary established in China. In the second phase, we established a team of top-tier livestreaming hosts and set up multiple livestreaming channels on Douyin (including our main Douyin accounts 向太陳嵐, 向太奢品, and 向太官方旗艦店), as well as a "向樣" instant food brand flagship store on Rednote to expand our customer base. Both platforms emphasize "deeply rooted in Chinese culinary culture, adhering to high standards and quality, ensuring every product and series leaves a lasting impression on consumers and earns '像樣' (decent) praise". Following the launch of the first brand, "向樣", and its debut dessert (red bean paste) in July 2024, we successively introduced the "All the Way Blooming (一路繁花)" sister series featuring "桂花銀耳燉整梨" osmanthus-stewed pear with white fungus, "鳳凰酥小金磚" phoenix pastry mini gold bricks as gift snacks, "牛肉乾" beef jerky (Taiwanese style), and "可可芝士曲奇糕點" cocoa cheese cookies, all of which received widespread acclaim. In 2025, more private label products will be introduced to the market. In other business operations, the Group plans to develop the shopping mall at Tiffany House into an emporium, providing dining, shopping, and entertainment options for residents of Tiffany House and the surrounding community.

預期來年地緣政治依然緊張，美國新政府上場所施行的單邊保護主義，加上俄烏戰事曠日持久，為環球經濟貿易以至全球供應鏈添加諸多不明朗因素。尤其是，美國新近公布的所謂對等關稅政策，已引發市場對貿易戰及全球經濟衰退的憂慮，故經濟環境來年將會是充滿挑戰。年內，我們曾因物業銷售及多媒體及娛樂經營業務產生大量市場推廣、銷售及發行開支以及行政開支增加而發布盈利警告。然而，我們相信該等開支將在未來帶來豐厚回報。另一方面，市場踏入減息週期，加上澳門政府推出利好樓市措施，例如去年四月開始跟隨香港及國內其他城市實施全面撤辣等，相信有助C7物業及狄梵尼•豪舍第二座的銷售。就多媒體及娛樂經營業務而言，我們將加強開發並推出電子商務平台上的「向樣」產品以滿足目標客戶的需求，並繼續擴大其覆蓋範圍，以觸達更廣泛的消費群體，並加強供應鏈及提升自家品牌產品組合，以提高利潤率。本集團亦計劃運用本身於電影業的豐富經驗，開始投資製作短劇及網絡電影。

展望未來，本集團將透過不斷提高盈利能力，並審時度勢而實現其投資最大回報及業務穩健增長。最後，本人謹代表董事會對各位股東的不斷支持致以萬二分的謝意，並感謝各位員工努力不懈的精神，以及合作夥伴的配合與支援。

Looking ahead, geopolitical tensions are expected to persist in the coming year, with the new U.S. administration's unilateral protectionist policies and the protracted Russia-Ukraine conflict adding uncertainty to global trade and supply chains. In particular, the recently announced U.S. "reciprocal tariff" policy has sparked market concerns about trade wars and a global economic downturn, making the economic environment in the coming year highly challenging. During the year, we issued a profit warning due to significant marketing, sales, and distribution expenses, as well as increased administrative costs, stemming from property sales and the multimedia and entertainment business operations. However, we believe these expenditures will yield substantial returns in the future. On the other hand, as the market enters an interest rate reduction cycle and the Macau government introduces property-friendly measures, such as the full lifting of restrictive policies in April last year in line with Hong Kong and other mainland cities, we expect these factors to support sales of the Property C7 and the second tower of Tiffany House. With respect to the multimedia and entertainment business operations, we will enhance the development and launch of "向樣" products on e-commerce platforms to meet the needs of target customers, expand their reach to a broader consumer base, strengthen supply chains, and improve our private label portfolio to heighten profit margins. The Group also plans to leverage its extensive experience in the film industry to invest in producing short dramas and online movies.

Looking forward, the Group aims to maximize investment returns and achieve steady business growth by continuously improving profitability and adapting to the changing market conditions. Finally, on behalf of the Board, I would like to extend my immense appreciation to the shareholders for their relentless support, our staff force for their unremitting spirit, and our business partners for their cooperation and support.

財務回顧

截至二零二四年十二月三十一日止年度，本集團錄得收益728,216,000港元，較截至二零二三年十二月三十一日止年度之206,168,000港元增加253%。年內，本集團錄得穩健收益增長，因物業開發及投資經營業務為本集團貢獻收益675,240,000港元（二零二三年：148,230,000港元），多媒體及娛樂經營業務貢獻收益50,788,000港元（二零二三年：53,503,000港元），及電影相關業務經營業務貢獻收益2,188,000港元（二零二三年：4,435,000港元）。

本年度虧損為350,629,000港元，較截至二零二三年十二月三十一日止年度之289,508,000港元增加21%。虧損增加主要歸因於：(i)透過損益以公平價值列賬之金融資產之公平價值變動所產生之虧損大幅增加至79,366,000港元（二零二三年：27,721,000港元）；(ii)行政開支大幅增加至147,094,000港元（二零二三年：95,408,000港元），因為年內本集團員工人數及營運處所增加；及(iii)物業銷售及多媒體及娛樂經營業務所產生市場推廣及銷售開支大幅增加至101,043,000港元（二零二三年：79,108,000港元）。該影響部分主要由物業開發及投資經營業務及多媒體及娛樂經營業務產生的毛利126,951,000港元（二零二三年：69,331,000港元）所抵銷。

截至二零二四年十二月三十一日止年度，本公司擁有人應佔虧損為351,930,000港元，較上年之289,477,000港元增加22%。

股息

董事不建議派發截至二零二四年十二月三十一日止年度之末期股息（二零二三年：無）。

FINANCIAL REVIEW

For the year ended 31st December 2024, the Group recorded revenue of HK\$728,216,000, represented an increase of 253% as compared to HK\$206,168,000 for the year ended 31st December 2023. During the year, the Group recorded solid revenue growth as property development and investment operations contributed revenue of HK\$675,240,000 (2023: HK\$148,230,000), multi-media and entertainment business operations contributed revenue of HK\$50,788,000 (2023: HK\$53,503,000) and film related business operations contributed revenue of HK\$2,188,000 (2023: HK\$4,435,000) to the Group.

Loss for the year amounted to HK\$350,629,000, representing an increase of 21% from HK\$289,508,000 for the year ended 31st December 2023. The increase in loss mainly attributable to: (i) substantial increase in loss arising on change in fair value of financial assets at fair value through profit or loss amounted to HK\$79,366,000 (2023: HK\$27,721,000); (ii) substantial increase in administrative expenses amounted to HK\$147,094,000 (2023: HK\$95,408,000) due to increase in headcount and operation premises of the Group during the year; and (iii) substantial increase in marketing and selling expenses incurred in property sales and multi-media and entertainment business operations amounted to HK\$101,043,000 (2023: HK\$79,108,000). The effect was partially offset by the gross profit of HK\$126,951,000 (2023: HK\$69,331,000) generated mainly from property development and investment operations and multi-media and entertainment business operations.

Loss attributable to owners of the Company for the year ended 31st December 2024 amounted to HK\$351,930,000, representing an increase of 22% from HK\$289,477,000 in the previous year.

DIVIDEND

The directors do not recommend the payment of a final dividend for the year ended 31st December 2024 (2023: nil).

業務回顧

本集團有三個須予報告分類—(1)電影相關業務經營業務；(2)物業開發及投資經營業務；及(3)多媒體及娛樂經營業務。

在本年度總收益中，2,188,000港元或0%來自電影相關業務經營業務，675,240,000港元或93%來自物業開發及投資經營業務，及50,788,000港元或7%來自多媒體及娛樂經營業務。

電影相關業務經營業務

電影相關業務經營業務包括投資、製作、發行及授權電影及電視連續劇以及提供其他電影相關服務，包括藝人管理服務。

過往數年內，本集團轉移資源至物業投資及開發以及多媒體及娛樂業務方面，故於此分類調撥較少資源。電影製作為本集團的持續業務，收益可來自片庫銷售並代其他片主代發行電影。憑著我們在行內的豐富經驗及網絡，本集團認為我們於此分類具備相對優勢。本集團有一個新製作正在撰寫劇本階段，並預期於二零二五年開始製作。本集團亦計劃開始投資於現時在娛樂市場非常流行的短劇及網絡電影。本集團亦有投資於與其他製作公司合資製作電影，並將根據相關協議之投資百分比分享所投資電影的收益。本集團於此類聯合製作安排中屬被動角色，但需投入較少人力資源。

BUSINESS REVIEW

The Group has three reportable segments – (1) film related business operations; (2) property development and investment operations; and (3) multi-media and entertainment business operations.

Of the total revenue for the year, HK\$2,188,000 or 0% was generated from film related business operations, HK\$675,240,000 or 93% was generated from property development and investment operations, and HK\$50,788,000 or 7% was generated from multi-media and entertainment business operations.

Film Related Business Operations

Film related business operations included investment, production, distribution and licensing of films and television drama series and provision of other film related services including artist management services.

During the previous few years, the Group has shifted its resources to property investment and development; and multi-media and entertainment business and thus contributed less resources in this segment. Film production is the Group's ongoing business, revenue can come from sales of film library and sub-distribute films on behalf of other film owners. With our extensive experience and network in the industry, the Group considers that we have comparative advantage in this segment. A new production of the Group is in script writing process and expects to start production in year 2025. The Group also plan to start investment in short dramas and internet movies which are now very popular in the entertainment market. The Group also has investment in production of film which is co-financing with other production companies and will share revenue from the invested film according to the investment percentage in the relevant agreement. The Group takes a passive role in this kind of co-production arrangement but needs to contribute less human resource.

於二零二四年，電影相關業務經營業務之收益為2,188,000港元（二零二三年：4,435,000港元）而其分類虧損為85,465,000港元（二零二三年：52,560,000港元）。本集團目前並無正在製作中的電影或電視連續劇，而本年度收益主要為代發行費及藝人管理服務費。分類虧損主要包括電影投資之公平價值變動所產生之虧損69,433,000港元（二零二三年：7,265,000港元），主要為於二零二四年上畫的一齣電影（其票房和收益均不理想）之投資；有關電影版權之已確認減值虧損4,800,000港元（二零二三年：100,000港元）；及有關製作中電影之已確認減值虧損9,625,000港元（二零二三年：無）。去年，已就電影相關業務之按金及其他應收款項之預期信貸虧損撥備41,060,000港元，因就向一間製作公司支付製作電視連續劇之已付按金人民幣38,000,000已清算。

物業開發及投資經營業務

物業開發及投資經營業務包括投資及開發物業以及狄荳尼•豪舍之物業管理服務。本集團於澳門主要有兩個項目，即(i)位於何鴻樂博士大馬路南灣湖畔地區，名為「南灣湖計劃C區7地段」之土地，其於澳門物業登記局之登記編號為第23070號（「C7物業」）；及(ii)位於澳門高美士街及廈門街之狄荳尼•豪舍。

In year 2024, revenue from film related business operations amounted to HK\$2,188,000 (2023: HK\$4,435,000) and its segment loss amounted to HK\$85,465,000 (2023: HK\$52,560,000). The Group currently has no film or television drama series in production stage and this year's revenue was mainly sub-distribution fees and artist management service fees. The segment loss mainly included loss arising on change in fair value of investment in films of HK\$69,433,000 (2023: HK\$7,265,000) which mainly represented investment in a film released in year 2024 with poor box office and revenue; impairment loss recognized in respect of film rights of HK\$4,800,000 (2023: HK\$100,000); and impairment loss recognised in respect of films in progress of HK\$9,625,000 (2023: nil). For the last year, allowance for ECL on deposits and other receivables for film related business of HK\$41,060,000 was made as deposit paid to a production house for production of television drama series amounted to RMB38,000,000 was liquidated.

Property Development and Investment Operations

Property development and investment operations included investing and development of properties and property management services of Tiffany House. The Group mainly has two projects in Macau, namely (i) Lot C7 do Plano de Urbanizacao da Baia de Praia Grande, located in the Nam Van Lakes Zone, at Avenida Doutor Stanley Ho, registered with the Macau Land and Real Estate Registry under no. 23070 (the "Property C7"); and (ii) Tiffany House located at Rua De Luis Gonzaga Gomes and Rua De Xiamen, Macau.

根據土地工務局（「土地工務局」）於二零二三年六月二十九日發佈的城市規劃圖，C7物業（一幅地盤面積為4,669平方米的地皮）乃發展作住宅及停車場用途，其樓宇最大許可高度為海拔46.7米及最大許可地積比率為5.58倍（不包括停車場）。C7物業將發展成一幢十三層高的樓宇連一個地庫，其建築樓面面積為(a)住宅—25,832平方米；(b)商業—215平方米；及(c)停車場—3,930平方米。於二零二三年，本集團與澳門知名物業開發商訂立經營委託協議及主要銷售協議，並委託其協助C7物業的設計、開發及建築、銷售及融資安排。本集團認為，此等對C7物業的專業安排可加快建築進程並協助後期銷售。C7物業的建築工程已於二零二三年十二月十四日開始。C7物業現正式命名為「天璽•湖」，並將提供312個住宅單位（包括15座別墅）、一個商業單位及地下設144個車位及30個摩托車車位。C7物業已於二零二五年一月二十四日完成封頂，並於二零二五年一月十三日取得其預售許可證。佔用許可證則預期於二零二六年上半年取得。年內，本集團已取得一筆550,000,000港元之信貸融資以撥付C7物業的建築成本、設計及銷售開支。該信貸以將建在C7物業上的租賃土地及物業之首次法律按揭作抵押，並將於提取日期後二十八個月到期。本集團正準備於二零二五年預售C7物業。經上述所有安排後，本集團已準備就C7物業的開發及銷售所需資金。

如下文「重大投資、重大收購及出售」一節所詳細披露，收購事項（定義見下文）於二零二四年七月十二日完成後，本集團實際擁有C7物業之75%權益。

The Property C7 is a lot of land with site area of 4,669 square meters which are developing for residential and parking purpose with the maximum allowed height of the building of 46.7 meters above sea level and maximum utilization rate of 5.58 (parking not included) according to the Urbanistic Conditions Plan issued by Land and Urban Construction Bureau (“DSSCU”) on 29th June 2023. The Property C7 will be developed into a thirteen storey building and one basement and will have a gross floor area of (a) residential – 25,832 square meters, (b) commercial – 215 square meters and (c) parking – 3,930 square meters. In year 2023, the Group has entered into an operation entrustment agreement and a main sale agreement with a well-known Macau property developer and entrust it to assist for design, development and construction, sales and finance arrangement of the Property C7. The Group considered that this professional arrangement for the Property C7 can speed up the construction process and assist the later sales. The construction work of the Property C7 commenced on 14th December 2023. The Property C7 is formally named as “Lake Yoho” and will provide 312 residential units with 15 villas, one commercial unit, and 144 carparks and 30 motorcycle parks at the underground level. The Property C7 has completed its topping out on 24th January 2025 and obtained its presale permit on 13th January 2025. The occupation permit is expected to obtain in the first half of year 2026. During the year, the Group has obtained a credit facility in the amount of HK\$550,000,000 to finance the construction costs, design and sales expenses of the Property C7. The facility is secured by first legal mortgage over the leasehold land and properties to be erected on Property C7 and will mature twenty-eight months after the date of drawdown. The Group is preparing for pre-sale of Property C7 in year 2025. After all these arrangements, the Group has ready for the funding required for development and sales of Property C7.

After the completion of the Acquisition (defined below) on 12th July 2024 as detailed disclosed in the below section “Significant Investments, Material Acquisitions and Disposals”, the Group effectively owned 75% interest in the Property C7.

狄梵尼•豪舍鄰近澳門理工學院，毗鄰金蓮花廣場，澳門漁人碼頭及金沙娛樂場亦近在咫尺。狄梵尼•豪舍的建築樓面面積為：(a)住宅—31,192平方米，包括3,819平方米作會所；(b)商業—3,716平方米；及(c)停車場—11,250平方米。樓盤分兩幢大樓提供230個住宅單位，由開放式單位到四房公寓以及特式單位，以及地下三層設272個車位及75個摩托車車位。當中顯赫的會所由香港著名電影美術指導及服裝設計師張叔平先生設計，提供多種設施，包括泳池、健身室、設備齊全的廚房、瑜珈及舞蹈室等。狄梵尼•豪舍於二零一九年十二月取得其佔用許可證。狄梵尼•豪舍的住宅單位於二零二二年十月開始推售，並於二零二三年一月完成首筆成交。狄梵尼•豪舍第一座首先推售，提供115個住宅單位，建築樓面面積161,000平方呎。第二座面向金蓮花廣場及松山，提供115個單位，建築樓面面積175,000平方呎，預期呎價較高並已於二零二四年九月開售。年內，第一座有66個住宅單位（建築樓面面積87,000平方呎），第二座有16個住宅單位（建築樓面面積15,000平方呎），以及27個車位及5個摩托車車位已成交，總代價為674,308,000港元。截至二零二四年十二月三十一日，仍有126個住宅單位（建築樓面面積218,000平方呎）、243個車位及70個摩托車車位未售，其中21個住宅單位（建築樓面面積33,000平方呎）、5個車位及2個摩托車車位已簽署臨時協議，總代價為197,697,000港元。年內，澳門政府宣佈對澳門房地產政策作出大幅更改。於二零二四年一月統一所有住宅的按揭成數上限為七成，以及於二零二四年四月免除徵收懲罰性稅項，有助於業主提升或更換更大的單位並改善其居住環境。該等措施因而有助於狄梵尼•豪舍的銷售，因其擁有相對較多的較大單位。我們的市場推廣策略為「以類同價錢享有更大單位」，並因而於本年度取得較多成交。然而，我們物業的價值難免受到澳門住宅市場下滑的影響。本集團相信卓越的大廈管理服務可提升物業價值，故狄梵尼•豪舍由集團自組大廈管理團隊管理，為全部住戶提供卓越服務。

Tiffany House is located adjacent to Macao Polytechnic Institute and next to Golden Lotus Square, and is a couple of blocks away from Macau Fisherman's Wharf and Sands Casino. Tiffany House has a gross floor area of (a) residential – 31,192 square meters, including 3,819 square meters for clubhouse, (b) commercial – 3,716 square meters and (c) parking – 11,250 square meters. It provides 230 residential units in two towers, with units ranging from studio flats to four-bedroom apartments as well as special units and 272 carparks and 75 motorcycle parks in three underground levels. A prestigious clubhouse decided by Mr. William Chang, a famous art director and star designer in Hong Kong which provides a wide range of facilities including swimming pool, gym room, well equipped kitchen, yoga and dance room, etc. Tiffany House has obtained its occupational permit in December 2019. The sales of the residential units of Tiffany House started in October 2022 and its first sales completed in January 2023. Sales started at Tower 1 of Tiffany House with 115 residential units and gross floor area of 161,000 square feet. Tower 2 which facing Golden Lotus Square and Guia Hill with 115 units and gross floor area of 175,000 square feet are expected to have higher unit price has started sales in September 2024. During the year, sales of 66 residential units with gross floor area of 87,000 square feet in Tower 1, 16 residential units with gross floor area of 15,000 square feet in Tower 2 and 27 carparks and 5 motorcycle parks were completed with aggregate consideration of HK\$674,308,000. As at 31st December 2024, there were 126 residential units with gross floor area of 218,000 square feet, 243 carparks and 70 motorcycle parks unsold, of which 21 residential units with gross floor area of 33,000 square feet, 5 carparks and 2 motorcycle parks have signed provisional agreements with aggregate consideration of HK\$197,697,000. During the year, the Macau government has announced substantial changes to Macau's real estate policy. The removal of the standardization of the maximum mortgage limit across all residences at 70% in January 2024 and the relief of imposition of punitive taxes in April 2024 have aid property owners looking to upgrade or alter their living conditions for larger units. In turn, these measures have benefit sales of Tiffany House which has comparatively more large units. Our marketing strategy is "you pay similar price and you enjoy larger area" and therefore we achieved higher transactions in this year. However, our properties value is unavoidably affected by the downturn of residential market in Macau. The Group believes that excellent building management services can increase the value of the properties and thus Tiffany House is managed by our self-formed building management services teams and has provided excellent services to all tenants.

於二零二四年，物業開發及投資經營業務之收益為675,240,000港元（二零二三年：148,230,000港元），而其分類虧損為121,106,000港元（二零二三年：134,374,000港元）。本年度所有收益均來自狄梵尼•豪舍之銷售。分類虧損主要包括狄梵尼•豪舍之銀行貸款（「定期貸款」）之融資成本113,474,000港元（二零二三年：139,006,000港元）及狄梵尼•豪舍之撇減28,481,000港元（二零二三年：無）。融資成本繼續對物業開發及投資經營業務的表現構成負擔。狄梵尼•豪舍之撇減指部分個別單位價格之賬面值較其估計售價之不足。於二零二四年，本集團作出加快物業銷售進程的明智決定，並成功減少定期貸款及其融資成本。二零二四年澳門住宅成交宗數增加11%，惟整體住宅單位每平方米平均價按年下跌9%。踏入二零二五年首季，樓市繼續疲弱，市場觀望氣氛濃厚。

多媒體及娛樂經營業務

杭州英明向太多媒體有限公司為本公司於中國的全資附屬公司，主要業務為多媒體及娛樂經營業務，包括在多頻道網絡電子商務平台直播電子商務的開發、推廣及經營，並開發及銷售自家品牌產品。我們已建立由多名優秀帶貨主播組成的團隊並於抖音設立多個直播頻道（包括我們的主要抖音賬號向太陳嵐、向太奢品及向祥官方旗艦店），以提升我們的客戶基礎。本集團將其定位至適當市場份額，即名牌手袋等優質產品。抖音頻道向太奢品曾創出單日過百萬人民幣的商品交易總額（「商品交易總額」）及單日逾八千萬觀眾的記錄，且現為抖音頭號名牌手袋賣家。於截至二零二四年十二月三十一日止年度內，除繼續作為互聯網平台的中介，並從透過我們的直播頻道完成的每筆銷售廣告費收入中抽取佣金外，我們亦開發自家品牌產品，與其他供應商或廠家合作，生產我們的自家品牌產品。於二零二四年七月，我們推出首個自家品牌產品「陳皮蓮子紅豆沙」。我們的紅豆沙以高質紅豆、十年以上陳皮及其他新鮮原料製成，區別於市場上

In year 2024, revenue from property development and investment operations amounted to HK\$675,240,000 (2023: HK\$148,230,000) and its segment loss amounted to HK\$121,106,000 (2023: HK\$134,374,000). All revenue in this year came from sales in Tiffany House. The segment loss was mainly included finance costs for the bank loan of Tiffany House (the "Term Loan") amounted to HK\$113,474,000 (2023: HK\$139,006,000) and the write-down of Tiffany House of HK\$28,481,000 (2023: nil). The finance costs continued the burden for the performance of the property development and investment operations. Write down of Tiffany House represented the shortfall of the carrying amount of some of individual unit prices compared with their estimated selling prices. In year 2024, the Group made sound decision towards speeding up the process of property sales and successfully decreased the Term Loan and its finance costs. Macau's total residential transactions increased by 11% in year 2024 but the average price per square meter of the overall residential units fell by 9% year-on-year. In the first quarter of year 2025, the property market continues to be sluggish, and the market has a strong wait-and-see atmosphere.

Multi-media and Entertainment Business Operations

杭州英明向太多媒體有限公司，a wholly owned subsidiary of the Company in China which principal activities are multi-media and entertainment business operations which included development, promotion and operation of livestreaming e-commerce in multi-channel network e-commerce platform and development and sales of private label products. We have established team of talented livestreamers and set up various livestreaming channels in Douyin including our main Douyin account 向太陳嵐，向太奢品 and 向祥官方旗艦店 to enhance our customer base. The Group has positioned it to the appropriate market share, i.e. premium products such as brand handbags. Our Douyin channel 向太奢品 has created the record of over RMB100 million gross merchandise value ("GMV") a day and over 80 million viewers in the day and is now the first seller in Douyin for brand bags. During the year ended 31st December 2024, other than being as the mediator in the internet platform and keep a margin of commission each & every sale that is done through our livestreaming channels advertising fees income, we have developed our private label products and cooperate with other suppliers or factories to produce our private label products. In July 2024, we launched

絕大多數同類產品。我們以口號「很向樣的」向客戶傳達產品更優越和更健康的消息，並將其定位為可滿足消費者一天不同時刻需要的「健康早餐、元氣午茶、運動健身、輕食晚餐」。於二零二四年十月，我們推出另一款人氣產品「很向樣的牛肉干」，其口號為「巴掌大的牛肉乾，濕潤好嚼絲絲爆香」。於二零二五年一月至二月間，存貨日日售清，我們更要求供應商增加產能。直至截至二零二四年十二月三十一日止年度，我們已先後推出陳皮蓮子紅豆沙、很向樣的牛肉干、鳳凰酥及桂花銀耳炖整梨，除抖音直播外，該等產品的銷售渠道還包括淘寶、小紅書、天貓及微信小程序以增加銷售渠道。我們的自家品牌產品在市場上變得越受認可，迅速成為「品質、優品及時尚」的代名詞，故而我們的品牌正贏得數以百萬計的消費者回頭光顧。

於二零二四年，我們的商品交易總額（計及銷貨退回後）為人民幣378,357,000。多媒體及娛樂經營業務之收益為50,788,000港元（二零二三年：53,503,000港元），而其分類虧損為55,780,000港元（二零二三年：58,973,000港元）。收益與去年相若，因本集團轉移其部分資源開發自家品牌產品，而該等產品於下半年開始推出。虧損主要包括行政、市場推廣及經營開支。隨著愈來愈多的新加入者加入直播電子商務行業，競爭日趨激烈。來自直播的佣金利潤和收入難免受影響。我們的產品必須獨一無二並且優於其他競爭對手，因此我們生產、革新並開發出自家品牌產品「向樣」。於二零二五年初，我們的自家品牌產品在市場上越加受人歡迎。於截至二零二四年十二月三十一日止年度內，本集團已建立更全面組織架構以配合此業務的迅速增長，及為其未來發展奠定穩固根基，故市場推廣及廣告開支乃用於增加銷售渠道曝光度及追隨者數量。

our first private label product “Red Beans Paste (陳皮蓮子紅豆沙)”. Our Red Beans Paste is made of high-quality red beans, over 10 years tangerine peel and other fresh ingredients which is differentiated from most similar products on the market. We use the slogan “很向樣的” to convey the superior and healthier message of the product to our customers and position it as “健康早餐、元氣午茶、運動健身、輕食晚餐” in order to satisfy the consumers’ needs in different moment of a day. In October 2024, we launch another popular product “Beef Jerky (很向樣的牛肉干)”, its slogan is “巴掌大的牛肉乾，濕潤好嚼絲絲爆香”. In January and February 2025, our stock sold out every day and we have to demand supplier to increase their production capacities. Up to the year ended 31st December 2024, we have already launched Red Beans Paste (陳皮蓮子紅豆沙), Beef Jerky (很向樣的牛肉干), Fengheung Pastry (鳳凰酥) and Stewed whole pear with Osmanthus and White Fungus (桂花銀耳炖整梨). Other than livestreaming in Douyin, the sales channel of these products include Taobao (淘寶), Rednote (小紅書), Tmall (天貓) and Mini program (微信小程序) in order to increase our sales channels. Our private label products become increasingly recognise in the market, quickly becoming synonymous with “quality, premium and lifestyle” and thereby, our brand is gaining millions of returning customers.

In year 2024, our total GMV (after sales return) was RMB378,357,000. Revenue from multi-media and entertainment business operations amounted to HK\$50,788,000 (2023: HK\$53,503,000) and its segment loss amounted to HK\$55,780,000 (2023: HK\$58,973,000). The revenue was similar to last year as the Group shifted part of its resource to development of private label products and these products start to launch in the second half of the year. The loss mainly included administrative, marketing and operation expenses. As more and more new joiners enter the livestreaming e-commerce industry, competition becomes increasingly fierce. The commission margin and income from livestreaming is unavoidable influenced. Our products must be unique and superior to other competitors, so we produce, renovate and develop our private label products “向樣”. Our private label products become more popular in the market in the beginning of year 2025. During the year ended 31st December 2024, the Group has built a more comprehensive organization structure to support the rapid growth of this business and to lay a solid foundation for its future development and thus marketing and advertising expenses are spent to increase the publicity of our sales channels and the number of our followers.

其他經營業務

就位於狄梵尼•豪舍的商場方面，本集團擬將其發展為購物商場，為狄梵尼•豪舍的住戶及附近居民提供餐廳、商店及日常所需。於二零二四年，本集團已開設一間餐廳、一間咖啡廳及一間便利店。由於所有該等經營業務仍處於早期階段，故我們不會將其分類為新的及須予報告業務分類。於截至二零二四年十二月三十一日止年度內，該等業務仍在虧損狀態。該等業務需要時間增加客量及達致收支平衡。

地區分類

就地區分類方面，收益192,000港元或0%（二零二三年：805,000港元或1%）源自香港，收益675,240,000港元或93%（二零二三年：148,230,000港元或72%）源自澳門，收益52,784,000港元或7%（二零二三年：56,673,000港元或27%）源自中國，並無收益（二零二三年：460,000港元或0%）源自其他地區。來自澳門之收益主要為狄梵尼•豪舍之物業銷售，而來自中國之收益主要為多媒體及娛樂經營業務之收入。

行政開支

截至二零二四年十二月三十一日止年度，行政開支為147,094,000港元（二零二三年：95,408,000港元），即增加54%。該增加主要包括我們的多媒體及娛樂經營業務、餐飲經營業務及零售銷售業務所產生的行政開支。於年內，本集團之員工人數及營運處所均有增加。折舊由截至二零二三年十二月三十一日止年度之12,071,000港元增至截至二零二四年十二月三十一日止年度之27,621,000港元，增幅為129%，因餐飲經營業務及零售銷售之裝修於年內開始折舊。分類為行政開支之僱員福利開支為62,178,000港元，較43,023,000港元亦增加45%。

Other Business Operations

For the commercial mall in Tiffany House, the Group intends to develop it into shopping mall which can provide restaurants, shops and daily necessities to the tenants in Tiffany House and the nearby residents. In year 2024, the Group has opened a restaurant, a café and a convenient store. As all these business operations are still in its early stages, we will not classify them into new and reportable business segments. During the year ended 31st December 2024, these operations were still operated at a loss. They need time to increase their customers and reach a balance between income and expenditure.

Geographical Segments

For the geographical segments, revenue of HK\$192,000 or 0% (2023: HK\$805,000 or 1%) was sourced from Hong Kong, revenue of HK\$675,240,000 or 93% (2023: HK\$148,230,000 or 72%) was sourced from Macau, revenue of HK\$52,784,000 or 7% (2023: HK\$56,673,000 or 27%) was sourced from China and no revenue (2023: HK\$460,000 or 0%) was sourced from other territories. Revenue from Macau mainly represented property sales of Tiffany House and revenue from China mainly represented income from multi-media and entertainment business operations.

Administrative Expenses

For the year ended 31st December 2024, administrative expenses amounted to HK\$147,094,000 (2023: HK\$95,408,000), representing an increase of 54%. The increase mainly included administrative expenses incurred in our multi-media and entertainment business operations, catering operations and the operation of retail sales. During the year, both headcount and operation premises of the Group were increased. Depreciation increased from HK\$12,071,000 from the year ended 31st December 2023 to HK\$27,621,000 for the year ended 31st December 2024, an increased by 129% as decorations in catering operations and retail sales started depreciation in the year. Employee benefit expenses classified as administrative expenses amounted to HK\$62,178,000 as compared to HK\$43,023,000, also increased by 45%.

市場推廣、銷售及發行開支

截至二零二四年十二月三十一日止年度，市場推廣、銷售及發行開支為101,043,000港元（二零二三年：79,108,000港元），即增加28%。該增加主要為狄梵尼•豪舍之市場推廣及銷售開支，包括委聘顧問公司及代理佣金，以及多媒體及娛樂經營業務所產生的市場推廣開支，包括廣告開支，以維持抖音賬號等直播頻道的曝光度及追隨者數量。

融資成本

截至二零二四年十二月三十一日止年度，融資成本134,827,000港元（二零二三年：142,994,000港元）已於綜合收入表扣除，主要包括狄梵尼•豪舍建築成本融資之利息113,474,000港元（二零二三年：139,006,000港元）。C7物業建築成本融資之利息29,286,000港元（二零二三年：無）已資本化為物業存貨。於綜合收入表扣除之融資成本減少主要因為年內償還貸款後定期貸款減少所致。

流動資金及財務資源及資本架構

於二零二四年十二月三十一日，本集團之總資產為4,205,511,000港元（二零二三年：5,184,596,000港元），而流動資產淨值則為2,863,164,000港元（二零二三年：3,833,363,000港元），即流動比率為4.6（二零二三年：4.5）。本集團之現金及銀行結餘、定期存款及受限制現金總結餘為126,425,000港元（二零二三年：130,581,000港元）。

Marketing, Selling and Distribution Expenses

For the year ended 31st December 2024, marketing, selling and distribution expenses amounted to HK\$101,043,000 (2023: HK\$79,108,000), representing an increase of 28%. The increase was mainly due to marketing and selling expenses of Tiffany House which included engagement of consultancy parties and agency commission and marketing expenses incurred in multi-media and entertainment business operations which included advertising expenses in maintaining the publicity of the livestreaming channels such as the Douyin accounts and the number of followers.

Finance Costs

For the year ended 31st December 2024, finance costs amounted to HK\$134,827,000 (2023: HK\$142,994,000) were charged to the consolidated income statement which mainly included interests financing construction costs of Tiffany House amounted to HK\$113,474,000 (2023: HK\$139,006,000). Interests amounted to HK\$29,286,000 (2023: nil) financing construction costs of the Property C7 were capitalized to stock of properties. The decrease in finance costs charged to consolidated income statement was mainly due to decrease of Term Loan after loan repayment in the year.

LIQUIDITY AND FINANCIAL RESOURCES AND CAPITAL STRUCTURE

As at 31st December 2024, the Group had total assets of HK\$4,205,511,000 (2023: HK\$5,184,596,000) and net current assets of HK\$2,863,164,000 (2023: HK\$3,833,363,000), representing a current ratio of 4.6 (2023: 4.5). The Group had cash and bank balances, time deposits and restricted cash in aggregate balance of HK\$126,425,000 (2023: HK\$130,581,000).

As at 31st December 2024, the Group had total borrowing of HK\$1,629,316,000 (2023: HK\$1,803,257,000) which comprised the Term Loan of HK\$1,057,829,000 (2023: HK\$1,580,312,000), a secured bank loan (the “Secured Loan”) of HK\$80,986,000 (2023: HK\$87,142,000), a secured term loan from a finance company (the “Short Term Loan”) of HK\$165,000,000 (2023: unsecured loan of HK\$100,000,000), an unsecured loan from a related company (the “Director Loan”) of HK\$35,000,000 (2023: nil), a secured property loan (the “Construction Loan”) and its accrued interests of HK\$272,315,000 (2023: nil) and lease liabilities of HK\$18,186,000 (2023: HK\$35,803,000).

The purpose of the Term Loan is to finance the construction costs and any other soft costs in relation to Tiffany House and secured by first legal mortgage over properties of Tiffany House with carrying amount as stock of properties and restricted cash in aggregate amount of HK\$1,460,572,000 (2023: HK\$2,308,160,000), interest bearing at Hong Kong Interbank Offered Rate (“HIBOR”) for three or six month period selected by the borrower plus margin of 2.85% (2023: HIBOR plus 3%) per annum for each interest period and its minimum repayment schedules are as follows:

定期貸款中有一項條款，除非經貸款人批准，否則必須提前償還狄梵尼·豪舍銷售所得款項淨額的90%（扣除貸款人接受的直接開支）或處置狄梵尼·豪舍的任何財產或資產。狄梵尼·豪舍還款後剩餘銷售所得款項須存入扣賬戶口，且只能用於支付定期貸款之利息。原定期貸款信貸為1,700,000,000港元，經合共償還642,171,000港元後，未償還結餘為1,057,829,000港元，已符合首24個月的最低還款規定。於截至二零二四年十二月三十一日止年度內，本集團已償付本金522,483,000港元，並須於未來12個月內再償付本金47,829,000港元以符合最低還款規定。

有抵押貸款原貨幣金額342,000,000新台幣，以賬面值為150,297,000港元的投資物業作抵押，按中華郵政股份有限公司新台幣存款兩年期浮動利率加1.43厘息差（即於二零二四年十二月三十一日為3.15厘）之年利率計息，並將於二零二八年三月十二日到期。

短期貸款以本集團賬面值為42,799,000港元（二零二三年：無）之物業及由本公司董事兼控股股東向華強先生及陳明英女士所提供的個人擔保作抵押，按年利率13.5厘計息，並將於二零二五年十一月二十日到期。短期貸款部分資金已於二零二四年十一月二十日用以償付本金額為100,000,000港元之無抵押貸款，其按年利率10厘計息。

董事貸款為無抵押，按年利率13.5厘計息，並將於二零二五年十一月二十日到期。董事貸款之資金來源與及短期貸款相同。償還董事貸款於短期貸款後遞延。

There is a clause in the Term Loan that mandatory prepayment in an amount of 90% of the net sales proceeds from Tiffany House (net deduction of direct expenses to be accepted by the lender) or dispositions of any properties or assets of Tiffany House unless otherwise approved by the lender. The remaining sales proceeds from Tiffany House after the repayment shall be deposited into charge accounts, and can only be used for the payment of interest of the Term Loan. The original Term Loan facility was HK\$1,700,000,000, after an aggregate repayment of HK\$642,171,000, the outstanding balance is HK\$1,057,829,000 which has fulfilled the minimum repayment requirement in the first 24 months. During the year ended 31st December 2024, the Group repaid principal of HK\$522,483,000 and has to repay further principal of HK\$47,829,000 within the next 12 months in order to fulfill the minimum repayment amount.

The Secured Loan is in original currency of New Taiwan Dollar 342,000,000, secured by investment property in carrying amount of HK\$150,297,000, interest bearing at floating rate of 2-year New Taiwan Dollar deposit at Chungwa Post Co., Ltd plus margin 1.43% per annum (i.e. 3.15% as at 31st December 2024) which will mature on 12th March 2028.

The Short Term Loan is secured by the Group's property in carrying amount of HK\$42,799,000 (2023: nil), personal guarantee provided by Mr. Heung Wah Keung ("Mr. Heung") and Ms. Chen Ming Yin Tiffany ("Ms. Chen"), being directors and controlling shareholders of the Company, interest bearing at 13.5% per annum and will mature on 20th November 2025. Part of the funding from the Short Term Loan was used to repay an unsecured loan in principal amount of HK\$100,000,000 on 20th November 2024 which was interest bearing at 10% per annum.

The Director Loan is unsecured, interest bearing at 13.5% per annum and will mature on 20th November 2025. The source of fund for the Director Loan was same as the Short Term Loan. The repayment of the Director Loan is deferred after the Short Term Loan.

The purpose of the Construction Loan is to finance the construction costs, design and sales expenses of the Property C7. The facility amount of the Construction Loan is HK\$550,000,000, secured by first legal mortgage over the leasehold land and properties to be erected on Property C7 with carrying amount as stock of properties of HK\$1,670,860,000 and will mature twenty-eight months after the date of drawdown, i.e. 2nd November 2026. Interest is payable annually at the rate of 18% per annum.

As at 31st December 2024, the Group had bank and other credit facilities amounted to HK\$2,466,746,000 which were utilized to extent of HK\$2,030,986,000. The Group's gearing was acceptable during the year with total debts of HK\$1,629,316,000 (2023: HK\$1,803,257,000) against owners' equity of HK\$2,053,818,000 (2023: HK\$2,661,142,000). This represents a gearing ratio, calculated in the basis of the Group's total borrowings over owners' equity of 79% (2023: 68%).

As at the date of approving these annual results and as at 31st December 2024, the fair value of the Group's equity securities listed in Hong Kong held at 31st December 2024 was HK\$8,183,000 (excluded fair value of equity security stated at HK\$2,700,000 sold after 31st December 2024) and HK\$11,802,000 respectively. During the year ended 31st December 2024, the Group did not acquired or disposed any equity securities listed in Hong Kong. The loss arising on change in fair value of financial assets at fair value through profit and loss of HK\$9,933,000 was resulted from change in fair values of equity securities listed in Hong Kong between the year ended 31st December 2024 and 31st December 2023. As at 31st December 2024, no single equity security's fair value held by the Group accounted for 5% or more of the total assets of the Group.

During the year, 164,000,000 awards granted to Ms. Chen, the substantial shareholder and executive director of the Company were lapsed and no awards were granted, vested, expired or cancelled. As at 31st December 2024, there were no awards outstanding.

During the year ended 31st December 2024, no share options of the Company were outstanding, granted, exercised, lapsed, expired or cancelled.

資產抵押

於二零二四年十二月三十一日，賬面總值1,460,572,000港元之物業存貨及若干銀行賬戶以及本公司全資附屬公司中國星創新發展有限公司（從事物業開發及投資業務）之定額資本已質押作為本集團獲授予的銀行信貸1,700,000,000港元之抵押品；賬面值1,670,860,000港元之物業存貨已質押作為本集團獲授予的其他信貸融資550,000,000港元之抵押品；定期存款168,000港元因在澳門開發物業存貨需繳納按金而已作為保證金質押予澳門政府；本集團賬面值42,799,000港元之物業已質押作為短期貸款信貸之抵押品；及賬面值150,297,000港元之投資物業已質押作為有抵押貸款信貸之抵押品。

匯兌風險及對沖

本集團大部份交易、資產及負債以港元、澳門幣、美元、新台幣及人民幣列值。人民幣匯率波動之風險主要來自在中國之多媒體及娛樂經營業務，以及電影投資、製作及發行所產生收支。本集團會密切監察此波動並於必要時考慮對沖活動。其他貨幣之波動風險甚低，故認為無需任何對沖活動。

As at 31st December 2024, stock of properties and certain bank accounts in aggregate carrying amount of HK\$1,460,572,000 and quota capital of China Star Creative Development Limited, a wholly owned subsidiary of the Company which is engaged in the business of property development and investment has been pledged for banking facilities of HK\$1,700,000,000 granted to the Group; stock of properties in carrying amounts of HK\$1,670,860,000 has been pledged for other credit facilities of HK\$550,000,000 granted to the Group; time deposit in amount of HK\$168,000 has been pledged as guarantee to Macau government for deposits in the development of stock of properties in Macau; the Group's property in carrying amount of HK\$42,799,000 has been pledged for the Short Term Loan facility; and investment property in carrying amount of HK\$150,297,000 has been pledged for the Secured Loan facility.

EXCHANGE RISK AND HEDGING

Majority of the Group's transactions, assets and liabilities are denominated in Hong Kong Dollar, Macau Pataca, United States Dollar, New Taiwan Dollar and Renminbi. The exposure to fluctuation in exchange rates in Renminbi mainly arises from multi-media and entertainment business operations in China and receipts and expenditure incurred in film investment, production and distribution. The Group has closely monitors its exposure to this fluctuation and consider appropriate hedging activities if necessary. The exposure to fluctuation in other currencies is consider to be minimal and no hedge activity is considered necessary.

COMMITMENTS

As at 31st December 2024, outstanding commitments by the Group amounted to HK\$1,058,405,000, of which HK\$1,025,212,000 for development expenditure of stock of properties in Macau, HK\$16,046,000 for development expenditure of catering operations in Macau and HK\$17,147,000 for film rights, films in progress and film deposits.

重大投資、重大收購及出售

本公司之間接全資附屬公司Modern Vision (Asia) Limited (「Modern Vision」) 現透過Over Profit International Limited (「Over Profit」) 間接擁有C7物業50%權益。於二零二四年二月二十日，由陳女士全資擁有之Reform Base Holdings Limited (「Reform Base」)、陳女士及Modern Vision訂立一項協議 (「該協議」)，據此，Reform Base 同意轉讓與Reform Base所持Over Profit股權有關之權利 (「權利」)，包括(1) Modern Vision有權就Over Profit之管理及經營向Reform Base提出建議；(2) Modern Vision有權推薦Modern Vision可能推選為Over Profit董事之人士；及(3) Modern Vision有權收取Over Profit應付或結欠Reform Base之股息及其他分派，代價為479,678,000港元 (「收購事項」)。代價須透過提供予董事之本金額為500,000,000港元之貸款中抵銷該金額之方式支付。而陳女士應於完成日期起計6至12個月內向Modern Vision支付差額20,322,000港元。有關交易構成本公司之須予披露交易及關聯交易，其已於二零二四年七月八日獲本公司股東批准，並已於二零二四年七月十二日完成。

年內概無其他重大投資、重大收購或出售。

僱員及薪酬政策

於二零二四年十二月三十一日，本集團僱用237名員工 (二零二三年：236名員工)，僱員福利開支 (包括董事薪酬) 為90,799,000港元 (二零二三年：58,404,000港元)，其中62,178,000港元 (二零二三年：43,023,000港元) 分類為行政開支及28,621,000港元 (二零二三年：15,381,000港元) 分類為市場推廣、銷售及發行開支，整體增加55%。增加主要包括負責在中國之多媒體及娛樂經營業務以及在澳門之餐飲及零售經營業務的員工人數增加。董事相信，其員工質素乃本集團維持聲譽及改善盈利能力之單一最重要因素。員工之酬金乃根據彼等之工作表現、專業經驗及當時之行業慣例而釐定。除基本薪金、公積金、住房津貼、膳食津貼、醫療計劃及酌情花紅外，若干員工更可按個別表現評估獲授購股權及股份獎勵。

SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS AND DISPOSALS

Modern Vision (Asia) Limited ("Modern Vision") which is an indirect wholly owned subsidiary of the Company is currently indirectly interested in 50% of the Property C7 through Over Profit International Limited ("Over Profit"). On 20th February 2024, Reform Base Holdings Limited ("Reform Base") which is wholly owned by Ms. Chen, Ms. Chen and Modern Vision entered into an agreement (the "Agreement") pursuant to which Reform Base has agreed to transfer the rights (the "Rights") in relation to the shareholding of Reform Base in Over Profit including: (1) the right of Modern Vision to make recommendations to Reform Base on the management and operations of Over Profit; (2) the right of Modern Vision to make recommendation of such persons as Modern Vision may elect to be directors of Over Profit; and (3) the right for Modern Vision to receive dividends and other distribution of Over Profit payable or due to Reform Base, at the consideration of HK\$479,678,000 (the "Acquisition"). The consideration shall be satisfied by setting-off such amount from loan to director in principal amount of HK\$500,000,000. The difference of HK\$20,322,000 should be pay by Ms. Chen to Modern Vision between 6 and 12 months from date of completion. The transaction constitutes a disclosable transaction and connected transaction of the Company and was approved by the shareholders of the Company on 8th July 2024 and completed on 12th July 2024.

There were no other significant investments, material acquisitions or disposals during the year.

EMPLOYEES AND REMUNERATION POLICY

As at 31st December 2024, the Group employed 237 staff (2023: 236 staff) with employee benefit expenses (included directors' remuneration) of HK\$90,799,000 (2023: HK\$58,404,000), of which HK\$62,178,000 (2023: HK\$43,023,000) classified as administrative expenses and HK\$28,621,000 (2023: HK\$15,381,000) classified as marketing, selling and distribution expenses, an overall increase of 55%. The increase mainly included increase in headcount who are responsible for multi-media and entertainment business operations in China and catering and retail operations in Macau. The directors believe that the quality of its employees is the single most important factor in sustaining the Group's reputation and improving its profitability. The staff are remunerated based on their work performance, professional experience and prevailing industry practices. Apart from basic salaries, pension fund, housing allowances, meal allowances, medical schemes and discretionary bonuses, share options and share awards are awarded to certain staff according to the assessment of individual performance.

前景

二零二四年，本集團於狄梵尼•豪舍取得不俗銷售成績，而C7物業亦已開始施工並計劃於二零二五年預售。本集團就物業銷售取態保守，因澳門經濟對我們的物業銷售至關重要。於二零二四年，澳門慶祝回歸祖國二十五週年，習近平主席更親臨澳門出席慶祝回歸慶典及新一屆澳門政府就職儀式。此不單提升了澳門於實施「一國兩制」的信心，亦為澳門未來發展指明新方向。作為中國長期經濟發展的不可分割特區，澳門的經濟未來將會是穩健強勁的，也增加了我們對澳門前景的信心。未來幾年，澳門物業市場預期將迎來數個正面趨勢。澳門致力經濟多元化，避免過度依賴博彩及旅遊，將為工商類物業創造新機遇。同時，港澳與中國內地之間運輸連接改善，亦可提升我們所在地區物業的物業價值。澳門政府預期將為物業投資維持穩定而支持性的監管環境，鼓勵本地及境外投資者到來投資。我們的物業將可受惠於高淨值人士及投資者回流所帶動對豪宅物業的需求。然而，利率趨勢將仍是左右物業需求的重要因素。總言之，我們對澳門物業市道有信心，因有利好的政府政策、基建發展及跨界別需求上升作支持。投資者及準買家可望看到市道暢旺，無論是短期增益及長期投資均見機會處處。

PROSPECT

In year 2024, the Group has achieved remarkable sales in Tiffany House and the Property C7 has commenced construction and plans to pre-sell in year 2025. The Group adopts a conservative approach in selling properties and Macau's economy is crucial for our properties sales. In year 2024, Macau celebrated its 25th anniversary of returning to the motherland, President Xi Jinping visited Macau for the handover celebration and the inauguration ceremony of the new Macau government. This visit enhanced Macau's confidence in implementing "one country, two systems" outlined a new direction for Macau's future development. As an integral special region of China's long-term economic development, Macau's economic future is secure and strong, bolstering our confidence in Macau's prospects. Macau property market is expected to experience several positive trends in the coming years. Macau's efforts to diversify its economy away from heavy reliance on gaming and tourism will create new opportunities in commercial and industrial real estate. Meanwhile, improvements in transportation links between Macau, Hong Kong, and mainland China could have boosted property values in our properties' areas. Macau government is expected to maintain a stable and supportive regulatory environment for property investments, encouraging both local and foreign investors. Our properties will benefit from demand for luxury properties with the return of high-net-worth individuals and investors. However, the interest rate trends remain a significant factor influencing property demand. In conclusion, we are confidence with the Macau property market, supported by favorable government policies, infrastructure development, and increased demand across various sectors. Investors and potential buyers can anticipate a dynamic and growing market with numerous opportunities for both short-term gains and long-term investments.

二零二四年由於競爭激烈，本集團的直播電子商貿業務確受不利影響。然而，本集團仍看好中國的直播電子商貿業務的潛力。隨著越來越多消費者採用這種購物模式，競爭激烈亦帶來用戶不斷增長。我們的董事陳女士和向先生均為關鍵意見領袖和名人，每能透過直播帶動銷售，利用其眾多追隨者有效推廣產品。隨著我們不斷推出自家品牌產品，達到更廣泛的受眾且利潤率普遍較高，我們可以預期推高此類產品的銷售可進一步增加我們的收益。未來，我們的自家品牌產品將進軍店內銷售，因實體店仍是主要銷售渠道的重要一環。

總言之，中國的直播電子商貿前景秀麗，因有持續增長、技術創新及不斷演變的消費者偏好帶動。隨著市場成熟，將會更加融入全球電子商貿大局，密不可分。我們將不斷改善本公司的供應鏈管理能力，擴大產品組合，使能與更多電子商貿平台協作，訂製我們的產品組合以迎合不同平台目標消費者的多元化需要。此將確保消費者透過不同平台，都可一慣地收到高質產品、品牌經驗及服務。

展望未來，本集團將繼續抓緊多媒體及娛樂業務所帶來的利好機遇，並將提升狄梵尼•豪舍商場的開發以至住宅單位的銷售，以及將致力達致C7物業的高質開發，成功從其價值中獲利。

Due to the keen competition in year 2024, the Group's livestreaming e-commerce business has been adversely impacted. Nevertheless, the Group remains optimistic about the potential of livestreaming e-commerce business in China. Keen competition also leads to a growing user base as more consumers adopt this shopping method. Our directors, Ms. Chen and Mr. Heung are key opinion leaders and celebrities who play a crucial role in driving sales through live streaming by leveraging their large followings to promote products effectively. With the launch of more and more of our new private label products in the market, reaching a wider audience and with their generally higher margin, we can expect a boost in sales of these products which would further increase our revenue. In the future, our private label products will extend to in-store sales which remain a key part of major sales channels.

In conclusion, the future of livestreaming e-commerce looks promising, driven by sustained growth, technological innovation, and evolving consumer preferences. As the market matures, it will likely become an even more integral part of the global e-commerce landscape. With the Company's continuous improvements in supply chain management capabilities and the expansion of its product portfolio, we are able to collaborate with more e-commerce platforms and tailor our product portfolio to meet the diverse needs of target consumers of different platforms. This would ensure that consumers receive consistently high-quality products, brand experience and services through different platforms.

Looking forward, the Group will continue to grasp favorable opportunities brought by its multi-media and entertainment business and will enhance the development of commercial mall in Tiffany House as well as sales of residential units and will strive to achieve high quality development and successfully monetizing the value of the Property C7.

緒言

本公司董事(「董事」)會(「董事會」)及管理層致力設立良好企業管治常規及程序。本公司及其附屬公司(「本集團」)一向維持高水平之商業操守及企業管治常規，此乃本集團目標之一。本公司相信，良好企業管治所提供之架構，對有效管理、業務成功發展及建立良好企業文化屬至關重要，藉此提高股東之價值。

企業管治常規

本公司之企業管治原則著重董事會質素、穩健之內部監控，並且對全體股東具透明度及問責性。透過採用嚴密之企業管治常規，本集團相信將可改善問責性及透明度，從而增強股東及大眾之信心。截至二零二四年十二月三十一日止整個財政年度，本公司已應用並遵照香港聯合交易所有限公司(「聯交所」)證券上市規則(「上市規則」)附錄C1所載之《企業管治守則》(「企業管治守則」)之所有適用守則條文。董事會自聯交所首次建議就有關企業管治常規修訂上市規則後，一直監察及檢討本集團就企業管治常規之進度以確保符合規定。本公司於年內舉行多次會議，並於適當時向本集團董事及高級管理層發出通函及其他指引說明，以確保彼等知悉有關企業管治常規之事宜。

INTRODUCTION

The board (the “Board”) of directors (“Directors”) of the Company and the management of the Company are committed to establishing good corporate governance practices and procedures. The maintenance of high standard of business ethics and corporate governance practices has always been one of the goals of the Company and its subsidiaries (the “Group”). The Company believes that good corporate governance provides a framework that is essential for effective management, successful business growth and a healthy corporate culture, thereby leading to the enhancement of shareholders’ value.

CORPORATE GOVERNANCE PRACTICES

The corporate governance principles of the Company emphasize a quality Board, sound internal controls, transparency and accountability to all shareholders. 董事會

職責

董事會負責本公司之領導及監控工作，並監管本集團之業務、策略決策及表現，以及藉指引及監督本公司事務共同負責引領本公司邁向成功。實際上，董事會負責就本公司所有主要事項作出決策，包括：審批及監控所有政策事宜、制定目標、年度預算及整體策略、重大交易、委任董事及其他重大財務及經營事項。董事會亦負責履行整體的企業管治責任，包括制定及檢討本公司的企業管治政策及常規，檢討及監察董事及高級管理人員的培訓及持續專業發展，檢討及監察本公司在遵守法律及監管規定方面的政策及常規，制定、檢討及監察董事的操守守則，及檢討本公司遵守企業管治守則的情況。年內，董事會履行了所有以上職能。本公司之日常管理、行政及營運均由高級行政人員執行。有關職責包括實行董事會之決策、根據董事會審批之管理策略及計劃協調及指引本公司日常營運及管理。該等高級行政人員在訂立任何重大交易前須先獲得董事會批准，而董事會亦全力支持彼等執行職務。

THE BOARD

Responsibilities

The Board is responsible for the leadership and control of the Company and oversees the Group's business, strategic decisions and performances and is collectively responsible for promoting the success of the Company by directing and supervising its affairs. In practice, the Board takes responsibility for decision making in all major matters of the Company including: the approval and monitoring of all policy matters, the setting of objectives, annual budgets and overall strategies, material transaction, appointment of directors and other significant financial and operational matters. The Board is also responsible for performing overall corporate governance duties, including formulating and reviewing the Company's corporate governance policy and practice, reviewing and monitoring the training and continuous professional development of directors and senior management, reviewing and monitoring the Company's policies and practices on compliance with legal and regulatory requirements, formulating, reviewing and monitoring the code of conduct applicable to directors, and reviewing the Company's compliance with the CG Code. During the year, the Board has performed all of the above functions. The day-to-day management, administration and operation of the Company are delegated to the senior executives. These responsibilities include the implementation of decisions of the Board, the co-ordination and direction of day-to-day operation and management of the Company in accordance with the management strategies and plans approved by the Board. Approval has to be obtained from the Board prior to any significant transactions entered into by these senior executives and the Board has the full support of them to discharge its responsibilities.

組成

於二零二四年十二月三十一日，董事會由六名董事組成，包括三名執行董事，分別為向先生（主席）、陳女士（副主席，擔任上市規則附錄C1所述行政總裁之角色）及李玉嫦女士，以及三名獨立非執行董事，分別為洪祖星先生、何偉志先生及戴國良先生。

其中一名獨立非執行董事具備適當專業資格，或會計或相關財務管理專業知識。獨立非執行董事佔董事會人數超過三分之一。董事之履歷詳情載於第24頁至第28頁之「董事及高級管理人員履歷」一節內。

董事會認為，董事會包括三名獨立非執行董事，此可讓執行與非執行董事間取得合理之制衡。董事會認為，此制衡能為保障股東及本集團利益提供充份之核查及平衡。獨立非執行董事向本集團提供廣泛專業知識及經驗，從而可作出獨立判斷及確保已考慮全體股東之利益。彼等亦負責出席董事會會議、處理潛在利益衝突、出任審核委員會、薪酬委員會及提名委員會成員，以及監察本集團之表現及呈報。彼等之積極參與，為董事會及彼等所任職之委員會提供寶貴技能、專業知識及經驗，從而審慎檢討及監控管理程序。

Composition

As at 31st December 2024, the Board comprises six Directors: including three executive Directors, namely, Mr. Heung (Chairman), Ms. Chen (Vice Chairman, performing the role of chief executive as stated in Appendix C1 of the Listing Rules) and Ms. Li Yuk Sheung and three independent non-executive Directors, namely, Mr. Hung Cho Sing, Mr. Ho Wai Chi, Paul and Mr. Tai Kwok Leung, Alexander.

One of the independent non-executive Directors has appropriate professional qualifications, or accounting or related financial management expertise. The number of independent non-executive Directors is more than one-third of the Board. Biographical details of the Directors are set out in the section "Biographical Details of Directors and Senior Management" on pages 24 to 28.

The presence of three independent non-executive Directors is considered by the Board to be a reasonable balance between executive and non-executive Directors. The Board is of the opinion that such balance can provide adequate checks and balances for safeguarding the interests of shareholders and of the Group. The independent non-executive Directors provide to the Group with a wide range of expertise and experience so that independent judgement can effectively be exercised as well as ensuring that the interests of all shareholders are taken into account. They are also responsible for participating in Board meetings, dealing with potential conflicts of interest, serving on audit committee, remuneration committee and nomination committee, scrutinising the Group's performance and reporting. Through their active participation, they provide their valuable skills, expertise and experience to the Board and the committees on which they serve so that the management process can be critically reviewed and controlled.

董事在本身之專業範圍均為傑出人士，並展示高水平之個人及專業操守和誠信。全體董事均就本公司事務付出充足時間及心血。董事會相信，執行董事對非執行董事之比率誠屬合理，並足以發揮互相監察及制衡之作用，以保障股東及本公司之整體利益。

所有董事（包括非執行董事）均須遵照上市規則及本公司於二零二三年六月二十九日以決議案方式採納的新公司細則（「公司細則」）每三年輪流退任一次，並可膺選連任。董事薪酬乃參照彼等的責任及現行市況而釐定。

董事會（參考提名委員會的建議）整體負責委任新董事及提名董事於本公司股東週年大會上接受股東重選。根據公司細則，董事會可不時委任董事填補臨時空缺或出任董事會新成員。獲此委任之任何新董事須最少每三年於股東週年大會上輪值告退一次及於每屆股東週年大會上退任之董事人選將由董事會決定。

根據公司細則第99(A)條，洪祖星先生將於即將舉行之股東週年大會上告退，惟彼合資格並願意膺選連任。

The Directors have distinguished themselves in their field of expertise, and have exhibited high standards of personal and professional ethics and integrity. All the Directors give sufficient time and attention to the Company's affairs. The Board believes that the ratio of executive to non-executive Directors is reasonable and adequate to provide checks and balances that safeguard the interest of the shareholders and the Company as a whole.

All the directors, including the non-executive directors, will be subject to retirement by rotation and re-election every three years in accordance with the Listing Rules and the new bye-laws of the Company as adopted by a resolution on 29th June 2023 (the "Bye-laws"). The remuneration of the directors are determined with reference to their duties and to the prevailing market conditions.

The Board as a whole is responsible for the appointment of new director and nomination for re-election by shareholders at the annual general meeting of the Company with reference to recommendations from the Nomination Committee. Under the Bye-laws, the Board may from time to time appoint a director either to fill a vacancy or as an addition to the Board. Any new director so appointed shall be subject to retirement by rotation at the annual general meeting at least once every three years and the directors to retire at every annual general meeting shall be decided by the Board.

Pursuant to Bye-law 99(A) of the Bye-laws, Mr. Hung Cho Sing will retire at the forthcoming annual general meeting and, being eligible, will offer himself for re-election.

主席及副主席

向先生(主席)與陳女士(副主席,擔任上市規則附錄C1所述行政總裁之角色)之職責分離,並不由同一人同時兼任,以確保董事會有明確責任分擔,達致權力及權限的平衡。

主席負責領導董事會,確保董事會有效運作,及確保董事會與股東的意見有效溝通。在履行此項職責時,主席的責任包括主持董事會會議;確保董事會會議收到有關本公司事務之準確、完整、及時、可靠且清晰的資料;確保執行董事與非執行董事之間保持有建設性的關係;安排就提呈董事會考慮的問題進行討論及作出決定;確保所有董事均適當聽取董事會會議提出的事項之簡報;作為董事會與管理層之間的聯絡人;與副主席及公司秘書或其代表商議,草擬及批准每次董事會會議的議程,在適當情況下考慮其他董事提議納入議程的任何事項;確保建立良好的企業管治常規和程序承擔主要責任;以及至少每年與獨立非執行董事在執行董事不出席的情況下舉行會議。

副主席主要負責建議政策及策略方向供董事會批准;以及實施董事會採納的策略及政策,及執行本公司之日常營運。

CHAIRMAN AND VICE CHAIRMAN

The roles of Mr. Heung (Chairman) and Ms. Chen (Vice Chairman, performing the role of chief executive as stated in Appendix C1 of the Listing Rules) are separate and not performed by the same individual to ensure that there is a clear division of responsibilities at the board level to entail a balance of power and authority.

The Chairman is responsible for leadership of the Board, for ensuring that the Board functions effectively, and for ensuring effective communication of the views of the Board with the shareholders. In performing this role, the Chairman's responsibilities include chairing meetings of the Board; ensuring the board meetings receive accurate, complete, timely, reliable and clear information concerning affairs of the Company; ensuring constructive relations between executive and non-executive Directors; formulating for discussion and decision, questions which have been moved for the consideration of the Board; ensuring that all Directors are properly briefed on issues arising at board meetings; acting as liaison between the Board and management; in consultation with the Vice Chairman and the company secretary or his/her designated delegates, drawing up and approving the agenda for each board meeting taking into account, where appropriate, any matters proposed by the other Directors for inclusion in the agenda; take primary responsibility for ensuring that good corporate governance practices and procedures established; and at least annually hold meetings with independent non-executive Directors without the presence of the executive Directors.

The Vice Chairman is primarily responsible for recommending policy and strategic directions for Board approval; implementing the strategies and policies adopted by the Board; and conducting the day-to-day operation of the Company.

獨立性

遵照上市規則，本公司全年有三名獨立非執行董事，其中至少一名獨立非執行董事具備適當財務管理專業知識。本集團已接獲各獨立非執行董事之年度獨立性確認書。根據上市規則第3.13條所載指引，本公司認為該等董事均為獨立人士。

所有載有董事姓名之公司通訊中，均已說明全體獨立非執行董事之身份。此外，除本公司主席向先生為副主席陳女士之丈夫外，董事會成員之間並無重大關係。

截至二零二四年十二月三十一日止年度內，每名獨立非執行董事之酬金為240,000港元。

年內，董事會已檢討為確保董事會可獲得獨立的觀點和意見的機制的實施及效能。經考慮以下途徑及機制，董事會認為本公司維持有效的機制確保董事會內有強大的獨立元素：

- (1) 50%董事會成員為獨立非執行董事；
- (2) 董事會主席與所有獨立非執行董事在沒有其他董事出席的情況下舉行的年度會議，提供了有效平台讓董事會主席就本集團各項議題聽取獨立意見；
- (3) 可以應獨立非執行董事的合理要求，向他們提供獨立專業意見以協助彼等履行對本公司的職責；
- (4) 所有獨立非執行董事須提供根據上市規則第3.13條就其身份之獨立性發出之年度書面確認書；及
- (5) 並無向獨立非執行董事授予具有績效相關要素之以股權為基礎之薪酬。

INDEPENDENCE

The Company has three independent non-executive Directors, throughout the year at least one of whom has appropriate financial management expertise, in compliance with the Listing Rules. The Group has received from each independent non-executive Director an annual confirmation of his independence. The Company considers these Directors to be independent under the guidelines set out in Rule 3.13 of the Listing Rules.

All independent non-executive Directors are identified as such in all corporate communications containing the names of the Directors. In addition, there is no material relationship among members of the Board except that Mr. Heung, the Chairman, is the husband of Ms. Chen, the Vice Chairman of the Company.

Each of the independent non-executive Directors has remunerated at HK\$240,000 for the year ended 31st December 2024.

During the year, the Board has reviewed the implementation and effectiveness of mechanisms to ensure independent views and input are available to the Board. Taking into account the following channels and mechanisms, the Board considered that the Company had in place mechanisms which remain effective to ensure a strong independent element within the Board:

- (1) 50% of the Board members are independent non-executive Directors;
- (2) annual meeting between the chairman of the Board and all independent non-executive Directors without presence of other directors provide an effective platform for the chairman of the Board to listen to independent views on various issues concerning the Group;
- (3) independent professional advice would be provided to independent non-executive Directors upon reasonable request to assist them to perform their duties to the Company;
- (4) all independent non-executive directors are required to provide an annual written confirmation of independence pursuant to Rule 3.13 of the Listing Rules; and
- (5) no equity-based remuneration with performance-related elements are granted to independent non-executive Director.

董事會會議及股東大會

董事會定期以親身出席或透過電話或其他電子通訊方式舉行會議，有關會議每年至少舉行四次，以釐定整體策略方向及目標及審批中期及年度業績以及其他重大事項。倘召開董事會例會，則會向全體董事發出最少14日之通知，以讓彼等藉此機會出席及提出事項於議程中討論。除例會外，高級管理層亦不時向董事提供有關本集團業務活動及發展之資料。公司秘書協助主席編製會議議程，並確保有關會議之所有適用規則及規例均獲得遵守及遵從。最終落實之議程及隨附之董事會文件其後將在舉行會議前最少三日發送予全體董事。公司秘書亦會就會議作出詳盡會議記錄，並就會上之討論事項及議決決定保留記錄。

於回顧年度內，已舉行十次董事會會議。董事出席股東大會、董事會及其有關委員會之會議之詳情如下：

BOARD MEETINGS AND SHAREHOLDERS' MEETINGS

The Board regularly meets in person or through telephone or other electronic means of communication at least four times every year to determine overall strategic direction and objectives and approve interim and annual results, and other significant matters. At least 14 days' notice of regular Board meeting are given to all Directors, who are all given an opportunity to attend and include matters in the agenda for discussion. Apart from regular meetings, senior management from time to time provides Directors with information on activities and development of the businesses of the Group. The company secretary assists the Chairman in preparing the agenda for the meeting and ensures that all applicable rules and regulations in connection with the meetings are observed and complied with. The finalized agenda and accompanying board papers are then sent to all Directors at least three days prior to the meeting. The company secretary also takes detailed minutes of the meetings and keeps records of matters discussed and decision resolved at the meetings.

During the year under review, ten board meetings were held. Details of the attendance of the Directors at the general meetings, meetings of the Board and its respective committees are as follows:

於董事會之定期會議中，董事商討及制定本集團之整體策略、監察財務表現及商討年度及中期業績、制定年度預算方案，以及商討及決定其他重要事宜。日常營運事務已委派本集團管理層執行。

公司秘書就各董事會會議之議事程序作詳細之會議記錄，包括記錄董事會所作出之所有決定，以及所提出之關注事宜或表達之反對意見（如有）。會議記錄之初稿須於會議結束後，於切實可行之情況下盡快發送予全體董事，以供評論及審批。任何董事均可在任何合理時間要求查閱所有會議記錄。

由於主席會確保管理層向董事會及其委員會適時提供所有相關資料，故全體董事均可在所有情況下取得相關最新資料。董事於其認為有需要或適當時均可要求提供進一步資料。

彼等亦可取得公司秘書之意見及享用其服務，包括負責向董事提供董事會文件及相關材料，確保遵循所有正確董事會程序，以及遵守一切適用法律及法規。如董事認為有需要及適當時，彼等可聘用獨立專業顧問提供服務，費用由本集團支付。

倘一名主要股東或董事存有利益衝突，有關事項將於董事會會議上進行討論，而不會以書面決議案方式處理。概無利益衝突之獨立非執行董事將會出席會議以處理該等衝突事宜。

董事委員會（包括審核委員會、薪酬委員會及提名委員會）均就所有委員會會議採納董事會會議沿用之適用常規及程序。

During regular meetings of the Board, the Directors discuss and formulate the overall strategies of the Group, monitor financial performances and discuss the annual and interim results, set annual budgets, as well as discuss and decide on other significant matters. The execution of daily operational matters is delegated to management of the Group.

The company secretary records the proceedings of each board meeting in detail by keeping minutes, including the record of all decisions by the Board together with concerns raised and dissenting views expressed (if any). Drafts of board minutes are circulated to all directors for comment and approval as soon as practicable after the meeting. All minutes are open for inspection at any reasonable time on request by any Director.

All Directors have access to relevant and timely information at all times as the Chairman ensures that the management will supply the Board and its committees with all relevant information in a timely manner. They may make further enquiries if in their opinion it is necessary or appropriate to request for further information.

They also have unrestricted access to the advice and services of the company secretary, who is held responsible for providing Directors with board papers and related materials and ensuring that all proper Board procedures are followed and that all applicable laws and regulations are complied with. If considered necessary and appropriate by the Directors, they may retain the service of independent professional advisers at the Group's expense.

In case where a conflict of interest may arise involving a substantial shareholder or a director, such matter will be discussed in a physical meeting and will not be dealt with by way of written resolutions. Independent non-executive Directors with no conflict of interest will be present at meetings dealing with such conflict issues.

The board committees, including the audit committee, the remuneration committee and the nomination committee, have all adopted the applicable practices and procedures used in board meetings for all committee meetings.

本公司之股東週年大會及其他股東大會乃本公司與股東間溝通之主要平台，亦供股東參與。本公司鼓勵全體股東出席股東大會或委派代表代其出席大會並於會上投票（如彼等未能出席大會）。

The annual general meeting and other general meetings of the Company are the primary forum for communication by the Company with the shareholders and for shareholders' participation. All shareholders are encouraged to attend the general meetings or to appoint proxies to attend and vote at meetings on their behalf if they are unable to attend the meetings.

董事之培訓及支援

所有董事（包括獨立非執行董事）必須不時瞭解其作為董事之共同責任，以及本集團之業務。因此，本集團於每名新委任董事獲委任後將向彼等提供全面及正式指導，並向彼等提供及安排簡介會及介紹，以確保彼等熟悉董事會之角色、彼等作為董事之法律及其他責任，以及本集團之業務及管治常規。該等計劃考慮到各個別董事之背景及專業知識而為彼等度身制定。公司秘書將繼續向所有董事提供有關上市規則及其他適用監管規定之最新發展，以確保各董事遵守該等規則及規定。

TRAINING AND SUPPORT FOR DIRECTORS

All Directors, including independent non-executive Directors, must keep abreast of their collective responsibilities as directors and of the business of the Group. As such, the Group provides a comprehensive and formal induction to each newly appointed director upon his/her appointment. Briefings and orientations are provided and organised to ensure that the new Directors are familiar with the role of the Board, their legal and other duties as a director as well as the business and governance practices of the Group. Such programmes are tailored to each individual director taking into account their background and expertise. The company secretary will continuously update all Directors on the latest developments regarding the Listing Rules and other applicable regulatory requirements to ensure compliance of the same by all Directors.

全體董事亦會參與本集團提供或安排之持續專業發展計劃，例如由合資格專業人士舉辦之外界研討會更新有關法律及規例及上市規則資料，以發展及更新有關彼等對董事會作出貢獻之知識及技能。各董事所接受之培訓記錄由本公司之公司秘書留存及更新。

All Directors also participate in continuous professional development programmes provided or procured by the Group, such as external seminars organised by qualified professionals update materials regarding laws and regulation and the Listing Rules, to develop and refresh their knowledge and skills in relation to their contribution to the Board. A record of the training received by the respective Directors are kept and updated by the company secretary of the Company.

REMUNERATION COMMITTEE

A remuneration committee was formed with specific written terms of reference. As at 31st December 2024, the remuneration committee consists of two independent non-executive Directors, namely Mr. Hung Cho Sing and Mr. Tai Kwok Leung, Alexander, and an executive Director, namely, Ms. Chen. Mr. Hung Cho Sing is the chairman of the committee.

薪酬委員會負責制定及向董事會推薦薪酬政策和結構以及所有董事和高級管理人員的薪酬，並就本集團個別執行董事及高級管理人員的薪酬待遇向董事會提供建議。此委員會將就其建議及推薦建議諮詢主席，如認為有需要，亦可索取專業意見。薪酬委員會亦獲提供其他資源以履行其職責。

The remuneration committee is responsible for formulating and recommending to the Board the remuneration policy and structure and remuneration for all directors and senior management, and make recommendations to the Board on the remuneration packages of individual executive Directors and members of senior management of the Group. This committee consults with the Chairman on its proposals and recommendations and has access to professional advice if deemed necessary. The remuneration committee is also provided with other resources enabling it to discharge its duties.

The specific terms of reference of the remuneration committee are posted on the Stock Exchange's website and the Company's website. The remuneration committee meets at least once a year.

Pursuant to a resolution passed at an annual general meeting of the Company held on 29th June 2022, the Company adopted a new share option scheme (the "2022 Option Scheme") to replace the share option scheme adopted on 28th June 2012. Pursuant to a resolution passed at annual general meeting of the Company held on 29th June 2023, the Company adopted amendments to the 2022 Option Scheme (the 2022 Option Scheme and its amendments together the "Amended Option Scheme"). Particulars of the 2022 Option Scheme and the Amended Option Scheme are set out in note 41 to the consolidated financial statements.

提名委員會

提名委員會之職責包括每年最少檢討董事會架構、人數及成員一次，並就任何建議變更向董事會提出推薦建議以補足本公司之企業策略、物色合適及合資格人士出任董事會成員，並挑選個別人士提名出任董事、評估獨立非執行董事之獨立性及就委任或重新委任董事及董事繼任計劃（尤其是主席及副主席）向董事會提出推薦建議。提名委員會亦獲提供足夠資源以履行其職責。如有需要，提名委員會可尋求獨立專業意見以履行其職責，費用由本集團承擔。

Particulars of the Share Awards Scheme are set out in note 41 to the consolidated financial statements.

During the year ended 31st December 2024, 164,000,000 awards (“Awarded Shares”) was lapsed and no granted Awarded Shares were outstanding as at 31st December 2024. No award was granted, vested, forfeited or cancelled pursuant to the Share Award Scheme during the year ended 31st December 2024.

NOMINATION COMMITTEE

A nomination committee was formed with specific written terms of reference. As at 31st December 2024, the nomination committee consists of two independent non-executive Directors, namely Mr. Tai Kwok Leung, Alexander and Mr. Hung Cho Sing, and an executive Director, namely Mr. Heung. Mr. Tai Kwok Leung, Alexander is the chairman of the nomination committee.

The duties of the nomination committee include reviewing the structure, size and composition of the Board at least annually, making recommendations on any proposed changes to the Board to complement the Company’s corporate strategy, identifying individuals suitably qualified to become members of the Board and selecting individuals nominated for directorship, assessing the independence of the independent non-executive Directors and making recommendations to the Board on the appointment or re-appointment of Directors and succession planning for directors, in particular the chairman and the vice chairman. The nomination committee is also provided with sufficient resources to perform its duties. Where necessary, the nomination committee can seek independent professional advice, at the Group’s expense, to perform its responsibilities.

The Company has an Nomination Policy governing nomination practices and procedures. The Nomination Committee considers a variety of factors in assessing the suitability of a proposed candidate, including:

- (1) Reputation for integrity;
- (2) Accomplishment, experience and reputation in the business and industry;
- (3) Commitment in respect of time, interest and attention to the Company's business, including devoting adequate time for preparation and participation in meetings, training and other Board or Company associated activities;
- (4) Diversity in all aspects, including, but not limited to, gender, age, cultural, educational and professional background, skills, knowledge, experience and length of service;
- (5) Ability to assist and support management and make significant contributions to the Company's success;
- (6) Compliance with the criteria of independence as prescribed under Rule 3.13 of the Listing Rules for the appointment of an independent non-executive director; and
- (7) Any other relevant factors as may be determined by the Nomination Committee or the Board from time to time.

In considering the appointment of any proposed candidate to the Board, the Nomination Committee shall undertake adequate due diligence in respect of the individual, evaluate the candidate using the same criteria regardless of the source of the candidacy, and make recommendations for the Board's consideration and approval.

In considering the re-appointment of any existing member(s) of the Board, the Nomination Committee shall review the retiring director's overall contribution to the Company as well as the selection criteria set out in the Nomination Policy. The Nomination Committee will then make recommendations to the Board for its consideration, with the Board determining whether to recommend the proposed candidates for re-election at a general meeting.

於回顧年度內，提名委員會已舉行一次會議以檢討及考慮董事會架構、人數及組成、董事會成員及提名政策、獨立非執行董事的獨立性、重新委任退任董事、提名委員會現有的職權範圍並檢討董事會成員多元化政策。

董事會成員多元化

董事會於二零一三年採納了董事會成員多元化政策（「政策」），並根據董事會於二零一九年三月二十六日通過的決議進行了修訂。其主要條款載列如下。

1. 目的

本政策旨在列載董事會為達致成員多元化而採取的方針。

2. 願景

本公司明白並深信董事會成員多元化對提升其表現素質有利。

3. 政策聲明

為實現可持續和均衡的發展，本公司認為董事會層面的日益多元化是實現其戰略目標和可持續發展的關鍵因素。在實現董事會成員的多元化方面，將考慮每位董事候選人的若干方面，包括但不限於性別、年齡、文化和教育背景、種族、專業經驗、技能、知識和服務任期。所有董事會成員委任均以用人唯才為原則，候選人將根據本政策中規定的客觀標準進行考慮，同時適當考慮董事會成員多元化的裨益。

4. 可衡量的目標

選擇董事會成員候選人將基於一系列不同角度，包括但不限於：性別、年齡、文化和教育背景、種族、專業技能和知識，以及工作經驗。董事會將根據候選人可能帶給董事會的優點和貢獻作出最終決定。

The specific terms of reference of the nomination committee are posted on the Stock Exchange's website and the Company's website. The nomination committee meets at least once a year.

During the year under review, the nomination committee held one meeting to review and consider the structure, size and composition of the Board and the Nomination Policy, the independence of the independent non-executive Directors, the re-appointment of retiring Directors, the existing terms of reference of the nomination committee and to review the Board Diversity Policy.

BOARD DIVERSITY

The Board adopted a Board Diversity Policy (the "Policy") in 2013 and amended pursuant to the resolution of the Board passed on 26th March 2019. The key terms of the Policy are set out as follows.

1. Purpose

This Policy aims to set out the approach to achieve diversity in the Board.

2. Vision

The Company recognises and embraces the benefits of having a diversified Board to enhance the quality of its performance.

3. Policy Statement

With a view to achieving a sustainable and balanced development, the Company sees an increase in diversity at the Board level to be an essential element in the attainment of its strategic objectives and sustainable development. In achieving diversity of the Board, a number of aspects of each director candidate will be considered, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All Board appointments will be based on meritocracy, and the candidates will be considered based on the objective criteria set out in this Policy having due regard for the benefits of diversity on the Board.

4. Measurable Objectives

Selection of candidates will be based on a range of diversity perspectives, including but not limited to the candidate's gender, age, cultural and educational background, ethnicity, professional skills and knowledge, and working experience. The ultimate decision will be made by the Board based on the merit and contribution which the candidates may be able to bring to the Board.

5. 監察及匯報

提名委員會將每年在企業管治報告內彙報董事會在多元化層面的組成，並監察本政策的執行。

6. 檢討本政策

提名委員會將每年檢討本政策，以確保其實施及有效性。提名委員會將會討論任何可能作出的修訂，並向董事會提出修訂建議以供董事會審批。

關於性別多元化，董事會認為董事會中有兩名女性代表就已足夠。本公司的提名政策可確保董事會的潛在繼任者不斷湧現，從而延續董事會內的性別多元化。年內，董事會已檢討董事會成員多元化政策的實施情況及成效。

董事會認為董事會目前的結構，規模和組成適合使其能夠對管理實踐執行平衡且獨立的監督職能，以補充公司的企業戰略，及由於董事會由不同背景的董事組成，因此董事會已實現多元化。

5. Monitoring and Reporting

The Nomination Committee will report annually on the Board's composition under the diversified perspectives in the Corporate Governance Report, and monitor the implementation of this Policy.

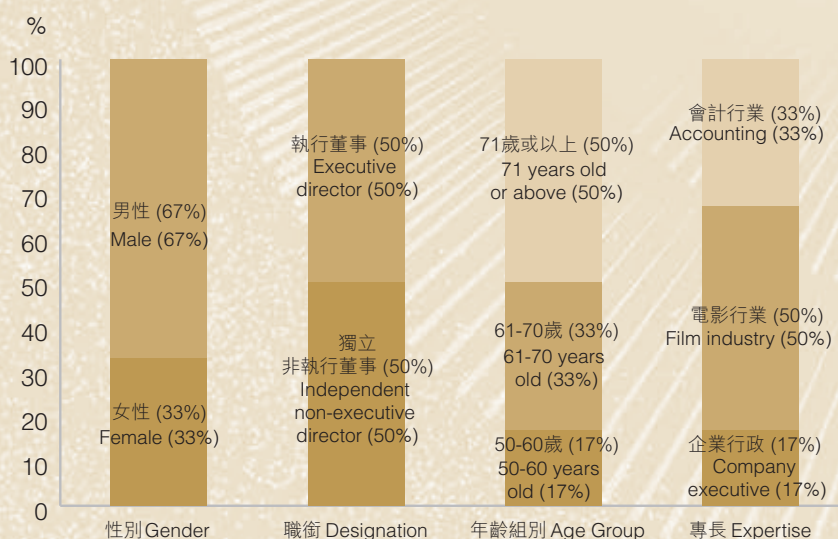
6. Review of this Policy

The Nomination Committee will review this Policy, on an annual basis, to ensure its implementation and effectiveness. The Nomination Committee will discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval.

Regarding gender diversity, the Board is of the view that two female representatives on the Board are sufficient. The nomination policy of the Company can ensure that there will be a pipeline of potential successors to the Board which continues the gender diversity within the Board. During the year, the Board has reviewed the implementation and effectiveness of the Board Diversity Policy.

The Board considered that the current structure, size and composition of the Board to be appropriate in enabling it to perform a balanced and independent monitoring function on management practices to complement the Company's corporate strategy and diversity within the Board has been achieved as the Board is composed of director from a diverse range of background.

審核委員會

本公司已遵照上市規則成立審核委員會，並以書面訂明其職權範圍。上市規則第3.21條規定審核委員會必須由至少三名非執行董事組成，而至少一名成員須為獨立非執行董事及必須具備適當專業資格或會計或相關財務管理專業知識。審核委員會之主要職責包括以下各項：

- (a) 於財務報表及報告提交董事會前進行審閱，並考慮外聘核數師提出之任何重大或不尋常項目。
- (b) 根據核數師進行之工作、其費用及聘用條款檢討與外聘核數師之關係，並就委聘、續聘及罷免外聘核數師向董事會提出建議。
- (c) 檢討本公司之財務申報制度、內部監控系統及風險管理系統以及有關程序是否足夠及有效。

審核委員會之其他職責載於聯交所網站及本公司網站刊載之具體成文職權範圍內。審核委員會已獲提供充足資源，讓彼等履行其職責。

於二零二四年十二月三十一日，審核委員會有三名成員，分別為何偉志先生（審核委員會主席）、洪祖星先生及戴國良先生，均為獨立非執行董事。概無審核委員會成員在其終止成為合夥人或享有核數公司財務利益之日期起計兩年內，為本公司之現有核數公司之前任合夥人。審核委員會已審閱本集團所採納之會計原則及慣例，並與本公司管理團隊討論內部監控及財務申報事宜。年內，審核委員會已舉行三次會議以考慮及審閱本集團之年度報告及中期報告。

AUDIT COMMITTEE

The Company established an audit committee with written terms of reference in compliance with the Listing Rules. Rule 3.21 of the Listing Rules requires that the audit committee must comprise a minimum of three non-executive directors, at least one of them should be independent non-executive directors with appropriate professional qualifications or accounting or related financial management expertise. The main duties of the audit committee include the followings:

- (a) To review the financial statements and reports and consider any significant or unusual items raised by the external auditor before submission to the Board.
- (b) To review the relationship with the external auditor by reference to the work performed by the auditor, their fees and terms of engagement, and make recommendation to the Board on the appointment, re-appointment and removal of external auditor.
- (c) To review the adequacy and effectiveness of the Company's financial reporting system, internal control system and risk management system and associated procedures.

Other duties of the audit committee are set out in its specific terms of reference which are posted on the Stock Exchange's website and the Company's website. The audit committee is provided with sufficient resources enabling it to discharge its duties.

As at 31st December 2024, the audit committee has three members, namely Mr. Ho Wai Chi, Paul (chairman of the audit committee), Mr. Hung Cho Sing and Mr. Tai Kwok Leung, Alexander, all being independent non-executive Directors. No member of the audit committee is a former partner of the existing auditing firm of the Company within two years on the date of his ceasing to be a partner or had any financial interest in the auditing firm. The audit committee has reviewed the accounting principles and practices adopted by the Group and discussed internal controls and financial reporting matters with the management team of the Company. During the year, the audit committee held three meetings to consider and review the Group's annual report and interim report.

本集團的外聘核數師為國衛會計師事務所有限公司。國衛會計師事務所有限公司已向審核委員會發出函件，確認該事務所對本公司而言為獨立，並且國衛會計師事務所有限公司與本公司之間不存在任何有可能被合理認為可影響其獨立性的關係。為維持外聘核數師的獨立性，該工作只在不會影響其獨立性並經由審核委員會預先批准的情況下，本公司才會聘用外聘核數師從事非審核工作。年內，外聘核數師向本集團提供了審核和非審核服務。審核服務包括與審核本集團的綜合財務報表有關的審核服務。非審核服務包括刊發特別審核報告或中期審閱或其他監管目的之服務。

本公司截至二零二四年十二月三十一日止年度之年報已由審核委員會審閱。本年度之財務報表已經由國衛會計師事務所有限公司審核，其任期將於即將舉行之股東週年大會上屆滿。審核委員會已向董事會建議，於本公司應屆股東週年大會上提名委任國衛會計師事務所有限公司為本公司之核數師。

截至二零二四年十二月三十一日止年度，核數師國衛會計師事務所有限公司提供之核數服務及非核數服務之已付及應付費用分別為950,000港元及150,000港元。

The audit committee has also reviewed the financial reporting and compliance procedures, report on the company's internal control and risk management review and processes as well as the re-appointment of the external auditor. There is no material uncertainty relating to events and conditions that may cast significant doubt on the Company's ability to continue as a going concern. There is no disagreement between the Board and the audit committee regarding the selection, appointment, resignation or dismissal of external auditor.

The Group's external auditors is HLB Hodgson Impey Cheng Limited. HLB Hodgson Impey Cheng Limited has written to the Audit Committee confirming that they are independent with respect to the Company and that there is no relationship between HLB Hodgson Impey Cheng Limited and the Company which may reasonably be thought to bear on their independence. In order to maintain the external auditors' independence, it would only be employed for non-audit work if the work does not compromise the external auditors' independence and has been pre-approved by the Audit Committee. During the year, the external auditors provided audit services and non-audit services to the Group. Audit services include services provided in connection with the audit of the Group's consolidated financial statements. Non-audit services include services such as issuance of special audit reports or interim review or other regulatory purposes.

The Company's annual report for the year ended 31st December 2024 has been reviewed by the audit committee. The financial statements for the year were audited by HLB Hodgson Impey Cheng Limited whose term of office will expire upon the forthcoming annual general meeting. The audit committee has recommended to the Board that HLB Hodgson Impey Cheng Limited be nominated for appointment as the auditor of the Company at the forthcoming annual general meeting.

For the year ended 31st December 2024, the fees paid and payable in respect of audit services and non-audit services provided by the auditors, HLB Hodgson Impey Cheng Limited, amounted to HK\$950,000 and HK\$150,000 respectively.

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the “Model Code”) as set out in Appendix C3 of the Listing Rules for securities transactions by directors of the Company on terms no less exacting than the required standard set out in the Model Code. The Model Code is extended to relevant employees (including any employee or a director or employee of a subsidiary or holding company who, because of his office or employment, is likely to possess inside information in relation to the Company or its securities) in respect of their dealings in the Company’s securities. All the members of the Board have confirmed, following specific enquiry of all of them by the Company, that they have complied with the required standard as set out in the Model Code and its code of conduct regarding directors securities transactions throughout the year ended 31st December 2024. The Model Code also applies to other specified senior management of the Group.

Ms. Wong Shuk Han, Dorothy has been appointed as the company secretary of the Company with effect from December 2001 and Ms. Wong has complied with the professional training requirement of the Listing Rules during the year.

The Group has established a whistleblowing policy for employees and those who deal with the Group to raise concerns, in confidence and anonymity, with the Audit Committee about possible improprieties in any matter and an anti-corruption policy for achieving the highest standards of business conduct with zero tolerance for corruption and related malpractice.

The Group has overseen its risk management and internal control system on an ongoing basis and conducted at least annually.

The Group has conducted a review of the implemented system and procedures, including areas covering financial, operational, compliance controls and risk management functions during the year under review. The systems are implemented to minimise the risk to which the Group is exposed and is used as a management tool for the day-to-day operation of business. The system can only provide reasonable but not absolute assurance against misstatement or losses.

The Group does not have an internal audit function as the Board has reviewed the effectiveness of the internal control system of the Company and is currently of the view that there is no immediate need to set up an internal audit function within the Group in light of the size, nature and complexity of the Group's business. The situation will be reviewed from time to time.

The Group had engaged Insightnetic Consultancy Limited, external professional consultant, to conduct risk management and independent internal control review for the year ended 31st December 2024 and the review is completed as at the date of this annual report.

For the year ended 31st December 2024, the Board considered the Group's risk management and internal control system as adequate and effective and that the Company has complied with the code provisions on risk management and internal control of the CG Code.

DELEGATION BY THE BOARD

The Board is responsible for decisions in relation to the overall strategic development of the Group's business. All Directors have formal letters of appointment setting out key terms and conditions relative to their appointment. Due to the diversity and volume of the Group's business, responsibility in relation to the daily operations and execution of the strategic business plans are delegated to management of the Group.

All committees, namely the audit committee, the remuneration committee and the nomination committee, have specific terms of reference clearly defining the authorities and responsibilities of the respective committees. All committees are required by their terms of reference to report to the Board in relation to their decisions, findings or recommendations, and in certain specific situations, to seek the Board's approval before taking any actions.

At the Company's 2024 annual general meeting, all the resolutions were put to the vote by poll and Tricor Investor Services Limited, the Company's Hong Kong Branch Share Registrar and Transfer Office, was engaged as scrutineer to ensure the votes were properly counted. The rights of shareholders and the procedures for demanding a poll on resolutions at shareholders' meeting are contained in the Bye-laws.

- (b) The contributed surplus of the Group brought forward represents the amount transferred from the capital account due to the capital reduction effective on 10th September 2002 and various capital reduction subsequently.

Under the Company Act 1981 of Bermuda (as amended), the contributed surplus is available for distribution or apply the amount standing to the credit of the contributed surplus account in such manner as the board of directors considers appropriate, including but not limited to setting off against any accumulated losses of the Company. However, the Company cannot declare or pay a dividend, or make a distribution out of the contributed surplus if: (i) it is, or would after the payment be, unable to pay its liabilities as they become due; or (ii) the realisable value of its assets would thereby be less than its liabilities and its issued share capital and share premium accounts.

- (c) Exchange reserve represents exchange differences relating to the translation of the net assets of the Group's foreign operations from their functional currencies to the Group's presentation currency (i.e. Hong Kong dollar ("HK\$")) and are recognised directly in other comprehensive income and accumulated in the exchange reserve. Such exchange differences accumulated in the exchange reserve are reclassified to profit or loss on the disposal of the foreign operations.

- (d) Pursuant to an ordinary resolution passed at the special general meeting of the Company held on 25th October 2012 in relation to the bonus issue of shares (with a right for shareholders to elect to receive bonus convertible bonds ("Bonus CBs") in lieu of bonus shares), Bonus CBs can be converted into ordinary shares at initial conversion price of HK\$0.01 per share issued by the Company. The Bonus CBs are recognised as equity and are presented in "bonus convertible bonds reserve". The Bonus CBs are unlisted and irredeemable but have conversion rights entitling the bondholders to convert into an equivalent number of shares as the number of bonus shares which the bondholders (the "Bonus CBs holders") would otherwise be entitled to receive under the bonus issue had the shareholder not elected for the Bonus CBs. The Bonus CBs do not carry voting rights at any general meeting of shareholders of the Company. The Bonus CBs holders can exercise the conversion rights at any time after the issue of Bonus CBs, subject to the terms and conditions of the applicable deed poll constituting the Bonus CBs. At 31st December 2024, there are approximately HK\$265,000 (2023: HK\$265,000) outstanding Bonus CBs which are convertible into 1,060,317 (2023: 1,060,317) fully paid ordinary shares of HK\$0.01 each at conversion price of HK\$0.25 per share.

1. 一般事項

中國星集團有限公司(「本公司」)乃於百慕達註冊成立之受豁免有限公司，其股份在香港聯合交易所有限公司(「聯交所」)上市。本公司之註冊辦事處及主要營業地點之地址分別為Victoria Place, 5th Floor, 31 Victoria Street, Hamilton HM10, Bermuda及香港干諾道中168-200號信德中心西翼34樓09室。

其直接及最終控股公司為Heung Wah Keung Family Endowment Limited，由向華強先生(「向先生」)及向先生之配偶陳明英女士(「陳女士」)等份擁有。

本綜合財務報表以港元列值，其亦為本公司之功能貨幣。除另有說明者外，所有價值均計算至最近之千位數(千港元)。

本集團之主要業務為投資、製作、發行以及授權電影及電視連續劇、提供藝人管理服務、物業開發及投資、大廈管理服務及多頻道網絡電子商務平台的開發、推廣及經營以及開發及銷售自家品牌產品。

1. GENERAL

China Star Entertainment Limited (the “Company”) is incorporated in Bermuda as an exempted company with limited liability and its shares are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). The addresses of the registered office and principal place of business of the Company are Victoria Place, 5th Floor, 31 Victoria Street, Hamilton HM10, Bermuda and Unit 3409, Shun Tak Centre, West Tower, 168-200 Connaught Road Central, Hong Kong respectively.

Its immediate and ultimate holding company is Heung Wah Keung Family Endowment Limited which is equally owned by Mr. Heung Wah Keung (“Mr. Heung”) and Ms. Chen Ming Yin, Tiffany (“Ms. Chen”), spouse of Mr. Heung.

The consolidated financial statements are presented in HK\$, which is also the functional currency of the Company and all values are rounded to the nearest thousand (HK\$'000) except otherwise indicated.

The principal activities of the Group are investment, production, distribution and licensing of films and television drama series, provision of artist management services, properties development and investment, building management services and development, promotion and operation in multi-channel network e-commerce platform and development and sales of private label products.

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. For the purpose of presentation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”) and by the disclosure requirements of the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for investment property and certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 *Share-based Payment*, leasing transactions that are accounted for in accordance with HKFRS 16 *Leases*, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 *Inventories* or value in use in HKAS 36 *Impairment of Assets*.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For financial instruments and investment property which are transacted at fair value and a valuation technique that unobservable inputs are to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

- Level 3 inputs are unobservable inputs for the asset or liability.

(b) Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

倘本集團於投資對象之投票權未能佔大多數，則當投票權足以賦予本公司實際能力以單方面指揮投資對象之相關活動時即可對投資對象行使權力。本集團於評估本集團於投資對象之投票權是否足以賦予其權力時考慮所有相關事實及情況，包括：

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

When the Group has less than a majority of the voting rights of an investee, it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The Group considers all relevant facts and circumstances in assessing whether or not the Group's voting rights in an investee are sufficient to give it power, including:

- the size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- potential voting rights held by the Group, other vote holders or other parties;
- rights arising from other contractual arrangements; and
- any additional facts and circumstances that indicate that the Group has, or does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated income statement from the date the Group gains control until the date when the Group ceases to control the subsidiary.

必要時，會就附屬公司之財務報表作調整以使其會計政策與本集團之會計政策一致。

有關本集團成員之間交易之所有集團內公司間之資產及負債、權益、收入、支出及現金流量於綜合時悉數對銷。

於附屬公司之非控股權益乃與本集團內的權益分開呈列，代表清盤時授權其持有人可按比例分佔相關附屬公司資產淨值之現有所有權權益。

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Changes in the Group's interests in existing subsidiaries

Changes in the Group's interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the non-controlling interests' proportionate interests.

Any difference between the amount by which the non-controlling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

業務為一整套活動及資產，包括投入及實質性過程，而兩者結合對創造產出的能力有重大貢獻。所收購過程會被視為實質性，條件是其對持續產出的能力至關重要，此包括具備執行相關過程所必需的技能、知識或經驗的有組織勞動力，或對持續產出的能力有重大貢獻，並被認為屬獨特或稀缺，或在無重大成本、努力或持續產出能力出現延遲的情況下不可取代。

A business is an integrated set of activities and assets which includes an input and a substantive process that together significantly contribute to the ability to create outputs. The acquired processes are considered substantive if they are critical to the ability to continue producing outputs, including an organised workforce with the necessary skills, knowledge, or experience to perform the related processes or they significantly contribute to the ability to continue producing outputs and are considered unique or scarce or cannot be replaced without significant cost, effort, or delay in the ability to continue producing outputs.

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

The identifiable assets acquired and liabilities assumed must meet the definitions of an asset and a liability in the *Conceptual Framework for Financial Reporting* (the “Conceptual Framework”) except for transactions and events within the scope of HKAS 37 *Provisions, Contingent Liabilities and Contingent Assets* or HK(IFRIC)-Int 21 *Levies*, in which the Group applies HKAS 37 or HK(IFRIC)-Int 21 instead of the Conceptual Framework to identify the liabilities it has assumed in a business combination. Contingent assets are not recognised.

商譽乃假設於收購日按所轉讓代價、於被收購方任何非控股權益金額以及購買方先前於被收購方持有股權權益之公平價值(如有)之總和，超過所收購之可識別資產及所承擔負債之淨額計量。如在重新評估後，所收購之可識別資產及所承擔負債之淨額超過其轉讓價、於被收購方的任何非控股權益金額以及購買方先前於被收購方持有權益之公平價值(如有)之總和，該超出之差額即時於損益確認為議價購買溢利。

非控股權益如屬現所有權權益並賦權其持有人於清盤時按比例分佔相關附屬公司淨資產，乃按非控股權益按比例分佔被收購方可識別淨資產之已確認金額，或按公平價值初步計量。計量基準之選擇按個別交易基準決定。

(d) 商譽

收購業務而產生之商譽乃按於收購業務當日之成本減累計減值虧損(如有)列賬。

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net amount of the identifiable assets acquired and the liabilities assumed at acquisition date. If, after re-assessment, the net amount of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the relevant subsidiary's net assets in the event of liquidation are initially measured at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets or at fair value. The choice of measurement basis is made on a transaction-by-transaction basis.

(d) Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units (the "CGU") (or group of CGUs) that is expected to benefit from the synergies of the combination, which represent the lowest level at which the goodwill is monitored for internal management purposes and not larger than an operating segment.

獲分配商譽之現金產生單位 (或現金產生單位組合) 會每年或於有跡象顯示該單位可能出現減值時進行更頻繁的減值測試。就報告期內收購所產生之商譽，獲分配商譽之現金產生單位 (或現金產生單位組合) 會於報告期末前進行減值測試。倘可收回金額低於其賬面值，則減值虧損會先用作減低任何分配至商譽之賬面值，其後則按該單位 (或現金產生單位組合) 內各項資產賬面值之比例分配至其他資產。

出售相關現金產生單位或現金產生單位組合內任何現金產生單位時，商譽之應佔金額於釐定出售之損益金額時加入計算。本集團出售現金產生單位 (或現金產生單位組合內某現金產生單位) 內一項經營業務時，所出售商譽金額乃按所出售經營業務 (或現金產生單位) 之相對價值及所保留現金產生單位 (或現金產生單位組合) 之份額計量，除非本集團能證明有其他方法能較好地反映與所出售經營業務相關之商譽。

A CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment annually or more frequently when there is indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit (or group of CGUs).

On disposal of the relevant CGU or any of the CGU within the group of CGUs, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal. When the Group disposes of an operation within the CGU (or a CGU within a group of CGUs), the amount of goodwill disposed of is measured on the basis of the relative values of the operation (or the CGU) disposed of and the portion of the CGU (or the group of CGUs) retained, unless the Group can demonstrate that some other method better reflects the goodwill associated with the operation disposed of.

(e) Interest in a joint venture

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

合資企業之業績及資產與負債以權益法納入該等財務報表。權益會計法所用合資企業之財務報表乃按與本集團處理類似情況中相類交易及事件一致的會計政策編製。根據權益法，於合資企業之投資初步按成本於綜合財務狀況表確認，並於其後就確認本集團應佔該合資企業之損益及其他全面收入而作出調整。合資企業之資產淨值變動除損益及其他全面收入外不會入賬，除非該等變動導致本集團所持所有權權益有變。當本集團應佔一間合資企業之虧損超出本集團於該合資企業之權益時（包括實質上成為本集團於該合資企業的淨投資一部份之任何長期權益），本集團停止確認其所佔進一步虧損。僅於本集團已產生法律或推定責任，或已代表該合資企業支付款項之情況下，方會進一步確認虧損。

The results and assets and liabilities of joint venture are incorporated in these financial statements using the equity method of accounting. The financial statements of joint venture used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in a joint venture is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the joint venture. Changes in net assets of the joint venture other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of a joint venture exceeds the Group's interest in that joint venture (which includes any long-term interests that, in substance, form part of the Group's net investment in the joint venture), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the joint venture.

An investment in a joint venture is accounted for using the equity method from the date on which the investee becomes a joint venture. On acquisition of the investment in a joint venture, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

本集團會評估是否有客觀證據證明於合資企業之權益有所減損。倘存在客觀證據，該項投資之全部賬面值(包括商譽)會根據香港會計準則第36號以單一資產形式進行減值測試，方法是比較其可收回金額(即使用價值與公平價值減出售成本兩者中之較高者)與其賬面值。任何已確認減值虧損構成該項投資之賬面值其中一部分，有關減值虧損之任何撥回乃根據香港會計準則第36號確認，惟以於該項投資之可收回金額其後增加之情況為限。

The Group assesses whether there is an objective evidence that the interest in a joint venture may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When the Group ceases to have joint control over a joint venture, it is accounted for as a disposal of the entire interest in the investee with a resulting gain or loss being recognised in profit or loss. When the Group retains an interest in the former joint venture and the retained interest is a financial asset within the scope of HKFRS 9, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition. The difference between the carrying amount of the joint venture and the fair value of any retained interest and any proceeds from disposing of the relevant interest in the joint venture is included in the determination of the gain or loss on disposal of the joint venture. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that joint venture on the same basis as would be required if that joint venture had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that joint venture would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal/partial disposal of the relevant joint venture.

When a group entity transacts with a joint venture of the Group, profits and losses resulting from the transactions with the joint venture are recognised in the Group's consolidated financial statements only to the extent of interests in the joint venture that are not related to the Group.

(f) Revenue recognition

Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Revenue from retail sales

Revenue from retail sales is recognised at a point of sale to customers or when a group entity has delivered products to the customer and collectability of the related receivables is reasonably assured.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

(j) Employee benefits

Annual leave

Employee entitlement to annual leave is recognised when it accrues to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees during the year. Employee entitlements to maternity leave and sick leave are not recognised until the time of leave.

退休福利責任

向強制性公積金計劃（「強積金計劃」）及退休金計劃供款乃於僱員已提供服務並可享有供款時確認為開支。

Bonuses

The Group recognises a liability for bonuses when there is a contractual obligation and the amount can be estimated reliably.

Retirement benefit obligations

Payments to the Mandatory Provident Fund Scheme (the "MPF Scheme") and pension fund schemes are recognised as an expense when employees have rendered service entitling them to the contributions.

The Group operates the MPF Scheme under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution scheme, the assets of which are held in separate trustee-administered funds.

Under the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at 5% of the employees' relevant income, with the employers' contributions subject to a cap of monthly relevant income of HK\$30,000. The Group's contributions to the MPF Scheme are expensed as incurred. The Group has no further payment obligations once the contributions have been paid. There are no forfeited contributions for the MPF Scheme as the contributions are fully vested to the employees upon payment to the MPF Scheme.

本集團為其澳門僱員設立定額供款退休計劃，其資產由獨立信託管理基金持有。僱主及僱員均須按僱員基本薪金之5%向計劃作出供款，供款以每月2,000澳門幣為上限。本集團之計劃供款於產生時支銷。支付供款後本集團再無其他付款責任。倘僱員於有權享有僱主供款之前退出計劃，被沒收供款將用作扣減本集團之應付供款。僱員於完成任職三年後合資格可享有僱主之計劃供款的30%。歸屬利益比率按每年10%遞增，而完成任職十年後比率達100%。

The Group operates defined contribution retirement schemes for its employees in Macau, the assets of which are held in separate trustee-administered funds. The employers and their employees are each required to make contributions to the schemes at 5% of the employees' basic salary subject to a cap of monthly contribution of MOP2,000 each. The Group's contributions to the schemes are expensed as incurred. The Group has no further payment obligations once the contributions have been paid. Where employees leave the schemes prior to the full vesting of the employers' contributions, the amount of forfeited contributions is used to reduce the contributions payable by the Group. Employees are eligible for 30% of the employer's contribution to schemes after completion of three years of service. The rate of vested benefit increases at an annual increment of 10% thereafter reaching 100% after completion of ten years of service.

In accordance with the rules and regulations in the PRC, the PRC based employees of the Group participate in various defined contribution retirement benefit plans organised by the relevant municipal and provincial governments in the PRC under which the Group and the PRC based employees are required to make monthly contributions to these plans calculated as a percentage of the employees' salaries. The municipal and provincial governments undertake to assume the retirement benefit obligations of all existing and future retired PRC based employees' payable under the plans described above. Other than the monthly contributions, the Group has no further obligation for the payment of retirement and other post-retirement benefits of its employees. The assets of these plans are held separately from those of the Group in independently administrated funds managed by the PRC government. The Group's contributions to the defined contribution retirement schemes are expensed as incurred.

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date.

The fair value of the equity-settled share-based payments determined at the grant date without taking into consideration all non-market vesting conditions is expensed on a straight-line basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity under the heading of share-based payment reserve. At the end of each reporting period, the Group revises its estimate of the number of equity instruments expected to vest based on assessment of all relevant non-market vesting conditions. The impact of the revision of the original estimates, if any, is recognised in the profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to the share-based payment reserve.

When share options are exercised, the amount previously recognised in share-based payment reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share-based payment reserve will be transferred to retained earnings/accumulated losses.

Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'loss before tax' as reported in the consolidated income statement because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale, except for freehold land, which is always presumed to be recovered entirely through sale.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to the lease liabilities separately. Property, plant and equipment are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after the property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the profit or loss in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of the property, plant and equipment, the expenditure is capitalised as an additional cost of that asset.

To the extent the allocation of the relevant payments can be made reliably, interests in leasehold land is presented as right-of-use assets under line item of property, plant and equipment in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at fair value, adjusted to exclude any prepaid or accrued operating lease income.

Gains or losses arising from changes in the fair value of investment properties are included in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposal. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

Film rights represent films and television drama series produced by the Group or acquired by the Group. Film rights are stated at cost less accumulated amortisation and accumulated impairment losses. The Group begins amortisation of the capitalised costs of film rights when a film is released and it begins to recognise revenue from that film.

The Group reviews and revises estimates of total projected revenue and total production costs of film rights at the end of each reporting period. If estimates are revised, the Group adjusts the amount of total projected revenue from the period when such changes in estimates take place and re-calculated the ratio for amortisation of film rights. The effect from changes in estimates is recognised on a prospective basis.

Amortisation expense is charged to profit or loss based on the proportion of actual income earned during the year to the total estimated income from the sale of film rights. The amortisation of film rights will not exceed twenty years. In the case where there is any impairment in value, the carrying amount is written down to its estimated recoverable amount.

At the end of each reporting period, both internal and external market information are considered to assess whether there is any indication that film rights are impaired. If any such indication exists, the carrying amounts of such assets are assessed and where relevant, an impairment loss is recognised to reduce the asset to its estimated recoverable amount. Such impairment losses are recognised in profit or loss.

Films in progress is transferred to film rights when the film is released.

At the end of each reporting period, both internal and external market information are considered to assess whether there is any indication that films in progress are impaired. If any such indication exists, the carrying amounts of such assets are assessed and where relevant, an impairment loss is recognised to reduce the asset to its recoverable amount. Such impairment losses are recognised in the profit or loss.

(p) Investment in films

Investment in films projects which entitles the Group to receive a fixed and/or variable income based on the Group's investment amount and expected rate of return as specified in the respective film investment agreements. The investments are carried at amortised cost if their cash flows represent solely payments of principal and interest. All other investments that are not solely payments of principal and interest are carried at fair value.

The Group performs impairment assessment under expected credit loss (“ECL”) model on financial assets (including loan to a director, trade receivables, deposits and other receivables, amount due from a joint venture, amount due from non-controlling interest, time deposits and bank balances). The amount of ECL is updated at each reporting period to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL (“12m ECL”) represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting period. Assessments are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting period as well as the forecast of future conditions.

The Group applies simplified approach to recognise lifetime ECL for trade receivables. The ECL on these trade receivables are assessed individually for debtors with significant balances.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Where the Group is jointly and severally liable for an obligation, the part of the obligation that is expected to be met by other parties is treated as a contingent liability and it is not recognised in the consolidated financial statements.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgements in applying accounting policies

The followings are the critical judgements, apart from those involving estimations, that the directors of the Company have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

Deferred taxation on investment property

For the purposes of measuring deferred tax arising from investment property that are measured using the fair value model, the directors of the Company have reviewed the Group's investment property portfolios and concluded that the Group's investment property are not held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time. Therefore, in determining the deferred taxation on investment property, the directors of the Company have determined that the presumption that the carrying amounts of investment property measured using the fair value model are recovered entirely through sale is not rebutted. For investment property located in The Republic of China ("Taiwan"), the Group is subject to capital gain tax upon disposal of the relevant investment property. The Group has recognised deferred tax liabilities on change in fair value of investment property of the Taiwan subsidiary.

Provision of ECL for financial assets

Financial assets are assessed for ECL individually. The provision rates are based on the Group's historical default rates taking into consideration forward-looking information that is reasonable and supportable available without undue costs or effort. Estimated net realisable value on stock of properties

In determining whether allowances should be made for the Group's stock of properties, the Group considers the current market and the estimated market value (i.e. the estimated selling price less estimated costs of selling expenses) less estimated costs to completion of the properties. An allowance is made if the estimated market value is less than the carrying amount. If the actual net realisable value on stock of properties is less than expected as a result of change in market condition and/or significant variation in the budgeted development cost, may result in material provision for impairment loss.

主要利率基準之根本性改革正在全球進行，包括以近乎無風險之替代利率取代部分銀行同業拆借利率（「IBORs」）。有關該利率基準改革對本集團風險管理策略所產生的影響及實施替代基準利率進程的詳情載列於本附註「利率基準改革」一節。

敏感度分析

以下敏感度分析乃根據於各報告期末非衍生工具之所承受之利率風險而釐定。該分析乃假設於各報告期末之未平倉金融工具於整個年度均未平倉而編製。向主要管理人員內部匯報利率風險時使用增加或減少25個基點，並為管理層對利率合理可能變動之評估。截至二零二四年十二月三十一日止年度，如利率為上升／下降25個基點而所有其他變數保持不變，本集團稅後虧損應增加／減少約2,490,000港元。截至二零二三年十二月三十一日止年度，如利率為上升／下降25個基點而所有其他變數保持不變，本集團資本化為物業存貨之利息應增加／減少約3,651,000港元。

A fundamental reform of major interest rate benchmarks is being undertaken globally, including the replacement of some Interbank Offered Rates (“IBORs”) with alternative nearly risk-free rates. Details of the impacts on the Group’s risk management strategy arising from the interest rate benchmark reform and the progress towards implementation of alternative benchmark interest rates are set out under “interest rate benchmark reform” section in this note.

Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rates for non-derivative instruments at the end of each reporting period. The analysis is prepared assuming the financial instruments outstanding at the end of the reporting period were outstanding for the whole year. A 25 basis points increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management’s assessment of the reasonably possible change in interest rates. For the year ended 31st December 2024, if interest rates had been 25 basis points higher/lower and all other variables were held constant, the Group’s post-tax loss would increase/decrease by approximately HK\$2,490,000. For the year ended 31st December 2023, if interest rates had been 25 basis points higher/lower and all other variables were held constant, the Group’s interests capitalised to stock of properties would increase/decrease by approximately HK\$3,651,000.

信貸風險及減值評估

本集團之信貸風險披露主要歸因於提供予一名董事之貸款、貿易應收賬款、按金及其他應收款項、應收非控股權益款項、定期存款、銀行結餘以及受限制現金。本集團並無持有任何抵押品或其他信貸增強措施以為其金融資產有關之信貸風險提供保障，惟與提供予一名董事之貸款有關的信貸風險已予減輕，因為該筆提供予一名董事之貸款乃以陳女士全資擁有於英屬處女群島（「英屬處女群島」）註冊成立之公司Reform Base Holdings Limited（「Reform Base」）全部已發行股本的股份押記作為抵押。

為將信貸風險降至最低，管理層已委派一個團隊負責釐定信貸限額、信貸批准及其他監察程序，以確保採取行動追收逾期貸款。此外，本集團就金融資產個別進行預期信貸虧損模式下的減值評估。就此而言，董事認為本集團之信貸風險已大幅降低。

Credit risk and impairment assessment

The Group's credit risk exposures are primarily attributable to loan to a director, trade receivables, deposits and other receivables, amount due from non-controlling interest, time deposits, bank balances and restricted cash. The Group does not hold any collateral or other credit enhancements to cover its credit risks associated with its financial assets, except that the credit risks associated with loan to a director is mitigated because loan to a director is secured by way of a share charge over the entire issued share capital of Reform Base Holdings Limited ("Reform Base"), a company incorporated in the British Virgin Islands (the "BVI") and wholly owned by Ms. Chen.

In order to minimise the credit risk, the management has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group performs impairment assessment under ECL model on financial assets individually. In this regard, the directors consider that the Group's credit risk is significantly reduced.

本集團採用簡易法按個別基準來計量貿易應收賬款之全期預期信貸虧損。董事基於歷史違約經驗而評估客戶結付應收款項之能力。賬面總值1,922,000港元(二零二三年：1,891,000港元)之貿易應收賬款乃應收與本集團有良好往績紀錄的客戶，故董事論定歸因於該等客戶之信貸風險為低並已確認無預期信貸虧損撥備(二零二三年：42,000港元)，預期平均虧損比率為0%(二零二三年：2.2%)。董事認為賬面總值640,000港元(二零二三年：640,000港元)之貿易應收賬款有信貸減值，故於二零二四年及二零二三年十二月三十一日全數計提預期信貸虧損撥備。

本集團對按金及其他應收款項之預期信貸虧損進行個別評估。預期虧損比率乃參考過往違約經驗釐定，並經調整以反映影響結付能力之宏觀經濟因素的當前及前瞻資料。董事論定賬面總值394,407,000港元(二零二三年：364,344,000港元)之信貸風險自初始確認以來並無明顯增加，及本集團乃基於12個月預期信貸虧損計提該等結餘之減值。已確認預期信貸虧損撥備5,322,000港元(二零二三年：8,066,000港元)，而預期平均虧損比率為1.4%(二零二三年：2.2%)。董事認為，賬面總值48,928,000港元(二零二三年：130,928,000港元)之按金及其他應收款項有信貸減值，故確認預期信貸虧損撥備48,928,000港元(二零二三年：79,928,000港元)，預期平均虧損比率為100%(二零二三年：61.1%)。

The Group applies simplified approach to measure lifetime ECL for trade receivables on an individual basis. The directors assessed customers' ability to settle the receivables based on historical default experience. Trade receivables with gross carrying amount of HK\$1,922,000 (2023: HK\$1,891,000) are due from customers that have good track record with the Group, the directors conclude that the credit risk attributable to these customers is low and no allowance for ECL (2023: HK\$42,000) was recognised with expected average loss rate of 0% (2023: 2.2%). The directors considered that trade receivables with gross carrying amount of HK\$640,000 (2023: HK\$640,000) was credit-impaired and allowance for ECL was fully provided as at 31st December 2024 and 2023.

The Group assessed the ECL for deposits and other receivables individually. The expected loss rate was determined by reference to past default experience and have been adjusted to reflect current and forward-looking information on macroeconomic factors that affecting the ability of settlement. The directors concluded that there is no significant increase in credit risk of gross carrying amount of HK\$394,407,000 (2023: HK\$364,344,000) since initial recognition and the Group provided impairment on these balances based on 12m ECL. Allowance for ECL of HK\$5,322,000 (2023: HK\$8,066,000) was recognised with expected average loss rate of 1.4% (2023: 2.2%). The directors considered that deposits and other receivables with gross carrying amount of HK\$48,928,000 (2023: HK\$130,928,000) was credit-impaired and allowance for ECL of HK\$48,928,000 (2023: HK\$79,928,000) was recognised with expected average loss rate of 100% (2023: 61.1%).

At 31st December 2023, the Group had advanced a loan to a director and considered the credit risk is limited since the borrower has an appropriate credit history and good reputation. The directors concluded that there is no significant increase in credit risk of these amounts since initial recognition and the Group provided impairment based on 12m ECL. Credit risk associated with loan to a director is also mitigated by way of a share charge over the entire issued share capital of Reform Base which holds indirect interest in a property located in Macau. Hence, the Group assessed the 12m ECL for loan to a director is insignificant and no allowance for ECL was recognised.

The Group assessed the ECL for amount due from non-controlling interest individually. The management believes that there is no significant increase in credit risk of these amounts since initial recognition as there was no significant change in its financial status. The Group provided impairment based on 12m ECL. During the year ended 31st December 2024 and 2023, the Group assessed the ECL for amount due from non-controlling interest are insignificant and no allowance for ECL was recognised.

Credit risk on time deposits and bank balances and restricted cash is limited because the counterparties are reputable banks with high credit ratings. The Group assessed 12m ECL for time deposits and bank balances to be insignificant and no allowance for ECL was recognised.

Liquidity risk

The Group manages liquidity risk by maintaining adequate cash and cash equivalents, monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and financial liabilities.

The liquidity risk is under continuous monitoring by the management. Reports with maturity dates of bank and other borrowings and thus the liquidity requirements are provided to management for review periodically. Management will raise or refinance bank and other borrowings whenever necessary.

At 31st December 2024 and 2023, the Group has no available unutilised banking facilities, and has HK\$435,760,000 (2023: nil) available unutilised other facilities.

The following table shows details of the Group's remaining contractual maturity for its non-derivative financial liabilities. The tables have been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest date on which the Group can be required to pay. Specifically, bank and other borrowings with a repayment on demand clause are included in the earliest time band regardless of the probability of the lender choosing to exercise their rights. The maturity dates for non-derivative financial liabilities are prepared based on the agreed repayment dates.

Under the MPF scheme, the employer and its employees are each required to make contributions to the MPF Scheme at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the MPF Scheme vest immediately upon the completion of the services in the relevant service period.

Under other defined contribution retirement schemes, the employers and their employees are required to make contributions to the schemes at 5% of the employees' basic salary subject to a cap of monthly contribution of MOP2,000 each. Where employees leave the schemes prior to the full vesting of the employers' contributions, the amount of forfeited contributions is used to reduce the contributions payable by the Group.

Employees of the Group's subsidiaries in the PRC are members of a state-managed retirement benefit scheme operated by the PRC government. The Group is required to contribute a specified percentage of payroll costs as determined by respective local government authority to the retirement benefits scheme to fund the benefit scheme.

Contributions totalling of HK\$12,000 (2023: HK\$164,000) were forfeited and utilised during the year ended 31st December 2024 to reduce contributions paid by the Group and no forfeited contribution was available at 31st December 2024 and 2023.

However, the Company cannot declare or pay a dividend, or make a distribution out of contributed surplus if: (i) it is, or would after the payment be, unable to pay its liabilities as they become due; or (ii) the realisable value of its assets would thereby be less than its liabilities and its issued share capital and share premium accounts.
