Corporate Communication means any document(s) issued or to be issued by the Company for the information or action of any holders of its securities, including but not limited to (a) the directors' report, its annual accounts together with a copy of the auditors' report and, where applicable, its summary financial report; (b) the interim report and, where applicable, summary interim report; (c) a notice of meeting; (d) a listing document; (e) a circular; and (f) a proxy form. You may elect:

- (1) to read future Corporate Communication published on the Company's website at www.chinatelecom-h.com and the Stock Exchange's website at www.hkexnews.hk ("Website Version") in place of receiving printed copies, and receive printed notification of the publication of Corporate Communication on websites; or
- (2) to receive the printed English version of all future Corporate Communication only; or
- (3) to receive the printed Chinese version of all future Corporate Communication only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communication.

In order to protect the environment and save costs, the Company recommends you to select the Website Version. To make your election, please mark (X) in the appropriate box on the enclosed reply form ("Reply Form") and sign and return it by post using the mailing label at the bottom of the Reply Form (a stamp is not needed if posted in Hong Kong) or hand delivery to the Company c/o the Company's H Share Registrar, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong.

If the Company does not receive the duly completed Reply Form nor receive a response indicating any objection from you by 6 February 2014, you will be deemed to have consented to Website Version of all future Corporate Communication only. A notification of the publication of the Corporate Communication will be sent to you by post when the relevant Corporate Communication is published on websites.

If you choose to receive future Corporate Communication in printed form, the Company will send the selected language(s) of the Corporate Communication to you unless and until you notify the Company c/o the Company's H Share Registrar in writing or using email that you wish to receive the Corporate Communication in the other (or both) language(s) or by electronic means (through the Company's and the Stock Exchange's websites). You have the right at any time by reasonable notice in writing or by sending email to chinatelecom.ecom@computershare.com.hk specifying your name, address and request to the Company c/o the Company's H Share Registrar, to change the choice of language or means of receipt of the Corporate Communication. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communication using electronic means but for any reason have difficulty in receiving or gaining access to the Corporate Communication, the Company will promptly upon your request send the Corporate Communication to you in printed form free of charge.
