Failure to complete any or all the boxes will entitle your proxy to cast his/her votes at his/her discretion. Your proxy will also be entitled to vote at his/her discretion on any resolution properly put to the meeting other than those referred to in the Notice of the First Class Meeting of H Shareholders of 2025.

The full descriptions and details of the special resolution proposed to be considered and approved at the First Class Meeting of H Shareholders of 2025 are set out in the circular and Notice of the First Class Meeting of H Shareholders of 2025 both dated 8 December 2025, which are also available at the Company's website www.china-tower.com.
- 6. This form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of a corporation, must be either executed under its common seal or under the hand of an officer or attorney or other person duly authorized to sign the same.
- 7. In the case of joint holders of any share, any one of such joint holders may vote at the meeting, either personally or by proxy, in respect of such shares as if he/she were solely entitled thereto. However, if more than one of such joint holders is present at the meeting, personally or by proxy, the vote of the joint holder whose name stands first in the H Share register of members of the Company and who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holder(s).
- 8. To be valid, this form of proxy together with the power of attorney (if any) or other authority under which it is signed (if any) or a notarially certified copy thereof, must be deposited at the Company's share registrar not less than 24 hours before the time arranged (i.e. before 10:00 a.m. on 22 December 2025) for convening the First Class Meeting of H Shareholders of 2025 or any adjournment thereof (as the case may be). H Shareholders shall deposit the relevant documents to the Company's share registrar, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong.
- 9. The proxy needs not be a shareholder of the Company but must attend the meeting in person to represent you.
- 10. Completion and return of the form of proxy will not preclude you from attending and voting at the meeting or any adjournment thereof if you so wish. In such event, the instrument appointing a proxy shall be deemed to be revoked.
