On 28 September 2010, the Company entered into a conditional subscription agreement with its wholly owned subsidiary, Billion Express Investments Limited and with China International Capital Corporation Hong Kong Securities Limited, Goldman Sachs (Asia) L.L.C. and Nomura International (Hong Kong) Limited under which Billion Express Investments Limited agreed to issue US\$1,838.8 million 0.75 per cent. guaranteed convertible bonds due 2015, exchangeable into ordinary shares of the Company. The convertible bonds are expected to be issued on 18 October 2010. Assuming full conversion of the convertible bonds at their initial conversion price, the convertible bonds will be convertible into approximately 900 million ordinary shares of the Company. Please refer to the announcement of the Company dated 28 September 2010 for details.
