- 5. This proxy form must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, this proxy form must be under its common seal or under the hand of an officer or attorney duly authorised.
- 6. Where there are joint holders of any shares in the Company, any one of such joint holders may vote at the meeting, either in person or by proxy, in respect of such shares as if he was solely entitled thereto, but if more than one of such joint holders be present at the meeting, the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of other joint holders and, for this purpose, seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.
- 7. To be valid, the proxy form together with power of attorney or other authority (if any) under which it is signed or a certified copy of such power or authority, must be deposited at the Company's Hong Kong Registrar and Transfer Office, Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than 48 hours before the time appointed for holding the meeting or any adjournment thereof.
- 8. Any member of the Company entitled to attend, speak and vote at the Meeting shall be entitled to appoint one or more (if the relevant member holds more than one share) proxies to attend, speak and vote instead of him. A proxy need not be a member of the Company but must be present in person to represent the member.
- 9. Completion and deposit of the proxy form will not preclude you from attending and voting at the Meeting or any adjourned meeting thereof if you so wish, and in such event, the proxy form will be deemed to be revoked.
- 10. Members of the Company who are entitled to attend, speak and vote at the Annual General Meeting are those whose names appear as members of the Company on the register of members of the Company on Tuesday, 20 May 2025. In order to be eligible to attend, speak and vote at the Annual General Meeting, all completed transfer documents, accompanied by relevant share certificates, must be lodged with the Company's Hong Kong Share Registrar and Transfer Office, Tricor Investor Services Limited for registration no later than 4:30 p.m. on Wednesday, 14 May 2025.

PERSONAL INFORMATION COLLECTION STATEMENT
