**PROPOSED AMENDMENTS TO  
THE SECOND AMENDED AND RESTATED  
MEMORANDUM AND ARTICLES OF ASSOCIATION**

This announcement is made by Crystal International Group Limited (the “**Company**”) pursuant to Rule 13.51(1) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The board of directors of the Company (the “**Board**”) proposes to make certain amendments (the “**Proposed Amendments**”) to the existing second amended and restated memorandum and articles of association of the Company (the “**Articles**”), for the purposes of, among others, (i) enhancing practical arrangements to facilitate the Company’s adoption of electronic dissemination of corporate communications, which is mandated under the latest amendments to the Listing Rules; and (ii) incorporating certain housekeeping amendments. As such, the Board proposes to amend the Articles by way of adopting the new third amended and restated memorandum and articles of association in substitution for, and to the exclusion of, the Articles.

The Proposed Amendments shall be subject to the approval of the shareholders of the Company (the “**Shareholders**”) by way of a special resolution at the forthcoming annual general meeting of the Company (the “**AGM**”). A circular containing, among others, details of the Proposed Amendments and a notice convening the AGM will be made available (and despatched, where applicable) to the Shareholders in due course.
