POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 25 SEPTEMBER 2020

The board of directors (the “**Board**”) of CST Group Limited (the “**Company**”) is pleased to announce that all the resolutions proposed at the annual general meeting of the Company held on 25 September 2020 (the “**AGM**”) were duly passed by the shareholders of the Company (the “**Shareholder(s)**”) by way of poll. The Company’s share registrar in Hong Kong, Tricor Tengis Limited, was appointed as the scrutineer for the vote-taking at the AGM.

As at the date of the AGM, the total number of shares of the Company (the “**Share(s)**”) entitling the holders to attend and vote on all the resolutions at the AGM was 38,698,308,961 Shares. There was no Share entitling the holders thereof to attend and abstain from voting in favour of any resolutions at the AGM pursuant to Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and no Shareholder was required under the Listing Rules to abstain from voting on any resolutions at the AGM. No party had stated his/her/its intention in the circular of the Company dated 25 August 2020 to vote against or to abstain from voting on any resolutions at the AGM.
