POSITIVE PROFIT ALERT

This announcement is made by Daido Group Limited (the “Company”, together with its subsidiaries, the “Group”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong) (the “SFO”).

Based on the information available for the time being, the board of directors (the “Board”) of the Company wishes to inform the shareholders of the Company (the “Shareholders”) and potential investors that the Group is expected to record a net profit attributable to the Shareholders of approximately not less than HK\$2,200,000 for the six months ended 30 June 2022 (the “First Half of 2022”), as compared to a net loss attributable to the Shareholders of approximately HK\$38,990,000 recorded for the six months ended 30 June 2021 (the “Prior Period”).

The Board considered that the turnaround from loss to profit position of the Group was primarily attributable to an internal business restructuring during 2021 including the disposal of interest in an associate, resulting in significant increase in the revenue and net profit from cold storage and related services business by approximately 42% and 161% respectively in the First Half of 2022 as compared to the Prior Period.

The information contained in this announcement is only based on the preliminary assessment by the Board with reference to the latest available consolidated management accounts of the Group, which have not been reviewed by the Company’s auditor. Details of the Group’s financial performance will be disclosed in the interim results announcement of the Group which will be issued in August 2022.

Shareholders and potential investors should exercise caution when dealing in the shares of the Company.
