If the Company does not receive the enclosed reply form or receive a response indicating the objection from you by 27 November 2017, you will be deemed to have consented to receive all future Corporate Communications by electronic means via the Website Version, and notification of the publication of the Corporate Communications on the Company’s website will be sent to you in the future.
