As at the date of the AGM, the total number of issued and fully paid up shares of the Company was 1,131,839,264 shares, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM. There were no shares entitling the holders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and there were no holders of shares that are required under the Listing Rules to abstain from voting at the AGM.

The executive director, namely Mr. ZHANG Yuying and the independent non-executive directors, namely Mr. YUEN Po Kwong, Mr. LAW Yee Kwan, Quinn and Ms. WONG Lai, Sarah attended the AGM in person, while executive directors, namely Mr. WANG Yusuo, Mr. GONG Luojian, Mr. WANG Dongzhi, Ms. ZHANG Jin and Ms. SU Li; the non-executive director, namely Mr. WANG Zizheng; and the independent non-executive director, namely Mr. MA Zhixiang attended the AGM by electronic means.
