- *"issue price per share" should be construed as "redemption price per share".*

**8. The closing balance date is the date of the last relevant event being disclosed.**

**9. Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.**

**10. "Identical" means in this context:**

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*
