DELAY IN DESPATCH OF CIRCULAR

An application has been made to the Stock Exchange by the Company for a waiver from strict compliance with Rules 14.38 and 14A.49 of the Listing Rules by extending the despatch date of the Circular to no later than 7th December, 2007.

Reference is made to the announcement of Riche Multi-Media Holdings Limited (the “Company”) dated 8th August, 2007 (the “Announcement”) in relation to the acquisition of a 100% interest in the issued share capital of Exceptional Gain Profits Limited and a sale loan, which constitute a very substantial acquisition and connected transaction for the Company under the Listing Rules. Terms used herein shall have the same meanings as defined in the Announcement unless defined otherwise.

As stated in the Announcement, a circular (the “Circular”) containing, among other things, further information in respect of the Acquisition, the letter of advice from the Independent Board Committee to Independent Shareholders and the recommendation of the independent financial adviser to the Independent Board Committee and the Independent Shareholders in respect of the Acquisition, the accountants’ report on Exceptional Gain, the independent valuation report of the Kingsway Hotel together with a notice convening the SGM will be despatched to Shareholders as soon as practicable in accordance with the Listing Rules.

Pursuant to Rules 14.38 and 14A.49 of the Listing Rules, the Company is required to send the Circular to Shareholders within 21 days after publication of the Announcement (i.e. 30th August, 2007). Extensions had been granted the Company to extend the date for despatch of the Circular to no later than 30th September, 2007, further to 26th October, 2007 and further to 16th November, 2007. All matters which had been outstanding for such extension have since been completed. However, as the statement of indebtedness is currently as at 31st August, 2007 (i.e. the figures are more than 8 weeks old) and update of such figures is necessary, additional time is required to prepare the statement of indebtedness up to 31st October, 2007. In addition, the valuation report to be included in the Circular will need to be updated to a date of not more than three months before the date of the Circular and additional time is also required to prepare an updated valuation report. As such, an application has been made to the Stock Exchange by the Company for a waiver from strict compliance with Rules 14.38 and 14A.49 of the Listing Rules by further extending the despatch date of the Circular to no later than 7th December, 2007.

Shareholders and potential investors of the Company should note that the Acquisition may or may not proceed. Shareholders and potential investors of the Company are advised to exercise caution when dealing in the Shares.
