MONTHLY PROGRESS OF POSSIBLE DISPOSAL OF SHARES IN SKYNET GROUP LIMITED

References are made to the announcements of Eternity Investment Limited (the "**Company**") dated 8 January 2016 and 11 January 2016 and the circular of the Company dated 22 April 2016 (the "**Circular**") relating to the possible disposal of shares in SkyNet Group Limited.
