### **Electronic Dissemination of Corporate Communications**

Pursuant to new Rule 2.07A<sup>1</sup> of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the second amended and restated articles of association of EuroEyes International Eye Clinic Limited (the “**Company**”), the Company will disseminate all future corporate communications of the Company (the “**Corporate Communications**”<sup>2</sup>) to the shareholders of the Company (the “**Shareholders**”) electronically and only send the Corporate Communications in printed form to the Shareholders upon request.

In this connection, the following arrangements will come into effect on 19 February 2024.

#### **ARRANGEMENTS**

1. Actionable Corporate Communications<sup>3</sup>

The Company will send the Actionable Corporate Communications to the Shareholders individually in electronic form by email. If the Company does not possess the email address of a Shareholder or the email address provided by a Shareholder is not functional<sup>4</sup>, the Company will send the Actionable Corporate Communications in printed form together with a request form for soliciting the Shareholder’s functional email address to facilitate electronic dissemination of Actionable Corporate Communications in the future.

2. Corporate Communications

The Company will make the Corporate Communications available on its website ([ir.euroeyes.hk](http://ir.euroeyes.hk)) and the Stock Exchange’s website ([www.hkexnews.hk](http://www.hkexnews.hk)).

A publication notice of the Corporate Communications, in both English and Chinese, will be sent by the Company to Shareholders by email or by post (only if the Company does not possess the functional email address of a Shareholder) on the publication date of the Corporate Communications.

#### **PROVISION OF SHAREHOLDER’S EMAIL ADDRESS TO THE COMPANY**

In support of electronic communication by email, the Company recommends its Shareholders to provide the Company with their email address at any time in future by reasonable notice in writing to the Company’s branch share registrar in Hong Kong at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong or by email to [1846-ecom@hk.tricorglobal.com](mailto:1846-ecom@hk.tricorglobal.com).

It is the responsibility of the Shareholders to provide an email address that is functional. If the Company does not possess the email address of a Shareholder or the email address provided is not functional, the Company will act according to the abovementioned arrangements. The Company will be considered to have complied with the Listing Rules if it sends Actionable Corporate Communications to the email address provided by a Shareholder without receiving any “non-delivery message”.
