VOLUNTARY ANNOUNCEMENT THE TOTAL NUMBER OF EYE SURGERIES FOR THE FIRST QUARTER OF 2024

EuroEyes International Eye Clinic Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis makes this announcement. The board (the “**Board**”) of directors (the “**Directors**” and each a “**Director**”) of the Company wishes to announce, according to the Company’s preliminary statistics and the information currently available to the Company, the combined total number of eye surgeries performed by the Group (the “**Eye Surgeries**”) for the period between 1 January 2024 to 31 March 2024 (the “**First Quarter of 2024**”), which was 7,234 eye surgeries, representing an increase of 6% as compared to the same period in 2023 (from 1 January 2023 to 31 March 2023: 6,825 eye surgeries).

The Group observed a continued favourable sales mix change throughout the First Quarter of 2024 due to (i) a significant increase in the number of lens exchange surgeries; and (ii) the opening of the clinics in Hong Kong and London, resulting in noticeable revenue growth. The Board is of the view that this is consistent with the Group’s three-year organic compound annual growth rate (CAGR) guidance.

The figures set out in this announcement have not been audited, and may differ from the final actual figures. Investors are reminded to exercise caution when dealing in the shares of the Company.
