Every Shareholder present in person or by proxy has one vote for every share of which he is the holder. There were (i) no Shares entitling the Shareholders to attend and abstain from voting in favour of any of the resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”); (ii) no Shareholder was required under the Listing Rules to abstain from voting on the resolutions at the AGM; and (iii) no Shareholders have stated their intention in the circular of the Company dated 26 April 2024 to vote against or to abstain from voting on any of the proposed resolutions at the AGM.
