**UNAUDITED OPERATING STATISTICS
OF PROPERTIES OF THE GROUP
FOR MARCH 2015**

The board of directors (the “**Board**”) of Evergrande Real Estate Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that the Group’s contracted sales of properties for the month of March 2015 amounted to approximately RMB13.71 billion. The contracted sales area for the month was approximately 1,814,000 square meters. The average selling price of properties of the Group for March 2015 was RMB7,558 per square meter. The aggregate contracted sales amount, aggregate contracted sales area and average selling price for the month of March 2015 represent an increase of 31.4%, 17.6% and 11.8%, respectively, over the same period in 2014, and an increase of 162.1%, 154.3% and 3.0%, respectively, over the month of February 2015.

The aggregated contracted sales of properties for the period from January to March 2015 amounted to approximately RMB30.54 billion, with the aggregated contracted sales area and average selling price for the period amounted to approximately 4,038,000 square meters and RMB7,564 per square meter respectively.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information. As such, the above data is provided
