**UNAUDITED OPERATING STATISTICS OF  
PROPERTIES OF THE GROUP FOR OCTOBER 2016**

The board of directors (the “**Board**”) of China Evergrande Group (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that the Group’s contracted sales of properties for the month of October 2016 amounted to approximately RMB36.13 billion. The contracted sales area totalled approximately 4,062,000 square meters. The average contracted selling price of properties was RMB8,894 per square meter. The contracted sales amount, sales area and average selling price for the month of October 2016 increased by 40.1%, 23.8% and 13.2% as compared to the same period in 2015, respectively.

The aggregate contracted sales amount of the Group’s properties for the period from January to October 2016 amounted to approximately RMB316.71 billion. The aggregate contracted sales area and average selling price amounted to approximately 38,640,000 square meters and RMB8,197 per square meter, respectively. The aggregate contracted sales amount, area and average selling price for the period from January to October 2016 increased by 104.9%, 92.5% and 6.4% as compared to the same period in 2015, respectively.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collecting such sales information.
