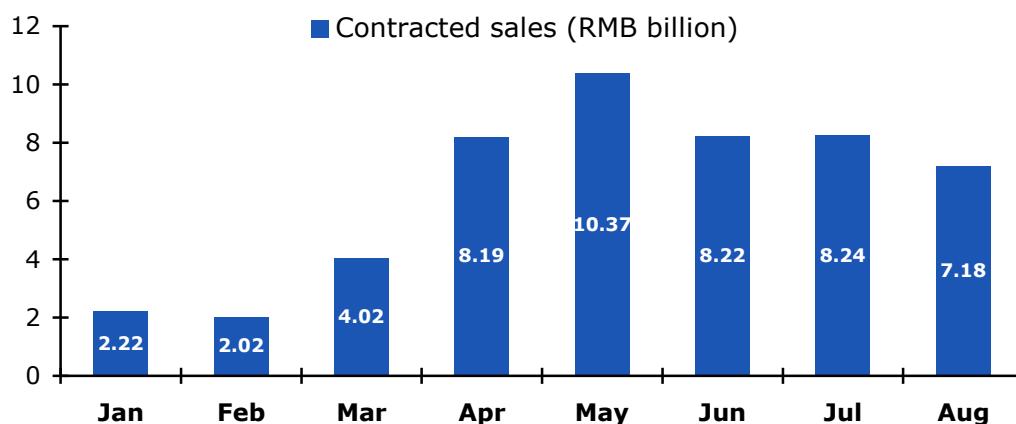

## **Evergrande Real Estate Group Limited Contracted Sales Results Update for August 2012**

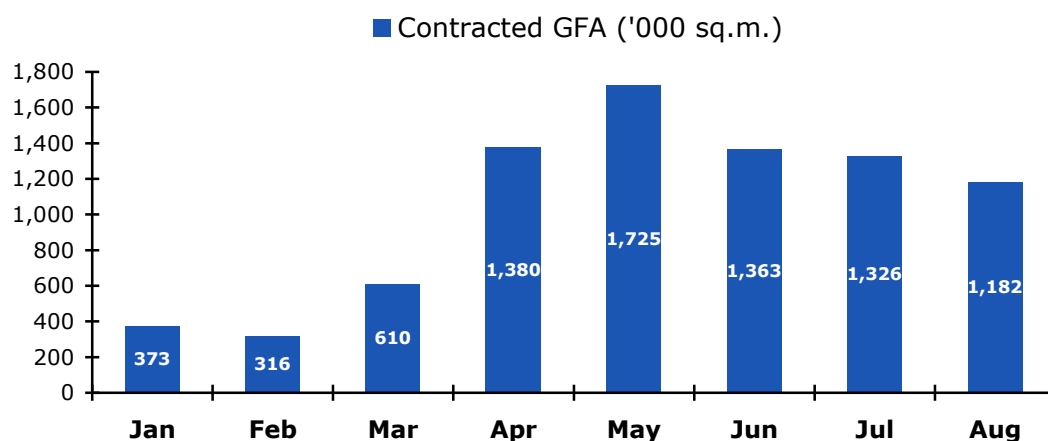
(11 September 2012, Hong Kong) **Evergrande Real Estate Group Limited** ("Evergrande" or the "Group", SEHK stock code: 3333), one of the leading large-scale integrated residential property developers in China, announces today its contracted property sales results for August 2012.

In August 2012, the Group achieved contracted sales amounting to RMB7.18 billion. Contracted GFA aggregated 1,182,000 sq. m., while contracted average selling price ("ASP") for the month was RMB6,076 per sq. m.. The Group launched 7 new projects for sale during the month, increasing its total number of projects in a sales mode to 163.

From January to August 2012, the Group's accumulated contracted sales amounted to RMB50.46 billion, thereby having 63.1% of its full-year contracted sales target completed. Contracted GFA aggregated 8,276,000 sq. m. and contracted ASP was RMB6,097 per sq. m. for the eight-month period.
