#### **Company Operation Information**

Fantasia Holdings Group Co., Limited ("Fantasia" or "the Company", SEHK stock code 1777) held a press conference on 29<sup>th</sup> November in Shenzhen regarding its new brand strategy. During the press conference, Fantasia launched a brand image and put forward a new slogan of "Blooming into value", with a view to build up the largest community service operating platform in China across eight major business sectors.

Colour Life (stock code: 1778), a subsidiary of the Company, starts to step into the international property management business. On 4<sup>th</sup> November, a wholly-owned subsidiary of Colour Life and Steadlink Asset reached an agreement that, the former agreed to purchase the latter's 34,000 shares for a total consideration of SGD 1.092 million (equivalent to approximately HKD 6.622 million), accounting for 68% of the latter's issued capital as of the date of the agreement. The move marks Colour Life's first attempt in international property management business, which is able to help

the Group gain experience in overseas property management, expand its online service platform, attract and retain more talents in property management for the Group's future expansion as well as strengthen its domestic business service capabilities.

On 13th November, Jiangsu Yangzhou Yulongwan Commercial Plaza Project, wholly entrusted to Fantasia Commercial Management Co., Ltd. ("Fantasia Commercial"), went into operation, which marked another significant breakthrough of the Company's light-asset model export. As of November 2014, Fantasia Commercial has successfully contracted four light-asset management projects in the cities, namely Chengdu, Hefei, Changsha and Yangzhou. The number of Fantasia Commercial's light-asset management projects is expected to exceed 10 by the end of 2015, which will establish Fantasia's leading position in light-asset business model in the industry.

### Property Sales (Note: Data in this news letter is unaudited and may be adjusted)

Fantasia realized contracted sales area of 162,691 square meters and contracted sales amount of RMB1.536 billion in November, which represented a YoY decrease of 1.53% and a YoY increase of 9.71%, respectively.

As of 30 November 2014, Fantasia's real estate business recorded cumulative contracted sales area of 1,135,951 square meters and contracted sales amount of RMB8.589 billion within this year, reaching 86% of the full-year sales target of RMB10 billion.
