On 29 November 2013, JL Investment Group Limited, an entity which is wholly-owned by Mr Lim Hwee Chiang, completed its disposal of 118,930,000 shares in ARA to The Straits Trading Company Limited (the "Disposal").

Prior to the Disposal, Mr Lim Hwee Chiang was deemed to have an interest in 18,892,828 units in Fortune REIT ("Units") comprising:

(a) 16,792,828 Units held by ARA Asset Management (Fortune) Limited, which is a wholly-owned subsidiary of ARA. Mr Lim had an interest (direct and deemed) of 33.33% of the shares in ARA; and

(b) 2,100,000 Units held by Citibank Nominees Singapore Pte. Ltd. (as nominee for JL Philanthropy Ltd). Mr Lim is the settlor of JL Charitable Settlement which is the beneficiary of JL Philanthropy Ltd.

Immediately after completion of the Disposal, Mr Lim has an interest (direct and deemed) in 19.25% of the shares in ARA, and accordingly, Mr Lim has ceased to have a deemed interest in the Units held by ARA Asset Management (Fortune) Limited.


