Completion of a Reorganisation Agreement

Further to the notification on 7 May 2015 in relation to the deemed interest arising from the reorganization agreement dated 5 May 2015 (the "Reorganization Agreement") entered into between CK Hutchison Holdings Limited ("CK Hutchison"), Cheung Kong Property Holdings Limited ("CK Property"), and other parties, Novel Trend Holdings Limited ("Novel Trend") has acquired Paola Holdings Limited ("Paola"). Novel Trend is 100% held by Mighty State Limited ("Mighty State") and CK Property holds 100% of Mighty State. Paola holds 100% of Burgeon Force Limited ("Burgeon Force"), which in turn holds 100% of Focus Eagle Investment Limited ("Focus Eagle") which holds 21.97% of Fortune Real Estate Investment Trust ("Fortune REIT").

New Challenge Global Limited which is 100% held by Mighty State has acquired HWPL Holdings Limited ("HHL"), which holds 100% of Hutchison REIT Holdings Limited ("Hutchison REIT Holdings"), which in turn holds 100% of Ballston Profits Limited ("Ballston"), which holds 5.98% of Fortune REIT.

The transactions contemplated under the Reorganization Agreement were completed on 3 June 2015 (the "Completion").

Relationship between Substantial Unitholders

Focus Eagle, which holds 413,074,684 units of Fortune REIT, is a wholly-owned subsidiary of Burgeon Force which in turn is a wholly-owned subsidiary of Paola. Immediately before the Completion, Paola was a whollyowned subsidiary of Ample Jungle Investments Limited ("Ample Jungle") which in turn is a wholly-owned subsidiary of Partner Vision Holdings Limited ("PVHL"). PVHL is a wholly-owned subsidiary of Cheung Kong (Holdings) Limited ("CKH") which in turn is a wholly-owned subsidiary of CK Hutchison. As such, each of CK Hutchison, CKH, PVHL, Ample Jungle ceased to have any deemed interest in the 413,074,684 Fortune REIT units which are currently held by Focus Eagle.

Ballston holds 112,556,000 units in Fortune REIT. Ballston is a wholly-owned subsidiary of Hutchison REIT Holdings which in turn is a wholly-owned subsidiary of HHL. Immediately before the Completion, HHL was a wholly-owned subsidiary of HWPL Group Holdings Limited which in turn is a wholly-owned subsidiary of Hutchison Whampoa Properties Limited ("HWPL"). HWPL is a wholly-owned subsidiary of Hutchison International Limited which in turn is a wholly-owned subsidiary of HWL. HWL is 49.97% owned by CKH which in turn is a wholly-owned subsidiary of CK Hutchison. As such, CK Hutchison and CKH ceased to have any deemed interest in the 112,556,000 Fortune REIT units which are currently held by Ballston.
