POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 6 JUNE 2018

The Board is pleased to announce that all the Ordinary Resolutions set out in the Notice of AGM were duly passed by the Shareholders by way of poll at the Annual General Meeting held on 6 June 2018.

Reference is made to the notice of Annual General Meeting (the “**Notice of AGM**”) and the circular (the “**Circular**”) of Frontier Services Group Limited (the “**Company**”) both dated 27 April 2018. Capitalized terms used herein shall have the same meanings as those defined in the Circular unless the context requires otherwise.

POLL RESULTS OF THE ANNUAL GENERAL MEETING

The Board is pleased to announce that all the ordinary resolutions (the “**Ordinary Resolutions**”) set out in the Notice of AGM were duly passed by the Shareholders by way of poll at the Annual General Meeting held on 6 June 2018.

Tricor Tengis Limited, the Company’s branch share registrar in Hong Kong, was appointed as the scrutineer for the vote-taking at the Annual General Meeting.

As at the date of the Annual General Meeting, the total number of issued ordinary shares in the Company was 2,139,703,003 shares, representing the total number of shares entitling the holders to attend and vote for or against the Ordinary Resolutions at the Annual General Meeting. There was no Shareholder, who was eligible to attend the Annual General Meeting, required to abstain from voting in favour of the Ordinary Resolutions at the Annual General Meeting as set out in Rule 13.40 of the Listing Rules and no Shareholder was required under the Listing Rules to abstain from voting on the Ordinary Resolutions at the Annual General Meeting. No parties had stated their intention to vote against or to abstain from voting on the Ordinary Resolutions at the Annual General Meeting.
