The Board is pleased to announce that with effect from 29 May 2013, the name of the Company has been changed from “Trasy Gold Ex Limited” to “Well Way Group Limited” and the dual foreign name of the Company name from “卓施金網有限公司” to “和滙集團有限公司”. The Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 19 June 2013.

The Shares will be traded on the Stock Exchange under the new stock short names of “WELL WAY GP” in English and “和滙集團” in Chinese with effect from 9:00 a.m. on Friday, 28 June 2013. The stock code of the Company remains as “8063”.

With effect from 2 July 2013, the website of the Company will be changed from www.trasy.com to www.wellwaygp.com to reflect the Change of Company Name.

The Board is pleased to announce that subsequent to the approval of the special resolution in relation to the Change of Company Name at the AGM held on 29 May 2013, the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in the Cayman Islands on 29 May 2013, certifying the change of the name of the Company from “Trasy Gold Ex Limited” to “Well Way Group Limited” and the dual foreign name of the Company name from “卓施金網有限公司” to “和滙集團有限公司” effective from 29 May 2013.

The Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 19 June 2013 confirming the registration of the Company's new English and Chinese names of "Well Way Group Limited" and "和滙集團有限公司" respectively in Hong Kong under Part XI of the Companies Ordinance (Cap. 32 of the laws of Hong Kong).

Thereafter, any new share certificate(s) of the Company will be issued under the new English and Chinese names of the Company.
