TERMS OF REFERENCE OF THE AUDIT COMMITTEE

(EFFECTIVE FROM 1 APRIL 2012)

審核委員會職權範圍

(於2012年4月1日生效)

1 Membership

成員

- (a) The Audit Committee (the “Committee”) shall be appointed by the Board of directors (the “Board”) from amongst the non-executive directors of the Company and shall consist of not less than three members, a majority of which should be independent non-executive directors (“INEDs”). At least one member must be an INED with appropriate professional qualifications or accounting or related financial management expertise as required under Rule 3.10(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”). The constitution of the Committee shall comply with the requirements of the Listing Rules as amended from time to time. R3.21

審核委員會（“委員會”）須由董事會從非執行董事中委任。委員會必須由不少於三名成員組成，且委員會的成員必須以公司的獨立非執行董事占大多數。其中至少有一名成員是須按香港聯合交易所有限公司證券上市規則（“上市規則”）第3.10(2)條所規定，具備適當專業資格，或具備適當的會計或相關的財務管理專長的獨立非執行董事。委員會的組成必須遵守不時更新的上市規則的要求。

- (b) The Chairman of the Committee shall be an INED. R3.21

委員會的主席必須是獨立非執行董事。

- (c) A former partner of the Company's existing auditing firm shall be prohibited from acting as a member of the Committee for a period of 1 year from the date of his or her ceasing: App 14
-C.3.2

- (i) to be a partner of the auditing firm; or
- (ii) to have any financial interest in the auditing firm,

whichever is later to occur.

現時負責審計公司賬目的核數公司的前任合夥人自以下日期（以日期較後者為準）起計一年內，不得擔任委員會的成員：

- (i) 他終止成為該核數公司合夥人的日期；或
- (ii) 他不再享有該核數公司財務利益的日期。

2 Attendance at Meetings 出席會議

- (a) The quorum for a meeting of the Committee shall be two members, both of whom must be INEDs.

委員會會議的法定人數為兩人，該兩人必須為獨立非執行董事。

- (b) The Chairman of the Board, the financial controller and internal auditor shall normally attend meetings of the Committee. A representative of the external auditors shall be invited to attend the meetings of the Committee where appropriate. Other staff who has specific responsibility for an area under review may also be invited to attend.

一般來說，董事會主席、財務總監及內部核數師必須出席委員會會議。如需要，外聘核數師的代表亦應被邀請出席委員會會議。對被檢討的範圍有特定職責的其它員工亦可以被邀請出席。

- (c) The company secretary shall be the secretary of the Committee and shall attend all meetings of the Committee.

公司秘書是委員會的秘書，而他必須出席委員會的所有會議。

- (d) Members of the Committee may participate in a meeting of the Committee by means of a conference telephone or other communications equipment through which all persons participating in the meeting can hear each other and participation in a meeting pursuant to this provision shall constitute presence in person at such meeting.

委員會成員可以透過電話會議或其他相似的通訊設備參加委員會會議，而透過該設備令參與會議的所有人應能夠聽見對方。根據本條款所述方式參加會議的人士將構成以個人方式參加該會議。

3 Frequency and Proceedings of Meetings

會議的次數

- (a) Meetings of the Committee shall be held not less than twice a year. The external auditors or any members of the Committee may request a meeting if they consider necessary. Upon the receipt of such request, the secretary of the Committee shall convene a meeting as soon as reasonably practicable and having regard to the convenience of all members with priority given to the INEDs.

會議應每年召開不少於 2 次。如認為有需要，外聘核數師或任何委員會成員可以要求召開會議。在收到該要求後，委員會秘書必須在合理、切實和可行的範圍內及方便所有成員（應給予獨立非執行董事優先權）的情況下儘快召開有關會議。

- (b) Unless otherwise agreed by all the members of the Committee, a meeting shall only be called with at least 7 days' prior notice.

除非委員會的所有成員一致同意，否則，會議只能在至少 7 天通知的情況下召開。

4 Committee's Resolutions

委員會的決議

A resolution in writing signed by all the members of the Committee shall be as valid and effective as if it had been passed at a meeting of the Committee and may consist of several documents in like form each signed by one or more of the members of Committee. Such resolution may be signed and circulated by facsimile or other forms of electronic communications. This provision is without prejudice to any requirement under the Listing Rules for a meeting of the Board or Committee to be held.

經委員會的所有成員簽署的書面決議，有如該決議是於委員會會議上通過，一樣具有同等效力。該決議可由多份相同格式的文件組成，而每份文件由一位或多位成員簽署。該決議可以透過傳真或其他電子通訊方式簽署及傳閱。本條文不得違反上市規則任何有關董事會或委員會會議的舉行之規定。

5 Authorities

授權

- (a) The Committee is authorised by the Board to investigate any activity within its terms of reference. It is authorised to seek any information it requires from any employee or executive director and such persons are directed to co-operate with any request made by the Committee.

委員會已獲董事會授權調查在其職權範圍內的任何活動。委員會已獲授權向所有員工或執行董事索取任何所須的資料，而該等人士已獲指示須對委員會所提出的所有要求作出合作。

- (b) The Committee is authorised by the Board, and at the reasonable expense of the Company, to obtain legal or other independent professional advice and to secure the attendance of other persons with relevant experience and expertise in the meetings of the Committee if it considers this necessary.

委員會已獲董事會授權，如委員會認為有需要，可由公司支付合理的費用向外界尋求法律或其他獨立專業意見及確保具備相關經驗及專業知識的外界人士出席會議。

- (c) The Committee shall report to the Board any suspected frauds or irregularities, failures of internal control and suspected infringements of any laws, rules and regulations which come to its attention and are of sufficient importance to warrant the attention of the Board.

如委員會知悉或懷疑公司內有任何欺詐、不合規則、不遵守內部監控或侵犯法律、法規及規例的行為，而委員會認為該等行為具足夠重要性須讓董事會知悉，委員會便應就該行為向董事會報告。

- (d) The Committee should make available its terms of reference, explaining its role and the authority delegated to it by the Board by including them on the Exchange's website and the Company's website. The terms of reference of the Committee shall be provided upon request and the role and function of the Committee should be explained in the Corporate Governance Report in the annual reports of the Company.

- (e) Where the Board disagrees with the Committee's view on the selection, appointment, resignation or dismissal of the external auditors, the Committee shall make arrangements to disclose in the Corporate Governance Report in the annual reports of the Company an explanation of the Committee's recommendation and the reasons why the Board has taken a different view.

6 General Responsibilities

一般責任

- (a) The Committee shall serve as a focal point for communication between other directors, the external auditors and the internal auditors regarding their duties relating to financial and other reporting, internal controls, external and internal audits and such other matters as the Board determines from time to time.

委員會應就其對財務及其他匯報、內部監控、外部和內部審計的責任及董事不時決定的其他事項作為其他董事、外聘核數師及內部核數師之間的一個溝通的焦點。

- (b) The Committee shall assist the Board in fulfilling its responsibilities by providing an independent review and supervision of financial reporting, by satisfying themselves as to the effectiveness of the internal controls of the Company and its subsidiaries (the “**Group**”), and as to the adequacy of the external and internal audits.

委員會應透過令其信納公司及其附屬公司（“**集團**”）的內部監控的有效性及內部和外部審計的足夠性，對財務匯報提供獨立檢討及督導從而協助董事會履行其責任。

- (c) The Committee shall fulfill other responsibilities as required by the Listing Rules as amended from time to time. App 14-C.3.8

7 Duties

The duties of the Committee shall be:

Relationship with the Company's auditors

與公司核數師的關係

- (a) to be primarily responsible for making recommendations to the Board on the appointment, reappointment and removal of external auditors, and to approve remuneration and terms of engagement of external auditors, and any questions of resignation or dismissal of external auditors; App 14-C.3.3(a)

主要負責就外聘核數師的委任、重新委任及罷免向董事會提供建議、批准外聘核數師的薪酬及聘用條款及處理任何有關該核數師辭職或辭退該核數師的事宜；

- (b) to consider the plan for each year's audit submitted by the external auditors and discuss the same at a meeting if necessary;

考慮外聘核數師提交的每年核數計劃及，如需要，在會議中就該計劃作出討論；

- (c) to review and monitor the external auditors' independence and objectivity and effectiveness of the audit process in accordance with applicable standards. In this connection, the Committee shall: App 14-C.3.3(b)

按適用的標準檢討及監察外聘核數師是否獨立及客觀以及核數程序是否有效。就此而言，委員會必須：

- (i) consider all relationships between the Company and the external auditors (including non-audit services); App 14-C.3.3 Note 1(i)

- (ii) obtain from the external auditors annually, information about policies and processes for maintaining independence and monitoring compliance with relevant requirements, including provision of non-audit services and requirements regarding rotation of audit partners and staff; App 14-C.3.3 Note 1(ii)

每年向外聘核數師索取資料，瞭解核數師就保持其獨立性以及在監察有關規則執行方面所採納的政策和程序，包括有關提供非核數服務及就轉換核數合夥人及職員的規定；

- (iii) meet with the external auditors, at least annually, in the absence of management, to discuss matters relating to its audit fees, any issues arising from the audit and any other matters the external auditors may wish to raise; App 14-C.3.3 Note 1(iii)

至少每年在管理层不在场的情况下会见外聘核数师一次，以讨论与核数费用有关的事宜、任何因核数工作产生的事宜及外聘核数师想提出的其它事项；

- (iv) conduct annual review of all non-audit services performed by the external auditors, the nature of the non-audit services, the related fee levels and the fee levels individually and in aggregate relative to the external auditors, the criteria which govern the compensation of the individuals performing the audit, the safeguards in place to ensure that there is no threat to the objectivity and independence of the audit because the external auditors provide non-audit services, and to ensure that such services do not impair the independence or objectivity of the external auditors; and

For this purpose, "external auditors" includes any entity that is under common control, ownership or management with the audit firm or any entity that a reasonable and informed third party knowing all relevant information would reasonably conclude to be part of the audit firm nationally or internationally. The Committee should report to the Board, identifying and making recommendations on any matters where it considers that action or improvement is needed;

- (f) to monitor the integrity of the Company's financial statements and annual reports and accounts, half-yearly reports and, if prepared for publication, quarterly reports, and to review significant financial reporting judgments contained in them. In reviewing these reports before submission to the Board, the Committee shall focus particularly on: App 14-C.3.3(d)

This discussion should include the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's accounting and financial reporting function; App 14-C.3.3(g)

8 Reporting Procedures

報告程序

- (a) The Committee shall report to the Board. At the next meeting of the App 14-

Committee shall report their decisions and recommendations of the
Committee to the Board.

- (b) Full minutes of meetings of the Committee shall be kept by the secretary of the Committee. Draft and final versions of minutes of the meetings shall be sent to all Committee members for their comment and records within 14 days after the meeting. App 14-C.3.1

- (c) Copies of the minutes of meetings of the Committee shall be provided to the Board at its meetings.

委員會會議紀錄的副本須於董事會會議中向董事提供。

- (d) The Committee shall make available the chairman of the Committee (or in his absence, at least one of its members) to attend the Company's annual general meeting to answer shareholders' questions about audit issues. App 14-E.1.2

委員會應安排委員會主席(若委員會主席未克出席，則至少一名委員)出席股東周年大會，並在會上回答股東就審計問題有關的提問。

9 Revision of the terms of reference 職權範圍的更新

These terms of reference shall be updated and revised as and when necessary in light of changes in circumstances and changes in regulatory requirements (e.g. the Listing Rules). Any amendment to these terms of reference shall be by way of resolution of the Board of the Company and shall be in full compliance with the Listing Rules and any other regulatory requirements.

當有需要時，本職權範圍應就環境及法定要求（如上市規則等）的改變而作出更新及修改。任何對此職權範圍之修改，須由公司董事會通過決議，有關修改須完全符合上市規則及其他監管要求。
