FURTHER DELAY IN DESPATCH OF CIRCULAR

Reference is made to the announcements of Greater China Financial Holdings Limited (the “**Company**”) dated 16 November 2019, 6 December 2019, 20 December 2019, 10 January 2020, 7 February 2020, 6 March 2020, 9 April 2020 and 8 May 2020 (the “**Announcements**”) in relation to, among other things, the acquisition of Xin Yunlian Investment Limited involving the issue of convertible notes under specific mandate and the issue of shares under general mandate to a consultant and the delay in despatch of circular. Capitalised terms used herein shall have the same meaning as those defined in the Announcements unless stated otherwise.

As disclosed in the Announcements, a circular containing, among other things, (i) further information of the Acquisition; (ii) a notice of the SGM; (iii) the valuation report of the Target Company; (iv) the accountants’ report of the Target Group; (v) pro forma financial information on the enlarged Group; and (vi) other information required to be disclosed under the Listing Rules, was expected to be despatched to the Shareholders on or before 12 June 2020. As additional time is required to finalise certain information in the circular, the Company expects that the date of despatch of the abovementioned circular will be postponed to a date falling on or before 30 June 2020.
