**CHANGE OF COMPANY NAME, STOCK SHORT NAMES  
AND COMPANY WEBSITE ADDRESS**

Reference is made to the announcement of Vision Fame International Holding Limited (now known as Green Economy Development Limited) (the “**Company**”) dated 6 September 2021 and the circular of the Company dated 7 September 2021 (the “**Circular**”) in relation to the proposed change of name of the Company. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless otherwise defined.

**CHANGE OF COMPANY NAME**

The Board is pleased to announce that the Shareholders passed the special resolution approving the Change of Company Name at the Extraordinary General Meeting held on 30 September 2021. The certificate of incorporation on change of name of the Company in relation to the change of the English name of the Company from “Vision Fame International Holding Limited” to “Green Economy Development Limited” and the adoption of “綠色經濟發展有限公司” as its new dual foreign name to replace its existing Chinese name “允升國際控股有限公司” was issued by the Registrar of Companies in the Cayman Islands on 13 October 2021. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Companies Registry in Hong Kong on 3 November 2021.

**EFFECT OF THE CHANGE OF COMPANY NAME**

The Change of Company Name will not affect any rights of the Shareholders or the Company’s daily business operation or its financial position. All existing share certificates of the Company in issue bearing the present name of the Company will continue to be effective and valid evidence of legal title to the Shares and will continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates of the Company for new certificates bearing the new English and Chinese names. All new share certificates will be issued in the new English and Chinese names of the Company.

## **CHANGE OF STOCK SHORT NAMES**

The English stock short name of the Company will be changed from “VISION FAME” to “GREEN ECONOMY” and the Chinese stock short name of the Company will be changed from “允升國際” to “綠色經濟” for trading in the securities of the Company on the Stock Exchange with effect from 9:00 a.m. on 17 November 2021. The stock code of the Company on the Stock Exchange remains unchanged as “1315”.

## **CHANGE OF COMPANY WEBSITE ADDRESS**
