

# Everbright Greentech Secures Anhui Xiao County General Industrial Solid Waste Treatment and Electricity and Heat Cogeneration Project and Shanxi Jinzhong Hazardous Waste Integrated Treatment Project

**Hong Kong, 25 March 2020** – China Everbright Greentech Limited ("Everbright Greentech" or the "Company") (Stock code: 1257.HK) is pleased to announce that the Company has recently secured Xiao County General Industrial Solid Waste Treatment and Electricity and Heat Cogeneration Project ("Xiao County Project") Phase I in Anhui Province and Jinzhong Hazardous Waste Integrated Treatment Project ("Jinzhong Project")in Shanxi Province, commanding a total investment of approximately RMB670 million.

With an investment of approximately RMB480 million, Xiao County Project Phase I is designed with a daily incineration processing capacity of 400 tonnes of general industrial solid waste, with its services covering industrial enterprises in Xiao County. The project is also expected to have an annual heat supply capacity of 220,000 tonnes for the surrounding industrial parks of the project and urban districts of Xiao County. It will be invested in and constructed based on a BOO (Build-Operate-Own) model, with a concession period of no less than 30 years.

Jinzhong Project, with an investment of approximately RMB190 million, has a designed annual hazardous waste landfill capacity of 50,000 tonnes and a designed annual physiochemical processing capacity of 20,000 tonnes. It will be responsible for collecting and processing hazardous waste and solid waste produced by industrial enterprises in Shanxi Province. The project will be invested in and constructed based on a BOO model, with a concession period of no less than 50 years.

**Mr. Qian Xiaodong, CEO of Everbright Greentech** said, "In 2020, Everbright Greentech will focus on value creation and steadily foster business transformation towards the industrial environmental protection. Following the securing of Suqian General Industrial Solid Waste Electricity and Heat Cogeneration Project, the Company has further expanded its presence in the field of general industrial solid waste treatment by securing Xiao County Project Phase I, which has helped to solidify the Company's position in the hazardous waste treatment market. Once the project completes construction, it will create effective synergy with the Company's integrated biomass and waste-to-energy projects that are under operation in the county, providing comprehensive environmental protection solution to Xiao County and facilitating the county to win the 'Three Major Battles' for ecological and environmental protection."
