

## **EVERBRIGHT GREENTECH RECEIVES DUAL ESG RATING UPGRADES, UNDERSCORING STRONG CAPABILITIES IN SUSTAINABLE DEVELOPMENT**

**Hong Kong, 5 August 2025** – China Everbright Greentech Limited (“Everbright Greentech” or the “Company”) (SEHK: 1257.HK) is pleased to announce recent enhancements in its Environmental, Social and Governance (ESG) performance, marked by rating upgrades from two leading agencies—Wind and Sino-Securities Index (SNSI). These upgrades reflect the Company’s continued advancement in sustainable development and its progress in delivering high-quality growth.

Everbright Greentech has been upgraded to an “A” rating in Wind’s latest 2025 ESG assessment, rising one notch from its previous “BBB” rating in 2024. The Company now ranks 19th out of 106 power sector firms evaluated by Wind, a leading provider of financial data. Wind’s ESG rating framework, which adheres to international standards and incorporates sector-specific ESG risks and opportunities, evaluates companies across seven tiers ranging from “AAA” to “CCC” based on their relative performance with industry peers. An “A” rating reflects strong governance, low exposure to ESG risks, and solid sustainability performance. This upgrade underscores Everbright Greentech’s strong ESG practices and risk management capabilities, marking another step forward in its sustainable development journey.

In addition, Everbright Greentech received an ESG rating upgrade from SNSI in June 2025, being awarded a “BBB” rating on 30 April 2025. This marked a significant uplift of three notches from the “CCC” rating received in July 2024. This significant advancement reflects a series of targeted enhancements, including increased employee training hours, the promotion of ISO and ISCC certifications across multiple projects, strengthened climate risk management, and improved ESG disclosure practices. SNSI’s ESG rating system comprises nine tiers, ranging from “AAA” to “C”, with a “BBB” rating corresponding to an adjusted ESG score between 80 and 85. The upgrade highlights Everbright Greentech’s significant progress across multiple ESG dimensions.
