Hong Kong, 22 August 2025 – China Everbright Greentech Limited (“Everbright Greentech” or the “Company”) (SEHK: 1257.HK) is pleased to announce that its wholly-owned subsidiary, Everbright Ecological Remediation (Jiangsu) Limited (“Everbright Ecological Remediation”), has recently secured the standard closure project for the Yundong Household Waste Landfill Site, located in Dashu Village and Heping Village, Wangzhigang Town, Baoying County, Yangzhou City, Jiangsu Province, China (the “Yangzhou Baoying Landfill Project”).

The project includes the excavation and treatment of excess waste, landfill closure and capping works, retrofit to the equalisation basin, and full-scale leachate treatment.

Leveraging its extensive hands-on experience and strong technical capabilities in landfill remediation and leachate treatment, Everbright Ecological Remediation has built a strong track record across multiple projects.
