2. Updated Arrangement on Electronic Dissemination of Corporate Communications

Please be informed that the following updated arrangement on electronic dissemination of Corporate Communications has come into effect pursuant to Rule 2.07A(1) of the Rules Governing the Listing of Securities on the HKEX (the “Listing Rules”) and the amended and restated Bye-laws of the Company which took effect from 13 November 2024 (the “Bye-Laws”):

i. Corporate Communications

The English and Chinese versions of all Corporate Communications will continue to be available on the website of the Company at www.guoco.com and the HKEXnews website of the HKEX at www.hkexnews.hk.

Under the Listing Rules and the Bye-Laws, the Company is no longer required to give notice of availability to shareholders on publication of Corporate Communications on the Company’s website. You are encouraged to (i) register under “Email Alert Request” in the “Investor Relations” section on the Company’s website at www.guoco.com/en/investor_relations/email-alert-request/; or (ii) subscribe for the News Alert service on the website of the HKEX at www.hkex.com.hk/eng/invest/user/login_e.aspx to receive notifications when the Company publishes its Corporate Communications.

ii. Actionable Corporate Communications^(Note 2)

The Company will send Actionable Corporate Communications to each shareholder individually by email or by post.

It is the responsibility of registered shareholders to provide a functional email address to the Company. If you have not provided your email address to the Company or you need to update your email address, you may provide/update your email address online by scanning your personalized QR code printed on **Option 1** of the enclosed request form (the “Request Form”). Alternatively, you may complete **Option 2** of the Request Form, sign and return it to the Company’s Hong Kong branch share registrar, Computershare Hong Kong Investor Services Limited (the “Share Registrar”), by post to 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wan Chai, Hong Kong, or by email to Guoco.ecom@computershare.com.hk.

If the Company does not have your functional email address, until such time that a functional email address is provided to the Share Registrar, the Company will send the Actionable Corporate Communications in printed form to you by post at the address as appearing in the Company’s register of members maintained by the Share Registrar together with a request form for soliciting your functional email address.

iii. Request for Corporate Communications in Printed Form

You are entitled at any time by reasonable prior notice in writing to the Share Registrar to request receiving, free of charge, the Corporate Communications in printed form or to change your choice of language of the printed copies. You may make your request by completing the Request Form, signing and returning it to the Share Registrar by post to 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wan Chai, Hong Kong, or by email to Guoco.ecom@computershare.com.hk. Any such request shall remain valid until such time following the Company’s publication of its next annual report, or when the original request is revoked in writing by you, or superseded by a subsequent written request by you (whichever is earlier). Please note that you must complete and return a fresh request form if you wish to continue to receive Corporate Communications in printed form after the original request becomes invalid.
