In addition, the innovative design effort that went into HTHKH's 2012 Annual Report earned the Silver Award in the Cover Photo/Design in Telecommunications: Asia category of the 2013 International ARC Awards.

The International ARC Awards scheme is one of the world's grandest annual report competitions, which this year saw more than 2,200 entries from 34 countries. The HTHKH 2012 Annual Report theme was "Connect to the Future", with abstract illustrations on the cover symbolising mobile and optical networking. This approach was made all the more appealing by a hot stamping and embossing production process.
