Conversion Price of the possible issue of Shares is HK\$0.6.

(II) On 31 May 2013, the Company entered into a subscription agreement pursuant to which the Company has conditionally agreed to issue convertible notes in the principal amount of HK\$45,750,000. Assuming full conversion of the convertible notes at the conversion price of HK\$0.6 per share, a total of 76,250,000 conversion shares will be allotted and issued.
