1. 250,000,000 share options of the 470,000,000 outstanding share options granted on 27 July 2017 were conditionally granted and are subject to the approval of the shareholders of the Company, and such 470,000,000 outstanding share options are exercisable from the date of grant to 26 July 2020.

2. Vesting date of the 153,000,000 outstanding share options granted on 27 July 2017: one third were vested on the date of grant and are exercisable from the date of grant to 26 July 2020; one third shall be vested on 1 January 2018 and be exercisable from such vesting date to 26 July 2020; and the remaining shall be vested on 1 January 2019 and be exercisable from such vesting date to 26 July 2020.

3. Such 80,000,000 outstanding share options granted on 29 November 2017 are subject to the acceptance of the grantees and are exercisable from the date of grant to 28 November 2020.

4. Vesting date of the 120,000,000 outstanding share options granted on 29 November 2017 (of which 10,000,000 share options are subject to the acceptance of the grantees): 50% were vested on the date of grant and are exercisable from the date of grant to 28 November 2020; and the remaining shall be vested on 29 November 2018 and be exercisable from the such vesting date to 28 November 2020.
