1. The 1,000,000 share options lapsed on 28 November 2020.

2. As at 30 November 2020, the convertible bonds with the principal amount of HK\$105,000,000 was overdue. Upon maturity of the convertible bonds in February 2020, the Company has been negotiating renewed terms with the bondholders. The Company intends to repay the convertible bonds from the net proceeds of the rights issue to be conducted by the Company as disclosed in the announcement and circular of the Company dated 11 September 2020 and 4 November 2020 respectively, and the completion of the rights issue will be subject to approval from independent shareholders of the Company at the extraordinary general meeting of the Company to be held on 27 November 2020 and fulfilment of all other conditions of the rights issue as detailed in the abovementioned announcement and circular of the Company.
