FURTHER DELAY IN PUBLICATION OF AUDITED ANNUAL RESULTS ANNOUNCEMENT AND ANNUAL REPORT

Reference is made to the announcement of Farnova Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) dated 24 June 2020 in relation to the unaudited annual results for the year ended 31 March 2020 (the “**Announcement**”) and the announcement of the Company in relation to the delay in publication of the 2019 Annual Results and the Annual Report dated 24 June 2020, 31 July 2020 and 14 August 2020 (the “**Delay Announcement**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Announcement and the Delay Announcement.

As disclosed in the Delay Announcement, the Company is unable to publish the annual results and the Company’s annual report for the year ended 31 March 2020 (the “**2020 Annual Results**”) by 31 July 2020 due to the reason of the outbreak of novel coronavirus pneumonia which affects the annual audit. The Company expected that the auditing process would be completed on or before 31 August 2020. Based on the recent discussion with the Company’s auditor, the Board currently expects that, barring unforeseen circumstances, the further announcement in relation to the audited 2020 Annual Results as agreed by the Company’s auditor and the material differences (if any) as compared with the unaudited annual results in the Announcement will be published on or before 4 September 2020 and the annual report for the year ended 31 March 2020 will be despatched to the Shareholders by no later than 7 September 2020.

The Company will keep the Shareholders and potential investors of the Company informed of the latest progress of the annual audit and make further announcement(s) as and when necessary.

Shareholders and potential investors of the Company are advised to exercise caution in dealing in the shares of the Company.
