**VOTING RESULTS AT ANNUAL GENERAL MEETING HELD

Reference is made to the circular (the “Circular”) of Leeport (Holdings) Limited (the “Company”) and the notice (the “Notice”) of the annual general meeting issued to the shareholders of the Company dated 21 April 2009.
