### **GRANT OF SHARE OPTIONS**

This announcement is made by Li Ning Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.06A of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board of directors (the “**Board**”) of the Company hereby announces that on 13 August 2013 (the “**Grant Date**”), the Board has granted in aggregate 6,575,840 options (the “**Options**”) to the senior management staff and one consultant of the Company (the “**Grantees**”), subject to acceptance of the Grantees, to subscribe for a total of 6,575,840 ordinary shares of HK\$0.10 each in the capital of the Company (the “**Shares**”) pursuant to the share option scheme adopted by the Company on 5 June 2004 and amended on 15 May 2009 and 11 October 2012. The total number of Grantees includes 20 senior management staff and one consultant.

Each Option shall entitle the holder of the Option to subscribe for one Share at an exercise price of HK\$5.07 per Share, which is the highest of: (a) the closing price of HK\$5.07 per Share as stated in the Stock Exchange’s daily quotations sheets on the Grant Date; (b) the average closing price of HK\$5.00 per Share as stated in the Stock Exchange’s daily quotations sheets for the five business days immediately preceding the Grant Date; and (c) the nominal value of HK\$0.10 per Share. Options granted are valid for a period from the Grant Date to 31 December 2019.

None of the Grantees is a director, chief executive or substantial shareholder of the Company, or an associate of any of them (as defined in the Listing Rules).
