ANNOUNCEMENT

WRIT OF SUMMONS ISSUED AGAINST THE COMPANY

This announcement is made by Mayer Holdings Limited (the “**Company**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited.

On 29 March 2012, a writ of summons (the “**Writ**”) was issued by Capital Wealth Finance Company Limited (“**Capital Finance**”) against the Company as the defendant, under which Capital Finance is claiming against the Company for the sum of HK\$5,500,000.00 being the outstanding principal of a loan advanced by Capital Finance to the Company (the “**Loan**”).

Pursuant to the Writ, Capital Finance is claiming against the Company for:

1. the said sum of HK\$5,500,000.00, being the outstanding principal of the Loan;
2. interest on the Loan at the judgment rate from 29 December 2011 to the date of full repayment;
3. costs; and
4. further and/or other relief.

The Company is currently seeking legal advice in respect of the Writ and will make further announcement in due course as to any material development in connection with the proceedings.

SUSPENSION OF TRADING

Trading in the Shares has been suspended since 9:00 a.m. on 9 January 2012, and it will remain suspended pending the release of an announcement by the Company.
