**INTRODUCTION**

The purpose of this circular is to provide you with the relevant information regarding the granting of the General Mandate and the Repurchase Mandate and the re-election of Directors, and to give you notice of AGM at which ordinary resolutions will be proposed to consider, and if thought fit, approve at the AGM, among other matters, the granting of the General Mandate and the Repurchase Mandate and the re-election of Directors.

### GENERAL MANDATES TO REPURCHASE AND ISSUE SHARES

On 19 June 2009, ordinary resolutions of the Shareholders of the Company were passed to grant to the Directors general unconditional mandates (i) to repurchase Shares of the Company on the Stock Exchange or on any other stock exchange on which the securities of the Company may be listed and which is recognized by the SFC and the Stock Exchange for this purpose, which does not exceed 10 per cent. of the aggregate nominal value of the share capital of the Company in issue on the date of passing the relevant resolution; and (ii) to allot, issue and otherwise deal with Shares of the Company up to the limit of 20 per cent. of the aggregate nominal value of the share capital of the Company in issue on the date of passing such resolution. No Shares have been repurchased pursuant to the repurchase mandate granted.

These general mandates will lapse at the conclusion of the forthcoming Annual General Meeting of the Company which will be held at Room 501, 5/F Aon China Building, 29 Queen's Road Central, Hong Kong on Friday, 11 June 2010 at 2:30 p.m. At the AGM, ordinary resolutions will be proposed:

- (i) to grant the Repurchase Mandate to the Directors to enable them to repurchase Shares of the Company on the Stock Exchange or on any other exchange on which the Shares have been or may be listed and recognised for this purpose by the SFC and the Stock Exchange under the Repurchases Code, which does not exceed 10 per cent. of the aggregate nominal value of the issued share capital of the Company on the date of passing such resolution to grant the Repurchase Mandate;
- (ii) to grant the General Mandate to the Directors to enable them to allot, issue and otherwise deal with Shares of the Company up to the limit of 20 per cent. of the aggregate nominal value of the issued share capital of the Company on the date of passing such resolution to grant the General Mandate; and
- (iii) to increase the number of Shares to be allotted, issued and deal with under the General Mandate by an additional number representing such number of Shares repurchased under the Repurchase Mandate.

As at the Latest Practicable Date, the authorised share capital of the Company was HK\$200,000,000 divided into 2,000,000,000 Shares, of which 576,000,000 Shares were in issue.

On the basis of 576,000,000 existing Shares in issues as at the Latest Practicable Date and no further Shares are issued or repurchased prior to AGM, the maximum number of Shares which may fall to be issued under this proposed Issued Mandate will be 115,200,000 Shares.

On the basis of 576,000,000 existing Shares in issue as at the Latest Practicable Date, the Directors would be authorised to repurchase up to 57,600,000 Shares which represent 10 per cent. of the 576,000,000 existing Shares in issue as at the Latest Practicable Date.

The Repurchase Mandate allows the Company to make repurchase only during the period from the date of the passing of the relevant resolution until the earliest of the conclusion of next annual general meeting of the Company, the date by which the next annual general meeting of the Company is required by the Articles of Association, or any applicable law of the Cayman Islands to be held and the date upon which the Repurchase Mandate is revoked or varied by an ordinary resolution of shareholders of the Company in general meeting.

In accordance with the Listing Rules, the Company is required to send to the Shareholders an explanatory statement containing all information reasonably necessary to enable them to make an informed decision on whether to vote for or against the ordinary resolution to renew the grant to the Directors of the Repurchase Mandate. Such explanatory statement is set out in the Appendix I to this circular.

### RE-ELECTION OF DIRECTORS

In accordance with Article 112 of the Articles of Association of the Company, each of Mr. Lin Sheng-bin, Mr. Huang Jui-hsiang and Mr. Alvin Chiu would retire by rotation at the forthcoming Annual General Meeting and offer themselves for re-election to serve for another term. Details of Mr. Lin Sheng-bin, Mr. Huang Jui-hsiang and Mr. Alvin Chiu are set out in Appendix II to this circular.

### ANNUAL GENERAL MEETING

A notice convening the AGM is set out on pages 11 to 14 of this circular, ordinary resolutions will be proposed to approve the General Mandate and the Repurchase Mandate.

A proxy form for use at the AGM is enclosed with this circular. Whether or not you intend to attend the AGM in person, you are requested to complete the proxy form in accordance with the instructions printed thereon and return the same to the Company's share registrar, Computershare Hong Kong Investor Services Limited at 46th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for holding of the AGM or any adjournment thereof. Completion and return of the proxy form will not preclude you from attending and voting in person at the AGM or any adjournment thereof should you so wish.

According to rule 13.39(4) of the Listing Rules, any vote of Shareholders at a general meeting must be taken by poll. Therefore, all the resolutions put to the vote at the Annual General Meeting will be taken by way of poll.

### RECOMMENDATION

The Directors consider that the granting of the Repurchase Mandate and the General Mandate and the re-election of the Directors to be proposed at the AGM are in the best interest of the Company and the Shareholders. Accordingly, the Directors recommend that all Shareholders should vote in favour of the relevant resolutions to be proposed at the AGM. The Directors wish to state that they have no immediate plans to repurchase any existing Shares or to issue any new Shares pursuant to the relevant mandate.

**RESPONSIBILITY STATEMENT**

This document, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquires, confirm that, to the best of their knowledge and belief:

1. the information contained in this document is accurate and complete in all material respects and not misleading;
2. there are no other matters the omission of which would make any statement in this document misleading; and
3. all opinions expressed in this document have been arrived at after due and careful consideration and are founded on bases and assumptions that are fair and reasonable.

The following is the explanatory statement required to be sent to the Shareholders under the Listing Rules in connection with the proposed general mandate for repurchases of Shares to be passed by the Shareholders by an ordinary resolution at the Annual General Meeting.

**(1) Reasons for Repurchases**

The Directors believe that it is in the best interest of the Company and its shareholders for the Directors to have a general authority from shareholders to enable the Company to repurchase Shares in the market. Repurchases of Shares will only be made when the Directors believe that such a repurchase will benefit the Company and its shareholders. Such repurchases may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net value of the Company and its assets and/or its earnings per Share.

**(2) Funding of Repurchases**

Repurchases pursuant to the Repurchase Mandate would be financed entirely from the Company's available cash flow or working capital facilities. Any repurchases will only be funded out of funds of the Company legally available for the purposes in accordance with its memorandum of association and Articles of Association and the laws of the Cayman Islands.

The Company may not repurchase its own Shares on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.



**(3) Impact of Repurchases**

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in its latest published audited accounts for the year ended 31 December 2009) in the event that the proposed repurchases were to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

**(4) Exercise of the Repurchase Mandate**

As at the Latest Practicable Date, the authorised share capital of the Company was HK\$200,000,000 divided into 2,000,000,000 Shares, of which 576,000,000 Shares were in issue.

On the basis of 576,000,000 existing Shares in issue as at the Latest Practicable Date, the Directors would be authorised to repurchase up to 57,600,000 Shares which represent 10 per cent. of the 576,000,000 existing Shares in issue as at the Latest Practicable Date.

**(5) Disclosure of Interest**

Rule 10.6(2) of the Listing Rules prohibit a company from knowingly repurchasing its shares on the Stock Exchange from a connected person (as defined in the Listing Rules) and a connected person is prohibited from knowingly selling his/her/its shares to the company on the Stock Exchange.

None of the Directors and, to the best of their knowledge, having made all reasonable enquiries, none of their respective associates, have any present intention, if the Repurchase Mandate is approved by the shareholders of the Company, to sell any Shares to the Company or its subsidiaries.

As at the Latest Practicable Date, no connected persons (as defined in the Listing Rules) of the Company have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Company is authorised to make repurchases of the Shares.

**(6) Directors' Undertaking**

The Directors have undertaken to the Stock Exchange that they will exercise the power of the Company to make purchases pursuant to the proposed resolution, if granted, in accordance with the Listing Rules, the applicable laws of the Cayman Islands and the regulations set out in the memorandum and articles of association of the Company.

**(7) Share Repurchase made by the Company**

No repurchases of Shares have been made by the Company during the six months (whether on the Stock Exchange or otherwise) preceding the Latest Practicable Date.

**(8) Takeovers Code Consequences**

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase of the Shareholder's interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best of the knowledge and belief of the Directors, Taiwan Mayer held indirectly 200,000,000 Shares through Mayer Corporation Development International Limited, representing 34.72% of the issued share capital of the Company. In the event that the Directors exercised in full the power to repurchase Shares of the Company in accordance with the terms of the Repurchase Mandate, Taiwan Mayer's proportionate interest in the voting rights of the Company would be increased to approximately 38.58% and Taiwan Mayer will not be obliged to make a mandatory offer under Rule 26 of the Takeovers Code in this respect.

Save as aforesaid, the Directors are not aware of any consequences which would arise under the Takeovers Code as a consequence of any repurchase pursuant to the Repurchase Mandate.

**Mr. Lin Sheng-bin** (林聖斌), aged 45, is an independent non-executive director of the Company. Mr. Lin holds a Master degree in Finance from National Chung-Cheng University. He has worked as the section staff member, commissioner, auditor and the supervisor of the Regulatory Commission for Securities and Futures, under the Finance Ministry of Taiwan and the supervisor of First Taiwan Securities Inc. He is currently the executive vice president of Sinopac Securities Corp. and directors of Giga Trend International Venture Investment Corp. and Gigawin International Venture Investment Corp. Save as disclosed above, Mr. Lin did not hold any directorship in other listed public companies in the last three years.

Mr. Lin is appointed for an initial term of 1 year commencing from the date of appointment and shall continue thereafter from year to year until terminated by either party with three month's notice in writing served on the other side. Mr. Lin is entitled to an annual fee of HK\$30,000. The director's fee of Mr. Lin is determined by the Board with reference to market rates. For the year ended 31 December 2009, Mr. Lin received HK\$30,000 as director's fees. Save as disclosed above, Mr. Lin does not have any relationship with any directors, senior management or substantial or controlling shareholders of the Company nor is aware of any matters concerning the appointment of Mr. Lin and there is no other information to be disclosed pursuant to any of the requirements of Rule 13.51(2)(h) to (v) of the Listing Rules that need to be brought to the attention of the shareholders of the Company and the Stock Exchange. As at the Latest Practicable Date, he does not have any interests in the Shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

**Mr. Huang Jui-hsiang** (黃瑞祥), aged 49, is an independent non-executive director of the Company. Mr. Huang obtained a Master degree in Accountancy from National Chengchi University. He has over 16 years of experience in the accounting field. He had worked as the assistant manager in the audit services department of KPMG in Taiwan. Save as disclosed above, Mr. Huang did not hold any directorship in other listed public companies in the last three years.

Mr. Huang is appointed for an initial term of 1 year commencing from the date of appointment and shall continue thereafter from year to year until terminated by either party with three month's notice in writing served on the other side. Mr. Huang is entitled to an annual fee of HK\$30,000. The director's fee of Mr. Huang is determined by the Board with reference to market rates. For the year ended 31 December 2009, Mr. Huang received HK\$30,000 as director's fees. Save as disclosed above, Mr. Huang does not have any relationship with any directors, senior management or substantial or controlling shareholders of the Company nor is aware of any matters concerning the appointment of Mr. Huang and there is no other information to be disclosed pursuant to any of the requirements of Rule 13.51(2)(h) to (v) of the Listing Rules that need to be brought to the attention of the shareholders of the Company and the Stock Exchange. As at the Latest Practicable Date, he does not have any interests in the Shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

**Mr. Alvin Chiu** (趙熾佳), aged 49, is an independent non-executive director of the Company. Mr. Chiu graduated from the University of Southern California in 1983 majoring in Economics. He has extensive commercial and retail banking experience in the U.S. He had worked as the vice president and branch manager of First Central Bank in Los Angeles, California for eight years. Mr. Chiu is now the managing director of Pacific Links Group Limited and Pacific Connections Group Limited. He has experience in China trades, importation and wholesale industries. He is also involved in the contract manufacturing, electronics and original equipment manufacturing (“OEM”) assembly business in Greater China. Save as disclosed above, Mr. Chiu did not hold any directorship in other listed public companies in the last three years.

Mr. Chiu is appointed for an initial term of 1 year commencing from the date of appointment and shall continue thereafter from year to year until terminated by either party with three month’s notice in writing served on the other side. Mr. Chiu is entitled to an annual fee of HK\$228,000. The director’s fee of Mr. Chiu is determined by the Board with reference to market rates. For the year ended 31 December 2009, Mr. Chiu received HK\$228,000 as director’s fees. Save as disclosed above, Mr. Chiu does not have any relationship with any directors, senior management or substantial or controlling shareholders of the Company nor is aware of any matters concerning the appointment of Mr. Chiu and there is no other information to be disclosed pursuant to any of the requirements of Rule 13.51(2)(h) to (v) of the Listing Rules that need to be brought to the attention of the shareholders of the Company and the Stock Exchange.
