- (如證券申請人要求將證券存於中央結算系統) 香港結算或香港結算代理人,彼等將會就中央 結算系統的運作使用有關個人資料;
- 本公司或香港證券登記處就其各自業務營運而 使用有關個人資料;
- 向本公司或香港證券登記處提供與其各自業務營運有關的行政、電訊、電腦、付款或其他服務的任何代理人、承包商或第三方服務供應商;
- 香港聯交所、證監會及任何其他法定監管機關 或政府部門或遵照其他法例、規則或法規;及
- 證券持有人與其進行或擬進行交易的任何人士 或機構,例如彼等的銀行、律師、會計師或股 票經紀等。

#### 4. 個人資料的保留

本公司及其香港證券登記處將按收集個人資料所需的用途保留證券申請人及持有人的個人資料。 毋須保留的個人資料將會根據《條例》銷毀或處理。

# 5. 查閱和更正個人資料
