The Adjustment is detailed as follows:

I. Adjustment on accrual mechanism of the Long-term Service Plan amount

To ensure that the incentivization objective of the Long-term Service Plan is highly aligned with the business objectives set by the Board of Directors, the accrual mechanism of the Long-term Service Plan amount is adjusted from "calculated according to a certain percentage based on the achieved percentage of the Company's net profit growth rate target determined by the Board of Directors: Upper limit of the amount of the Plan of the year =

net profit of the year x N" to "calculated according to a certain percentage based on the achieved percentage of the Company's profit growth rate target determined by the Board of Directors: Upper limit of the amount of the Plan of the year = profit of the year x N".

II. Impact on the Company

The Adjustment is in compliance with the requirements of the relevant laws and regulations, will not have any material impact on the implementation of the Long-term Service Plan of the Company, and will not materially affect the financial position and operating results of the Company.
